**For An Act To Be Entitled**

AN ACT TO MAKE TECHNICAL CORRECTIONS TO TITLE 24,  
CONCERNING PUBLIC RETIREMENT AND PENSION LAW, OF THE  
ARKANSAS CODE; AND FOR OTHER PURPOSES.

**Subtitle**

TO MAKE TECHNICAL CORRECTIONS TO TITLE  
24, CONCERNING PUBLIC RETIREMENT AND  
PENSION LAW, OF THE ARKANSAS CODE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 24-5-118(a)(2)(A)(i)(d), concerning annuity options under the Arkansas State Highway Employees' Retirement System, is amended to read as follows to correct an internal reference:

(d) This subdivision (a)(2)(~~B~~)(~~i~~)(A)(i) ~~shall apply~~ applies to all members and retirants.

SECTION 2. Arkansas Code § 24-10-102(28), concerning the definition of "political subdivision" under the Arkansas Local Police and Fire Retirement System, is amended to read as follows to use the preferred singular noun form:

(28) "Political subdivision" means:

- (A) ~~Incorporated towns~~ An incorporated town;
- (B) ~~Cities~~ A city of the first class;
- (C) ~~Cities~~ A city of the second class;



- (D) ~~Counties~~ A county;
- (E) ~~Fire~~ A fire protection ~~districts~~ district that ~~maintain~~ maintains standards established by the board;
- (F) ~~Rural~~ A rural fire protection ~~corporations~~ corporation; and
- (G) ~~Suburban~~ A suburban improvement ~~districts~~ district;

SECTION 3. Arkansas Code § 24-11-213(c)(2), concerning apportionment of revenues to the Firemen's and Police Officers' Pension and Relief Fund, is amended to read as follows to correct a reference to a fund:

(2) The remaining percentage shall be distributed to the General Revenue Fund Account of the State Apportionment Fund.

SECTION 4. Arkansas Code § 24-11-801(a)(4)(B), concerning the definition of "member" in relation to the qualifications required for membership on a board of trustees of a firemen's pension and relief fund, is amended to read as follows to clarify the wording:

(B)~~(i)~~ As used in this section, "member" includes an active or retired member of the fund-

~~(ii)~~ ~~"Member"~~ but does not include a beneficiary of the fund.

SECTION 5. DO NOT CODIFY. The enactment and adoption of this act shall not repeal, expressly or impliedly, the acts passed at the regular session of the Eighty-Ninth General Assembly. All such acts shall have the full force and effect and, so far as those acts intentionally vary from or conflict with any provision contained in this act, those acts shall have the effect of subsequent acts and as amending or repealing the appropriate parts of the Arkansas Code of 1987.
