## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION TO THE EAST ARKANSAS  
COMMUNITY COLLEGE FOR CONSTRUCTING AND EQUIPPING THE  
STUDENT CENTER FACILITY; AND FOR OTHER PURPOSES.

### Subtitle

AN ACT FOR THE EAST ARKANSAS COMMUNITY  
COLLEGE - CONSTRUCTING AND EQUIPPING THE  
STUDENT CENTER FACILITY GENERAL  
IMPROVEMENT APPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATION - STUDENT CENTER FACILITY CONSTRUCTION AND  
EQUIPPING. There is hereby appropriated, to the East Arkansas Community  
College, to be payable from the General Improvement Fund or its successor  
fund or fund accounts, the following:

(A) for construction, maintenance, equipment, security enhancements and  
technology upgrades/equipment of the Student Center Facility, including  
sidewalks, lighting and landscaping, in a sum not to exceed  
.....\$1,794,000.

SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
obligations otherwise incurred in relation to the project or projects  
described herein in excess of the State Treasury funds actually available  
therefor as provided by law. Provided, however, that institutions and  
agencies listed herein shall have the authority to accept and use grants and  
donations including Federal funds, and to use its unobligated cash income or



funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2013 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2013 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2013.
