## For An Act To Be Entitled

AN ACT TO AMEND THE REQUIREMENTS FOR MULTIYEAR  
VEHICLE REGISTRATION; AND FOR OTHER PURPOSES.

### Subtitle

TO AMEND THE REQUIREMENTS FOR MULTIYEAR  
VEHICLE REGISTRATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 27-14-612(c)-(e), concerning multiyear registration requirements, are amended to read as follows:

(c)~~(1)~~ The owner of a personal-use vehicle, who has owned the vehicle for a twelve (12) month renewal period following initial registration by the owner, may ~~submit~~ request a multiyear personal-use vehicle registration for a period of two (2) or three (3) years by providing the following information to the office with the application:

~~(A)(1)~~ All information necessary for the registration and licensing of the vehicle under law to include:

(A) Proof of current insurance coverage on the vehicle to be registered as required under § 27-13-102;

(B) Proof of payment of personal property taxes; and

(C) Proof of listing the vehicle for assessment;

~~(i) (2)~~ Proof that property taxes on the vehicle to be registered have been timely paid by the applicant for the preceding two (2) years; and

~~(ii) Proof that the motor vehicle has been insured~~



~~as required under § 27-22-104 and the Motor Vehicle Safety Responsibility Act, § 27-19-101 et seq., for the preceding two (2) years; and~~

~~(B)(3) Payment of the fees for registration and licensing for two (2) years;~~

~~(A) Two (2) years, if the registration is for a period of two (2) years; and~~

~~(B) Three (3) years, if the registration is for a period of three (3) years.~~

~~(2) The owner of a personal use vehicle may submit a multiyear personal use vehicle registration for a period of three (3) years by providing the following information to the office with the application:~~

~~(A) All information necessary for the registration and licensing of the vehicle under law to include:~~

~~(i) Proof that property taxes have been timely paid for the preceding three (3) years; and~~

~~(ii) Proof that the motor vehicle has been insured as required under § 27-22-104 and the Motor Vehicle Safety Responsibility Act, § 27-19-101 et seq., for the preceding three (3) years; and~~

~~(B) Payment of the fees for registration and licensing for three (3) years.~~

~~(d) A personal use vehicle is not eligible for registration under this section if it has not been licensed and registered for the period that the owner seeks to register the vehicle for multiple years prior to the owner's seeking to register the vehicle for multiple years.~~

~~(e) (d) The Office of Motor Vehicle may promulgate rules for the administration of this section.~~

SECTION 2. EFFECTIVE DATE. This act is effective on and after January 1, 2014.
