AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 254 of 2013, for construction of a Nursing and Allied Health building at the Paragould campus, in a sum not to exceed.....\$2,650,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 1 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$290,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 1 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$184,130.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 1 of Act 254 of 2013, for personal services, operating expenses and grants to support the continuation of the Arkansas Delta



Training and Education Consortium University Center initiatives, in a sum not to exceed.....\$240,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 1 of Act 254 of 2013, for personal services, operating expenses and economic development grants to support the continuation of Arkansas Delta Training and Education Consortium initiatives, in a sum not to exceed.....\$415,681.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 370 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$1,000,000.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 12 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$10,000,000.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 2 of Act 254 of 2013, for expansion of the Heber Springs Academic Center, in a sum not to exceed.....\$1,500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 2 of Act 254 of 2013, for renovations of State Hall, in a sum not to exceed.....\$1,500,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 2 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$850,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 2 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$468,560.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 387 of 2013, for construction, renovation,

equipment, maintenance, personal services, and operating expenses of the ASU - Heber Springs Campus Academic Building addition, in a sum not to exceed\$2,250,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 13 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 3 of Act 254 of 2013, for construction of the Vada Sheid Community Development Center, in a sum not to exceed.....\$1,500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 3 of Act 254 of 2013, for upgrades to technology infrastructure, in a sum not to exceed.....\$900,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 3 of Act 254 of 2013, for expansion of the campus security system, in a sum not to exceed.....\$200,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 3 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$120,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 3 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$160,010.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 372 of 2013, for technology infrastructure upgrade and renovation expenses, in a sum not to exceed.....\$900,000.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 14 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed

.....\$10,000,000.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 4 of Act 254 of 2013, for construction of a Classroom/Laboratory building on the Jonesboro campus, in a sum not to exceed\$500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 4 of Act 254 of 2013, for construction of a Workforce/Administration building on the Marked Tree campus, in a sum not to exceed.....\$1,500,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 4 of Act 254 of 2013, for construction of a Classroom building for the Technical Center on the Jonesboro campus, in a sum not to exceed.....\$325,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 4 of Act 254 of 2013, for construction of a Classroom building on the Newport campus, in a sum not to exceed.....\$325,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 4 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$260,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 4 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$182,200.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (G) Section 4 of Act 254 of 2013, for personal services, operating expenses and grants to support the continuation of the Arkansas Delta Training and Education Consortium University Center initiatives, in a sum not to exceed.....\$103,612.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (H) Section 4 of Act 254 of 2013, for personal services, operating expenses and economic development grants to support the continuation of Arkansas Delta Training and Education Consortium initiatives, in a sum not to

exceed.....\$279,210.

(I) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 357 of 2013, for parking lot renovations, resurfacing, paving, landscaping, painting, operating expenses, equipment, and lighting expenses of the Marked Tree campus, in a sum not to exceed\$150,000.

(J) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 360 of 2013, for supplies, materials, utilities, infrastructure, furnishing, personal services, and operating expenses, in a sum not to exceed.....\$500,000.

(K) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 15 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As referenced in Section 3(c) of Act 1518 of 2013 and Section 3(c) of Act 1519 of 2013, the authorized funding for the Arkansas State University - Newport for parking lot renovations, resurfacing, paving, landscaping, painting, and lighting expenses of the Marked Tree campus shall be deemed to also include operating expenses and equipment.

SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE - GENERAL IMPROVEMENT. There is hereby appropriated, to the Black River Technical College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Black River Technical College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 5 of Act 254 of 2013, for expansion of existing academic facilities on the Paragould campus, in a sum not to exceed.....\$1,500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 5 of Act 254 of 2013, for renovations to the "A" and "B" buildings, in a sum not to exceed.....\$1,200,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 5 of Act 254 of 2013, for deferred maintenance, in a sum

not to exceed.....\$310,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 5 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$280,070.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 2 of Act 380 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources at the Pocahontas campus, in a sum not to exceed.....\$300,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 16 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

SECTION 7. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE - TRUST - REACH PHASE III. There is hereby appropriated, to the Black River Technical College, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Black River Technical College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$250,000.

SECTION 8. REAPPROPRIATION - COLLEGE OF THE OUACHITAS. There is hereby appropriated, to the College of The Ouachitas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the College of The Ouachitas the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 6 of Act 245 of 2013, for course materials, operations and programmatic costs for the Nursing Program, in a sum not to exceed\$20,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 6 of Act 254 of 2013, for technology infrastructure improvements and upgrades, in a sum not to exceed.....\$230,000.

(C) Effective July 1, 2014, the balance of the appropriation provided

in Item (B) Section 6 of Act 254 of 2013, for construction of an Applied Science and Business Technology Center, in a sum not to exceed\$2,289,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 6 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$201,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 6 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$131,380.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 17 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

SECTION 9. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 7 of Act 254 of 2013, for construction of a multi-purpose facility to include classrooms, a lecture hall and a large exhibition space, in a sum not to exceed.....\$1,500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 7 of Act 254 of 2013, for renovation of facilities for the Collision Repair and Automotive Technology programs, in a sum not to exceed.....\$550,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 7 of Act 254 of 2013, for replacement of the HVAC system in the Administration Building, in a sum not to exceed.....\$200,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 7 of Act 254 of 2013, for storage area networks for disaster recovery, in a sum not to exceed.....\$162,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 7 of Act 254 of 2013, for upgrading the computer

networking infrastructure in the DeQueen Administrative Building, in a sum not to exceed.....\$9,500.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 7 of Act 254 of 2013, for virtual desktop infrastructure equipment, in a sum not to exceed.....\$178,500.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (G) Section 7 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$250,000.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (H) Section 7 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$134,600.

(I) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 2 of Act 352 of 2013, for operating expenses, repairs, improvements, major maintenance and purchase of equipment, in a sum not to exceed.....\$500,000.

(J) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 377 of 2013, for upgrades and updates to information technology and student support technology equipment, software, hardware, and other technology resources, in a sum not to exceed\$750,000.

(K) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 18 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

SECTION 10. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE - TRUST - RENOVATION OF EAST BROADWAY PROPERTY. There is hereby appropriated, to the East Arkansas Community College, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the East Arkansas Community College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$135,000.

SECTION 11. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE - GENERAL IMPROVEMENT. There is hereby appropriated, to the East Arkansas Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the East Arkansas Community College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (H) Section 8 of Act 245 of 2013, for construction, improvements, equipment, renovation, maintenance, personal services and operating expenses, in a sum not to exceed.....\$22,584.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 8 of Act 254 of 2013, for technology infrastructure updates, in a sum not to exceed.....\$487,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 8 of Act 254 of 2013, for renovation of Classroom Building 3, in a sum not to exceed.....\$1,095,500.

SECTION 12. REAPPROPRIATION - MID-SOUTH COMMUNITY COLLEGE. There is hereby appropriated, to the Mid-South Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Mid-South Community College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 9 of Act 254 of 2013, for construction of an Aviation Annex, in a sum not to exceed.....\$2,650,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 9 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$340,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 9 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$186,150.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 9 of Act 254 of 2013, for personal services, operating expenses and grants to support the continuation of the Arkansas Delta Training and Education Consortium University Center initiatives, in a sum not to exceed.....\$218,941.

SECTION 13. REAPPROPRIATION - NATIONAL PARK COMMUNITY COLLEGE. There is hereby appropriated, to the National Park Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the National Park Community College the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 10 of Act 254 of 2013, for upgrades and improvements to campus technology infrastructure, in a sum not to exceed.....\$1,409,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 10 of Act 254 of 2013, for classroom technology upgrades, in a sum not to exceed.....\$609,500.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 10 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$1,221,500.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 10 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$407,400.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 21 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 11 of Act 254 of 2013, for a Science and Chemistry addition, in a sum not to exceed.....\$1,200,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 11 of Act 254 of 2013, for renovation of a Student

Success Center, in a sum not to exceed.....\$1,000,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 11 of Act 254 of 2013, for upgrade and relocation of existing Information Technology operations, in a sum not to exceed.....\$500,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 11 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$400,000.

the National Child Protection Training Center, in a sum not to exceed

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 32 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$10,000,000.

SECTION 28. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT MORRILTON. There is hereby appropriated, to the University of Arkansas Community College at Morrilton, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas Community College at Morrilton the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 23 of Act 254 of 2013, for construction of a Technology

Center, in a sum not to exceed.....\$1,200,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 23 of Act 254 of 2013, for construction of an Education Complex, in a sum not to exceed.....\$1,500,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 23 of Act 254 of 2013, for deferred maintenance, in a sum not to exceed.....\$340,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 23 of Act 254 of 2013, for repair or replacement of equipment and library holdings, in a sum not to exceed.....\$263,670.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 33 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$10,000,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 845 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$1,000,000.

SECTION 29. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State

and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 30. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 31. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2014 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2014 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2014.
