## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF  
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

### Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER  
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - GENERAL  
IMPROVEMENT. There is hereby appropriated, to the Henderson State  
University, to be payable from the General Improvement Fund or its successor  
fund or fund accounts, for the Henderson State University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided  
in Item (D) Section 3 of Act 205 of 2013, for deferred maintenance expenses,  
in a sum not to exceed.....\$1,746,000.

(B) Effective July 1, 2014, the balance of the appropriation provided  
in Item (B) Section 3 of Act 205 of 2013, for local area network  
infrastructure expenses, in a sum not to exceed.....\$654,000.

(C) Effective July 1, 2014, the balance of the appropriation provided  
in Item (A) Section 3 of Act 205 of 2013, for the Phase I Campus Renovation  
expenses, in a sum not to exceed.....\$5,000,000.

(D) Effective July 1, 2014, the balance of the appropriation provided  
in Item (E) Section 3 of Act 205 of 2013, for the purchase, replacement, and  
renewal of library holdings, in a sum not to exceed.....\$546,168.

(E) Effective July 1, 2014, the balance of the appropriation provided



in Item (C) Section 3 of Act 205 of 2013, for underground electrical distribution expenses, in a sum not to exceed.....\$346,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 3 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed .....\$10,000,000.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 796 of 2013, for land acquisition, site preparation, construction, renovation, maintenance, major maintenance, purchase of equipment, personal services and operating expenses of the Henderson State University Community Education Center for the Hot Springs Downtown Education Center to be conducted in partnership with the National Park Community College, in a sum not to exceed.....\$15,000,000.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 347 of 2013, for construction, renovation, maintenance, critical maintenance, security enhancements, equipment, technology upgrades/equipment, and library resources, in a sum not to exceed .....\$1,000,000.

SECTION 2. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - TRUST - PROCTOR HALL RENOVATIONS. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$190,000.

SECTION 3. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is hereby appropriated, to the Southern Arkansas University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southern Arkansas University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (H) Section 2 of Act 244 of 2013, for expenses of a lignite

feasibility study, in a sum not to exceed.....\$32,194.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 2 of Act 244 of 2013, for constructing, equipping, personal services, maintenance and operating expenses of a Natural Resources Research Center for research of lignite and other natural resources in the State, in a sum not to exceed.....\$75,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 4 of Act 205 of 2013, for Bruce Center conversion expenses, in a sum not to exceed.....\$850,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 4 of Act 205 of 2013, for construction of agricultural instructional lab facilities, in a sum not to exceed.....\$1,300,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 4 of Act 205 of 2013, for deferred maintenance expenses, in a sum not to exceed.....\$1,570,000.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 4 of Act 205 of 2013, for renovation of the Engineering Training center, in a sum not to exceed.....\$850,000.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 4 of Act 205 of 2013, for technology upgrade expenses, in a sum not to exceed.....\$2,500,000.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 4 of Act 205 of 2013, for the purchase, replacement, and renewal of library holdings, in a sum not to exceed.....\$496,133.

(I) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 4 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$10,000,000.

(J) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 346 of 2013, for construction, renovation, maintenance, critical maintenance, security enhancements, equipment, technology upgrades/equipment, and library resources, in a sum not to exceed.....\$1,000,000.

(K) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 871 of 2013, for construction, renovation,

maintenance, critical maintenance, security enhancements, equipment, technology upgrades/equipment, and library resources, in a sum not to exceed.....\$1,000,000.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 4 of Act 244 of 2013, for constructing, equipping, landscaping, parking lot, and other construction related costs of completing a liberal arts teaching building, in a sum not to exceed.....\$3,613,972.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 1 of Act 205 of 2013, for construction of a Humanities and Social Sciences Building, in a sum not to exceed.....\$4,000,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 205 of 2013, for construction, renovation, maintenance, equipment and operating expenses of the various institutions and entities of the Arkansas State University System, in a sum not to exceed .....\$15,000,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 1 of Act 205 of 2013, for deferred maintenance, in a sum not to exceed.....\$4,100,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 1 of Act 205 of 2013, for personal services, operating expenses, and grants for the Arkansas Delta Training and Education Consortium University Center Initiatives, in a sum not to exceed.....\$1,142,664.

(F) Effective July 1, 2014, the balance of the appropriation provided in Item (G) Section 1 of Act 205 of 2013, for renovation of the System office, in a sum not to exceed.....\$1,050,000.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 1 of Act 205 of 2013, for renovation of Wilson Hall, in a sum not to exceed.....\$3,000,000.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 1 of Act 205 of 2013, for the purchase, replacement, and renewal of library holdings, in a sum not to exceed.....\$1,890,484.

(I) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed .....\$10,000,000.

(J) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 354 of 2013, for construction, renovation, maintenance, equipment, and operational expenses of the various institutions and entities of the Arkansas State University System, in a sum not to exceed .....\$15,000,000.

(K) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 652 of 2013, for construction, renovation, maintenance, personal services, operations, critical maintenance, and equipment for the Hemingway - Pfeiffer Museum and Educational Center, in a sum not to exceed.....\$500,000.

(L) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 358 of 2013, for construction, renovation, maintenance, personal services, operations, critical maintenance, equipment, and matching fund expenses for the Historic Dyess Colony: A New Deal Farm Experiment, a National Endowment of the Humanities Challenge grant initiative, in a sum not to exceed.....\$1,000,000.

(M) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 356 of 2013, for remodeling, renovation, refurbishing, equipment, furnishings, replacement of plumbing/electrical/heating and cooling systems, and exhibit expenses of Lakeport Plantation facilities, in a sum not to exceed.....\$175,000.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - TRUST - DYESS COLONY CENTER RESTORATION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$500,000.

SECTION 6. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas Tech University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Tech University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 2 of Act 205 of 2013, for construction of an academic classroom facility, in a sum not to exceed.....\$3,500,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 2 of Act 205 of 2013, for deferred maintenance, in a sum not to exceed.....\$1,610,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (F) Section 2 of Act 205 of 2013, for deferred maintenance at the Ozark Campus, in a sum not to exceed.....\$2,036,812.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (E) Section 2 of Act 205 of 2013, for electrical systems upgrade at the Ozark Campus, in a sum not to exceed.....\$193,188.

(G) Effective July 1, 2014, the balance of the appropriation provided in Item (G) Section 2 of Act 205 of 2013, for the purchase, replacement, and renewal of library holdings for the Ozark Campus, in a sum not to exceed .....\$122,350.

(H) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 2 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed .....\$10,000,000.

(I) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 828 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements,

technology upgrades/equipment and library resources at the Ozark Campus, in a sum not to exceed.....\$500,000.

(J) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 916 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed .....\$10,000,000.

SECTION 7. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - TRUST - RENOVATION OF WILSON HALL. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$500,000.

SECTION 8. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE-GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (Q) Section 8 of Act 244 of 2013, for operations, personal services, construction, renovations, capital outlay, maintenance and expenses of the Arkansas School for Mathematics, Sciences and the Arts, in a sum not to exceed.....\$2,191.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (R) Section 8 of Act 244 of 2013, for construction of a nanotechnology research center for the U of A - Fayetteville, in a sum not to exceed.....\$1,133,279.

(CC) Effective July 1, 2014, the balance of the appropriation provided in Item (X) Section 7 of Act 205 of 2013, for U of A - System, various institutions and entities, construction, renovation, maintenance, equipment, and operational expenses, in a sum not to exceed.....\$5,000,000.

(DD) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 5 of Act 629 of 2013, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed.....\$10,000,000.

(EE) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 656 of 2013, for transfer of funds and appropriation by the President of the University of Arkansas to the various institutions and entities of the University of Arkansas System for construction, renovation, maintenance, equipment, and operational expenses, in a sum not to exceed.....\$20,000,000.

(JJ) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 843 of 2013, for renovation, maintenance, personal services, equipment, and operational expenses of the Arkansas Archeological Survey, in a sum not to exceed.....\$500,000.

(KK) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 359 of 2013, for renovation, maintenance, personal services, equipment, and operational expenses of the Arkansas Research and Education Optical Network, in a sum not to exceed .....\$1,000,000.

SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - TRUST - PETIT JEAN STATE PARK FORGOTTEN HERITAGE. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2014, the balance of the appropriation provided in Item (01) Section 31 of Act 932 of 2013, for acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed.....\$135,000.

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (B) Section 11 of Act 205 of 2013, for Education Building construction, in a sum not to exceed.....\$1,500,000.

(C) Effective July 1, 2014, the balance of the appropriation provided in Item (C) Section 11 of Act 205 of 2013, for Fine Arts building construction, in a sum not to exceed.....\$1,500,000.

(D) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 11 of Act 205 of 2013, for Math - Science building renovation, in a sum not to exceed.....\$2,500,000.

(E) Effective July 1, 2014, the balance of the appropriation provided in Item (D) Section 11 of Act 205 of 2013, for personal services, operating expenses, and grants for the Arkansas Delta Training and Education Consortium University Center Initiatives, in a sum not to exceed.....\$269,119.

SECTION 24. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 25. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 26. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2014 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2014 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2014.
