AN ACT TO AMEND THE MINIMUM TEACHER COMPENSATION
SCHEDULE; AND FOR OTHER PURPOSES.

Subtitle

TO AMEND THE MINIMUM TEACHER COMPENSATION
SCHEDULE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 6-17-2403(b), concerning the minimum teacher compensation schedule, is amended to read as follows:

(b) Each school district in the state shall have in place a salary schedule with at least the following minimum levels of compensation for a basic contract:

(1) For the 2015-2016 school year:

SECTION 2. Arkansas Code § 6-17-2403, concerning the minimum teacher compensation schedule, is amended to add an additional subsection to read as follows:

(d)(1) The minimum teacher compensation schedule under § 6-17-2403(b) of this section does not apply to a part-time teacher or part-time paraprofessional employed by a school district to work in an adult education program.

(2) The minimum teacher compensation schedule for a part-time teacher or part-time paraprofessional employed by a school district to work in an adult education program shall be established by the Adult Education

Section of the Department of Career Education and approved by the State Board of Career Education.
