*AN ACT TO AMEND PROVISIONS OF THE ARKANSAS CODE
CONCERNING THE PURCHASE OF VEHICLES FOR INSTITUTIONS
OF HIGHER EDUCATION; TO DECLARE AN EMERGENCY; AND FOR
OTHER PURPOSES.*

Subtitle

*TO AMEND PROVISIONS OF THE ARKANSAS CODE
CONCERNING THE PURCHASE OF VEHICLES FOR
INSTITUTIONS OF HIGHER EDUCATION; AND TO
DECLARE AN EMERGENCY.*

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

*SECTION 1. Arkansas Code § 19-4-906(a), item numbers 58 through 60,
concerning passenger motor vehicles, are amended to read as follows:*

SECTION 7. Arkansas Code § 19-4-906(a), item number 114, concerning passenger motor vehicles, is amended to read as follows:

(114) Southeast Arkansas College ~~6~~ 10

SECTION 8. Arkansas Code § 19-4-906(a), item number 129, concerning passenger motor vehicles, is amended to read as follows:

(129) University of Arkansas at Fayetteville ~~594~~ 605

SECTION 9. Arkansas Code § 19-4-906(a), item number 137, concerning passenger motor vehicles, is amended to read as follows:

(137) University of Arkansas for Medical Sciences ~~99~~ 105

SECTION 10. EMERGENCY CLAUSE. It is found and determined by the General Assembly of the State of Arkansas that institutions of higher education need additional vehicles to maintain efficient operation of the institutions; that the number of vehicles authorized under current law is insufficient; and that this act is immediately necessary to ensure that an institution of higher education may access the number of vehicles that the institution determines is necessary for efficient operation of the campus. Therefore, an emergency is declared to exist, and this act being immediately necessary for the preservation of the public peace, health, and safety shall

become effective on:

(1) The date of its approval by the Governor;

(2) If the bill is neither approved nor vetoed by the Governor, the expiration of the period of time during which the Governor may veto the bill; or

(3) If the bill is vetoed by the Governor and the veto is overridden, the date the last house overrides the veto.
