## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION TO THE STATE MILITARY DEPARTMENT FOR CAPITAL PROJECTS; AND FOR OTHER PURPOSES.

### Subtitle

AN ACT FOR THE STATE MILITARY DEPARTMENT  
- CAPITAL PROJECTS GENERAL IMPROVEMENT  
APPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATION - GENERAL IMPROVEMENT CAPITAL PROJECTS. There is hereby appropriated, to the State Military Department, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:

(A) for construction of a Youth Program Facility for the Civilian Student Training Program and Youth Challenge Program, in a sum not to exceed .....\$10,000,000.

(B) for construction and renovation projects for ADA compliance for Armories, in a sum not to exceed.....\$750,000.

(C) for construction and renovation of the Readiness Center located at 17303 Camp J.T. Robinson, in a sum not to exceed.....\$1,852,606.

(D) for construction and renovation of the Readiness Center located at 24346 Camp J.T. Robinson, in a sum not to exceed.....\$988,665.

(E) for upgrades and improvements associated with Readiness Center Energy Projects at Arkansas National Guard Readiness Centers throughout the state, in a sum not to exceed.....\$1,070,000.



(F) for construction, renovation, roof repair/replacement, upgrade latrines, upgrade windows and doors, parking and road resurfacing, and general facility maintenance for sustainment, restoration and modernization projects of the Arkansas Army National Guard Readiness Centers throughout the state, in a sum not to exceed.....\$8,025,025.

SECTION 2. APPROPRIATION - FEDERAL CAPITAL PROJECTS. There is hereby appropriated, to the State Military Department, to be payable from the federal funds as designated by the Chief Fiscal Officer of the State, the following:

(A) for construction and renovation projects for ADA compliance for Armories, in a sum not to exceed.....\$750,000.

(B) for upgrades and improvements associated with Camp J.T. Robinson Energy Projects, in a sum not to exceed.....\$3,210,000.

(C) for upgrades and improvements associated with Camp J.T. Robinson Solar Array Project, in a sum not to exceed.....\$1,867,890.

(D) for construction, renovation, roof repair/replacement, upgrade latrines, upgrade windows and doors, parking and road resurfacing, and general facility maintenance for sustainment, restoration and modernization projects at Camp J.T. Robinson, in a sum not to exceed.....\$10,700,000.

(E) for construction and renovation of Dining Facility Building 2501, in a sum not to exceed.....\$2,853,078.

(F) for construction, upgrades and improvements associated with Fort Chaffee Energy Projects, in a sum not to exceed.....\$3,210,000.

(G) for construction, upgrades and improvements associated with Fort Chaffee Solar Array Project, in a sum not to exceed.....\$1,867,890.

(H) for construction, renovation, roof repair/replacement, upgrade latrines, upgrade windows and doors, parking and road resurfacing, and general facility maintenance for sustainment, restoration and modernization projects at Fort Chaffee, in a sum not to exceed.....\$10,700,000.

(I) for construction of Camp J.T. Robinson Maryland Gate Access Control, in a sum not to exceed.....\$2,193,360.

(J) for construction of Camp J.T. Robinson Multi-Purpose Machinegun Range, in a sum not to exceed.....\$5,859,500.

(K) for construction and renovation of the Readiness Center located at 17303 Camp J.T. Robinson, in a sum not to exceed.....\$5,557,817.

(L) for construction and renovation of the Readiness Center located at 24346 Camp J.T. Robinson, in a sum not to exceed.....\$2,965,995.

(M) for upgrades and improvements associated with Readiness Center Energy Projects at Arkansas National Guard Readiness Centers throughout the state, in a sum not to exceed.....\$1,070,000.

(N) for construction, renovation, roof repair/replacement, upgrade latrines, upgrade windows and doors, parking and road resurfacing, and general facility maintenance for sustainment, restoration and modernization projects of the Arkansas Army National Guard Readiness Centers throughout the state, in a sum not to exceed.....\$8,025,025.

SECTION 3. APPROPRIATION - ARMORY CONSTRUCTION FUND CAPITAL PROJECTS.

There is hereby appropriated, to the State Military Department, to be payable from the Armory Construction Fund, the following:

(A) for construction, improvement, or equipping of Arkansas National Guard Readiness Centers throughout the state, in a sum not to exceed .....\$2,500,000.

SECTION 4. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided

otherwise by law.

SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2017 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2017 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2017.
