AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 1 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Workforce Training Building, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 1 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Nursing and Allied Health Building in Paragould, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 1 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$350,000.



(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 1 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$360,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 1 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$138,225.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 2 of Act 674 of 2017, for construction, renovation, equipment, maintenance, personal services and operating expenses of the ASU - Heber Springs Campus Academic Building, in a sum not to exceed\$20,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 2 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an IT Services Data Center, in a sum not to exceed\$2,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 2 of Act 904 of 2017, for renovations of State Hall, in a sum not to exceed\$1,375,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 2 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$110,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 2 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$1,070,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 2 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$445,250.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH. There is hereby appropriated, to the Arkansas State University - Mid-South, to be payable from the General Improvement Fund or its successor fund or fund

accounts, for the Arkansas State University - Mid-South the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 3 of Act 674 of 2017, for deferred maintenance, construction, renovation, maintenance, equipment, personal services and operating expenses, in a sum not to exceed\$268,072.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 5 of Act 904 of 2017, for upgrade and replacement of Classroom Instructional Technology Equipment, in a sum not to exceed\$102,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 5 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$20,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 5 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$460,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 5 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$159,060.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.

There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 3 of Act 904 of 2017, for acquisition and renovation of an Occupational Technical Center, in a sum not to exceed\$1,850,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 3 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Health and Wellness Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 3 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$90,000.

(D) Effective July 1, 2018, the balance of the appropriation provided

in Item (D) of Section 3 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$220,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 3 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$162,705.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 4 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a STEM Classroom/Lab Building on the Jonesboro Campus, in a sum not to exceed\$1,000,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 4 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of an Administration Building on the Newport Campus, in a sum not to exceed\$750,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 4 of Act 904 of 2017, for renovation of a classroom building to provide a Transportation Tech Building on the Newport Campus, in a sum not to exceed\$547,500.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 4 of Act 904 of 2017, for remodel of the Main Building on the Jonesboro Campus, in a sum not to exceed\$552,500.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 4 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$20,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 4 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$340,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 4 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$264,730.

SECTION 6. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Black River Technical College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 6 of Act 904 of 2017, for Student Information System upgrades, in a sum not to exceed\$1,062,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 6 of Act 904 of 2017, for the renovation of the "A" and "B" Buildings, in a sum not to exceed\$157,500.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 6 of Act 904 of 2017, for the construction of a storage building for Fire Science Program truck and equipment, in a sum not to exceed\$157,500.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 6 of Act 904 of 2017, for equipment replacement in the Academic Complex/Library, in a sum not to exceed\$54,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 6 of Act 904 of 2017, for construction of a storage building for Grounds Maintenance tractors and equipment, in a sum not to exceed\$90,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 6 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Technical Education Building, in a sum not to exceed\$1,167,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 6 of Act 904 of 2017, for renovation of the Randolph County Development Center, in a sum not to exceed\$162,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 6 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$10,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 6 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$390,000.

(J) Effective July 1, 2018, the balance of the appropriation provided in Item (J) of Section 6 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$201,595.

SECTION 7. REAPPROPRIATION - COLLEGE OF THE OUACHITAS. There is hereby appropriated, to the College of The Ouachitas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the College of The Ouachitas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 7 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Health/Science Technology Building, in a sum not to exceed\$1,600,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 7 of Act 904 of 2017, for improvements in technology infrastructure, in a sum not to exceed\$250,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 7 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Conference and Student Center, in a sum not to exceed\$1,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 7 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$50,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 7 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$200,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 7 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$129,325.

SECTION 8. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 8 of Act 904 of 2017, for technology upgrades, in a sum not to exceed\$600,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 8 of Act 904 of 2017, for Heating, Ventilation, and Air Conditioning replacement for the Leeper Building, in a sum not to exceed\$58,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 8 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Student Commons, in a sum not to exceed\$1,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 8 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Convocation/Education Center, in a sum not to exceed\$1,192,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 8 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$50,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 8 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$300,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 8 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$144,070.

SECTION 9. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS - NCRC - LOCKESBURG H.S. GYMNASIUM RESTORATION PROJECT. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings,

structures or objects, in a sum not to exceed\$225,000.

SECTION 10. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There is hereby appropriated, to the East Arkansas Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the East Arkansas Community College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 10 of Act 674 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$250,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 10 of Act 674 of 2017, for deferred maintenance, in a sum not to exceed\$150,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 9 of Act 904 of 2017, for renovation of technology infrastructure and systems, in a sum not to exceed\$363,500.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 9 of Act 904 of 2017, for renovation and expansion of the Maintenance Building, in a sum not to exceed\$280,950.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 9 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the Student Center, in a sum not to exceed\$1,250,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 9 of Act 904 of 2017, for renovation of Classroom Building 3, in a sum not to exceed\$455,550.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 9 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$30,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 9 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$290,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 9 of Act 904 of 2017, for repair or replacement of

equipment and library holdings, in a sum not to exceed\$116,675.

SECTION 11. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE - CROWLEY'S RIDGE TECHNICAL INSTITUTE. There is hereby appropriated, to the East Arkansas Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the East Arkansas Community College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 1 of Act 396 of 2017, for transfers of or refund to expenditures for capital balances for construction, renovation, major maintenance, and purchase of equipment for various capital projects or facility improvements, in a sum not to exceed\$1,571.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 1 of Act 232 of 2017, for cosmetology classroom and laboratory facility's construction and equipment costs, in a sum not to exceed\$894,375.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 1 of Act 232 of 2017, for major maintenance and repair of facilities, in a sum not to exceed\$957,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 1 of Act 232 of 2017, for transfers of or refund to expenditures for capital balances for construction, renovation, major maintenance, and purchase of equipment for various capital projects or facility improvements, in a sum not to exceed\$1,000,000.

SECTION 12. REAPPROPRIATION - NATIONAL PARK COLLEGE. There is hereby appropriated, to the National Park College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the National Park College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 10 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Learning Commons, in a sum not to exceed\$775,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 10 of Act 904 of 2017, for technology infrastructure

improvements, in a sum not to exceed\$1,605,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 10 of Act 904 of 2017, for classroom technology, in a sum not to exceed\$720,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 10 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$110,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 10 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$470,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 10 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$166,755.

SECTION 13. REAPPROPRIATION - NORTH ARKANSAS COLLEGE. There is hereby appropriated, to the North Arkansas College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the North Arkansas College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 12 of Act 674 of 2017, for construction, renovation, equipment, acquisition, furnishing, personal services, maintenance and operations expenses of the Searcy County campuses, in a sum not to exceed\$25,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 11 of Act 904 of 2017, for an upgrade and replacement of the Administrative ERP and SIS Software System, in a sum not to exceed\$1,300,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 11 of Act 904 of 2017, for roof renovations for the Durand Center and Library, in a sum not to exceed\$1,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 11 of Act 904 of 2017, for renovation of the North Campus Student Resource Area, in a sum not to exceed\$100,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 11 of Act 904 of 2017, for renovation of the South Campus Library, in a sum not to exceed\$450,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 11 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$520,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 11 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$470,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 11 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$204,955.

SECTION 14. REAPPROPRIATION - NORTHWEST ARKANSAS COMMUNITY COLLEGE.

There is hereby appropriated, to the Northwest Arkansas Community College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Northwest Arkansas Community College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 13 of Act 674 of 2017, for startup costs, including planning and architectural services, personal services, maintenance, operations, renovation, equipment, construction, improvement, and acquisition, for the Washington County Center at Springdale to address the requirements for workforce training in response to the needs of the local business community and the state, in a sum not to exceed\$10,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 12 of Act 904 of 2017, for construction of a Washington County Center, in a sum not to exceed\$961,325.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 12 of Act 904 of 2017, for renovation of the Burns Hall bathroom, in a sum not to exceed\$160,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 12 of Act 904 of 2017, for remodeling of the library, in a sum not to exceed\$111,300.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 12 of Act 904 of 2017, for the construction of storm drainage, leveling and replanting for the grounds covered by the railroad spur after removal, in a sum not to exceed\$190,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 12 of Act 904 of 2017, for renovation of the Burns

Hall East Wing, in a sum not to exceed\$151,900.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 12 of Act 904 of 2017, for renovation of the parking garage, in a sum not to exceed\$1,500,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 12 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, and technology upgrades/equipment of the NCPTC Generator, in a sum not to exceed\$40,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 12 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of the new Physical Plant facility, in a sum not to exceed\$400,000.

(J) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 12 of Act 904 of 2017, for Emergency Notification enhancements, in a sum not to exceed\$43,000.

(K) Effective July 1, 2018, the balance of the appropriation provided in Item (J) of Section 12 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$490,000.

(L) Effective July 1, 2018, the balance of the appropriation provided in Item (K) of Section 12 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$742,865.

SECTION 15. REAPPROPRIATION - OZARKA COLLEGE. There is hereby appropriated, to the Ozarka College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Ozarka College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 14 of Act 674 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$20,000.

technology upgrades/equipment and library resources of an Information Technology Center and Student Center, in a sum not to exceed\$1,500,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 13 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Fulton County Education Center, in a sum not to exceed\$1,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 13 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Health and Fitness Center, in a sum not to exceed\$350,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 13 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$240,000.

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 14 of Act 904 of 2017, for roof repair or roof replacement for four (4) buildings on the Helena-West Helena Campus and the Training Center - Dewitt Campus, in a sum not to exceed\$1,100,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 14 of Act 904 of 2017, for renovation of the gymnasium on the Helena-West Helena Campus, in a sum not to exceed\$220,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 14 of Act 904 of 2017, for Americans with Disabilities Act improvements to various buildings on the Helena-West Helena Campus, in a sum not to exceed\$280,000.

(D) Effective July 1, 2018, the balance of the appropriation provided

in Item (D) of Section 14 of Act 904 of 2017, for campus security upgrades, in a sum not to exceed\$100,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 15 of Act 904 of 2017, for renovation of the Science Building, in a sum not to exceed\$200,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 16 of Act 904 of 2017, for the technology upgrades of the lecture hall, in a sum not to exceed\$590,500.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 17 of Act 904 of 2017, for an addition to the Health and Natural Sciences Building, in a sum not to exceed\$1,250,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 17 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for the Library/Learning Center expansion, in a sum not to exceed\$755,357.

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$500,000.

SECTION 21. REAPPROPRIATION - SOUTHEAST ARKANSAS COLLEGE. There is hereby appropriated, to the Southeast Arkansas College, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southeast Arkansas College the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 18 of Act 904 of 2017, for replacement of the General Studies North-South Sewer, in a sum not to exceed\$790,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 18 of Act 904 of 2017, for replacement of transformers at General Studies South, in a sum not to exceed\$25,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 18 of Act 904 of 2017, for replacement of the McGeorge Hall boiler, in a sum not to exceed\$25,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 18 of Act 904 of 2017, for replacement of the Founders Hall boiler, in a sum not to exceed\$25,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 19 of Act 904 of 2017, for renovation of the Administration/Business Building, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 19 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$60,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 19 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$750,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 20 of Act 904 of 2017, for construction of confined space and rescue technique simulators, in a sum not to exceed\$500,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 20 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$50,000.

SECTION 24. REAPPROPRIATION - SAU - TECH - ENVIRONMENTAL TRAINING ACADEMY. There is hereby appropriated, to the SAU-Tech, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the SAU-Tech the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 21 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$20,000.

SECTION 25. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT BATESVILLE. There is hereby appropriated, to the University of Arkansas Community College at Batesville, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas Community College at Batesville the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 22 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Workforce Training Center, in a sum not to exceed\$1,250,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 22 of Act 904 of 2017, for upgrades, repair, and replacement of instructional equipment, in a sum not to exceed\$600,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 22 of Act 904 of 2017, for maintenance and stabilization of the vehicular bridge near the center of campus, in a sum not to exceed\$250,000.

(D) Effective July 1, 2018, the balance of the appropriation provided

in Item (D) of Section 22 of Act 904 of 2017, for land acquisition, in a sum not to exceed\$750,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 22 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$330,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 22 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$170,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 22 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$143,800.

SECTION 26. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT HOPE. There is hereby appropriated, to the University of Arkansas Community College at Hope, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas Community College at Hope the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 23 of Act 674 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$34,574.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 23 of Act 904 of 2017, for upgrades and replacement of instructional technology, in a sum not to exceed\$420,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 23 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Testing Center, in a sum not to exceed\$685,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 23 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Texarkana Student and Career Services Center, in a sum not to exceed\$1,745,000.

(E) Effective July 1, 2018, the balance of the appropriation provided

in Item (D) of Section 23 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$60,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 23 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$230,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 23 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$136,535.

SECTION 27. REAPPROPRIATION - UNIVERSITY OF ARKANSAS COMMUNITY COLLEGE AT MORRILTON. There is hereby appropriated, to the University of Arkansas Community College at Morrilton, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas Community College at Morrilton the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 24 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources of a Workforce Training Center, in a sum not to exceed\$600,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 24 of Act 904 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources to expand Technology Building III, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 24 of Act 904 of 2017, for critical maintenance, in a sum not to exceed\$40,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 24 of Act 904 of 2017, for deferred maintenance, in a sum not to exceed\$400,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 24 of Act 904 of 2017, for repair or replacement of equipment and library holdings, in a sum not to exceed\$231,395.

SECTION 28. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects

described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 29. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 30. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
