AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas State
University, to be payable from the General Improvement Fund or its successor
fund or fund accounts, for the Arkansas State University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided
in Item (G) of Section 1 of Act 702 of 2017, for construction, renovation,
maintenance, equipment, personal services and operating expenses of the
various institutions and entities of the Arkansas State University System, in
a sum not to exceed\$100,000.

(B) Effective July 1, 2018, the balance of the appropriation provided
in Item (A) of Section 1 of Act 842 of 2017, for construction, renovation,
maintenance, equipment, personal services and operating expenses of the
various institutions and entities of the Arkansas State University System, in
a sum not to exceed\$15,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided
in Item (B) of Section 1 of Act 842 of 2017, for construction of a College of
Engineering building, in a sum not to exceed\$4,000,000.



(D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 1 of Act 842 of 2017, for College of Education and Communications restrooms renovation, in a sum not to exceed\$908,500.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 1 of Act 842 of 2017, for Library HVAC system renovation and modernization, in a sum not to exceed\$2,000,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 1 of Act 842 of 2017, for Lab Sciences Lab and HVAC System renovation and modernization, in a sum not to exceed\$1,291,500.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 1 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$1,840,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 1 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$4,940,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 1 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$2,342,774.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - NCRC - V.C. KAYS HOUSE HERITAGE SITE. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$88,000.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - NCRC - KAIT - TV NEWS FILM COLLECTION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided

in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$25,000.

SECTION 4. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Arkansas Tech University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Tech University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 2 of Act 842 of 2017, for reroofing the Allied Health Building on the Ozark Campus, in a sum not to exceed\$107,731.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 2 of Act 842 of 2017, for technology upgrades, including a partial renovation of Corley Hall and connecting the Ozark Campus to the AREON, in a sum not to exceed\$5,832,533.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 2 of Act 842 of 2017, for instructional technology in labs for the Ozark Campus, in a sum not to exceed\$244,213.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 2 of Act 842 of 2017, for construction of an academic classroom facility, in a sum not to exceed\$2,367,467.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 2 of Act 842 of 2017, for renovation of restrooms in the Technology and Academic Support building on the Ozark Campus, in a sum not to exceed\$120,589.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 2 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$300,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 2 of Act 842 of 2017, for critical maintenance for the Ozark Campus, in a sum not to exceed\$30,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 2 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$2,460,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 2 of Act 842 of 2017, for purchase, replacement, and

renewal of equipment and library holdings, in a sum not to exceed
.....\$1,361,321.

(J) Effective July 1, 2018, the balance of the appropriation provided in Item (J) of Section 2 of Act 842 of 2017, for deferred maintenance for the Ozark Campus, in a sum not to exceed\$190,000.

(K) Effective July 1, 2018, the balance of the appropriation provided in Item (K) of Section 2 of Act 842 of 2017, for purchase, replacement, and renewal of equipment and library holdings at the Ozark Campus, in a sum not to exceed\$149,510.

SECTION 5. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - NCRC - RENOVATION OF WILLIAMSON HALL. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$600,000.

SECTION 6. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Henderson State University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Henderson State University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 3 of Act 842 of 2017, for construction of a HPER building and renovation of the Wells Building, in a sum not to exceed\$3,000,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 3 of Act 842 of 2017, for renovation of the Russell Fine Arts Building, in a sum not to exceed\$3,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 3 of Act 842 of 2017, for construction of a School of Business building and renovation of Mooney Hall, in a sum not to exceed\$1,200,000.

(D) Effective July 1, 2018, the balance of the appropriation provided

in Item (D) of Section 3 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$800,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 3 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$1,820,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 3 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$541,895.

SECTION 7. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - NCRC - CADDO CENTER CAFETERIA RENOVATIONS. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$1,092,777.

SECTION 8. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - GENERAL IMPROVEMENT. There is hereby appropriated, to the Southern Arkansas University, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Southern Arkansas University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 7 of Act 702 of 2017, for deferred maintenance expenses, in a sum not to exceed\$11,329.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 7 of Act 702 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$30,735.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 7 of Act 702 of 2017, for deferred maintenance, in a sum not to exceed\$500,000.

(D) Effective July 1, 2018, the balance of the appropriation provided

in Item (A) of Section 4 of Act 842 of 2017, for construction of an Educational building, in a sum not to exceed\$1,350,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 4 of Act 842 of 2017, for technology infrastructure improvements and upgrades, in a sum not to exceed\$3,465,750.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 4 of Act 842 of 2017, for renovation of Childs Hall and ADA upgrades to create the Science, Technology, Engineering and Mathematics training center, in a sum not to exceed\$2,384,250.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 4 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$420,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 4 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$1,780,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 4 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$618,586.

SECTION 9. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - NCRC - ALEXANDER HOUSE. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$400,000.

SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas for Medical Sciences the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 5 of Act 842 of 2017, for upgrades to the Central

Building to meet code requirements, in a sum not to exceed\$4,200,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 5 of Act 842 of 2017, for expansion of the Electronic Health System to Primary Care Clinics managed by UAMS Regional Programs and Specialty Clinics operating at the UAMS Northwest Campus, in a sum not to exceed\$2,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 5 of Act 842 of 2017, for the purchase of new and replacement hospital clinical equipment, in a sum not to exceed ..\$1,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 5 of Act 842 of 2017, for construction of an energy plant on the Little Rock campus, in a sum not to exceed\$1,000,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 5 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$2,030,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 5 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$10,730,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 5 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$1,927,257.

SECTION 11. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 9 of Act 702 of 2017, for personal services and general operating expenses of the Partners for Inclusive Communities - Sickle Cell Anemia Task Force, in a sum not to exceed\$60,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (Z) of Section 9 of Act 702 of 2017, for personal services and general operating expenses, construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources for U of A - Fayetteville - Partners for Inclusive

Communities, in a sum not to exceed\$41,542.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (AA) of Section 9 of Act 702 of 2017, for U of A Fayetteville Partners for Inclusive Communities Autism Awareness Supporting Grants, in a sum not to exceed\$38,867.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 9 of Act 702 of 2017, for construction of a Creativity and Innovation Complex for the ASMSA, in a sum not to exceed\$500,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (W) of Section 9 of Act 702 of 2017, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed\$1,183,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 6 of Act 842 of 2017, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed\$15,000,000.

(R) Effective July 1, 2018, the balance of the appropriation provided in Item (M) of Section 6 of Act 842 of 2017, for costs of bank stabilization of Coleman Creek for the Division of Agriculture - Cooperative Extension Service headquarters, in a sum not to exceed\$200,000.

(S) Effective July 1, 2018, the balance of the appropriation provided in Item (N) of Section 6 of Act 842 of 2017, for costs of constructing a Multi-Purpose Building & Community Hall for the ASMSA, in a sum not to exceed\$525,000.

(T) Effective July 1, 2018, the balance of the appropriation provided in Item (O) of Section 6 of Act 842 of 2017, for technology and equipment upgrades at the Criminal Justice Institute, in a sum not to exceed\$240,000.

(U) Effective July 1, 2018, the balance of the appropriation provided in Item (P) of Section 6 of Act 842 of 2017, for deferred maintenance of the Arkansas Archeological Survey, in a sum not to exceed\$80,000.

(V) Effective July 1, 2018, the balance of the appropriation provided in Item (Q) of Section 6 of Act 842 of 2017, for critical maintenance at the U of A - System, in a sum not to exceed\$10,000.

(W) Effective July 1, 2018, the balance of the appropriation provided in Item (R) of Section 6 of Act 842 of 2017, for costs of constructing and equipping a Rice Innovation Center of the Division of Agriculture, in a sum not to exceed\$1,000,000.

(X) Effective July 1, 2018, the balance of the appropriation provided in Item (S) of Section 6 of Act 842 of 2017, for critical maintenance for the U of A - Division of Agriculture, in a sum not to exceed\$70,000.

(Y) Effective July 1, 2018, the balance of the appropriation provided in Item (T) of Section 6 of Act 842 of 2017, for costs of renovation of the Fine Arts Center, in a sum not to exceed\$1,200,000.

(Z) Effective July 1, 2018, the balance of the appropriation provided in Item (U) of Section 6 of Act 842 of 2017, for critical maintenance for the U of A - Fayetteville, in a sum not to exceed\$3,390,000.

(AA) Effective July 1, 2018, the balance of the appropriation provided in Item (V) of Section 6 of Act 842 of 2017, for deferred maintenance of the U of A - Division of Agriculture, in a sum not to exceed\$1,600,000.

(AB) Effective July 1, 2018, the balance of the appropriation provided in Item (W) of Section 6 of Act 842 of 2017, for deferred maintenance at the U of A - System, in a sum not to exceed\$40,000.

(AC) Effective July 1, 2018, the balance of the appropriation provided in Item (X) of Section 6 of Act 842 of 2017, for deferred maintenance for the U of A - Fayetteville, in a sum not to exceed\$9,090,000.

(AD) Effective July 1, 2018, the balance of the appropriation provided in Item (Y) of Section 6 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$4,555,200.

SECTION 12. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - NCRC - REPAIR/RESTORATION OF HISTORIC ARKANSAS AVE. SANDSTONE WALL. There is hereby appropriated, to the University of Arkansas, to be payable from the

Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$510,000.

SECTION 13. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FAYETTEVILLE - NCRC - PRESERVING AND INTERPRETING ARKANSAS HERITAGE - NEW APPROACHES.

There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$90,000.

SECTION 14. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - LITTLE ROCK - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Sustainable Building Design Revolving Loan Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 12 of Act 1043 of 2017, for construction, renovation, maintenance and operating expenses, in a sum not to exceed\$1,495,000.

SECTION 15. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - LITTLE ROCK - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 15 of Act 702 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and library resources, in a sum not to exceed\$1,263.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 15 of Act 702 of 2017, for improvements to technology infrastructure, in a sum not to exceed\$431,673.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 7 of Act 842 of 2017, for improvements to technology infrastructure, in a sum not to exceed\$4,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 7 of Act 842 of 2017, for construction costs to complete the Nanotechnology Center, in a sum not to exceed\$3,000,000.

SECTION 16. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - LITTLE ROCK - NCRC - SEQUOYAH RESEARCH CENTER. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$20,000.

SECTION 17. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of

Arkansas at Monticello, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 17 of Act 702 of 2017, for grants to cities, counties, planning and development districts, and other eligible entities for land acquisition, improvements, construction, renovation, major maintenance, and purchase of equipment, industrial site development costs including, construction, renovation, and equipment acquisition, development of intermodal facilities, including port and waterway projects, rail spur construction and road and highway improvements, environmental mitigation projects, and construction and improvement of water and sewer systems, in a sum not to exceed\$20,500.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 17 of Act 702 of 2017, for wireless access point and controller expenses, in a sum not to exceed\$144,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (O) of Section 17 of Act 702 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and furnishings for the UAM - Crossett campus, in a sum not to exceed\$25,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (P) of Section 17 of Act 702 of 2017, for construction, renovation, maintenance, critical maintenance, equipment, security enhancements, technology upgrades/equipment and furnishings for the UAM - McGehee campus, in a sum not to exceed\$25,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (N) of Section 17 of Act 702 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$250,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 8 of Act 842 of 2017, for costs of construction of the Workforce/Collegiate Center on the Crossett campus, in a sum not to exceed\$1,050,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 8 of Act 842 of 2017, for construction of a General

Education Building on the McGehee campus, in a sum not to exceed
.....\$1,050,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 8 of Act 842 of 2017, for construction of a Math and Science Center, in a sum not to exceed\$3,500,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 8 of Act 842 of 2017, for critical maintenance on the Crossett campus, in a sum not to exceed\$40,000.

(J) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 8 of Act 842 of 2017, for costs of renovation of the Old Student Union, in a sum not to exceed\$2,000,000.

(K) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 8 of Act 842 of 2017, for costs of renovation of the Library and Technology Center, in a sum not to exceed\$325,000.

(L) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 8 of Act 842 of 2017, for critical maintenance at the McGehee campus, in a sum not to exceed\$70,000.

(M) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 8 of Act 842 of 2017, for deferred maintenance at the McGehee campus, in a sum not to exceed\$140,000.

(N) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 8 of Act 842 of 2017, for deferred maintenance at the Crossett campus, in a sum not to exceed\$110,000.

(O) Effective July 1, 2018, the balance of the appropriation provided in Item (J) of Section 8 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings at the Crossett Campus, in a sum not to exceed\$27,895.

(P) Effective July 1, 2018, the balance of the appropriation provided in Item (K) of Section 8 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings at the McGehee Campus, in a sum not to exceed\$28,830.

(Q) Effective July 1, 2018, the balance of the appropriation provided in Item (L) of Section 8 of Act 842 of 2017, for costs of renovation of the Fine Arts Center, in a sum not to exceed\$375,000.

(R) Effective July 1, 2018, the balance of the appropriation provided in Item (M) of Section 8 of Act 842 of 2017, for critical maintenance, in a

sum not to exceed\$1,340,000.

(S) Effective July 1, 2018, the balance of the appropriation provided in Item (N) of Section 8 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$1,710,000.

(T) Effective July 1, 2018, the balance of the appropriation provided in Item (O) of Section 8 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$387,969.

SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO - NCRC - HOLLYWOOD PLANTATION - TAYLOR HOUSE. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$550,000.

SECTION 19. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 19 of Act 702 of 2017, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$144,000.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 19 of Act 702 of 2017, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$700,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 9 of Act 842 of 2017, for costs of campus renovations and repair, in a sum not to exceed\$3,000,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 9 of Act 842 of 2017, for costs of construction of a Nanotechnology/Biotechnology Center, in a sum not to exceed\$2,000,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 9 of Act 842 of 2017, for costs of construction of a Life Sciences facility, in a sum not to exceed\$1,200,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 9 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$150,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 9 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$1,500,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 9 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$387,294.

SECTION 20. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF - NCRC - CALDWELL HALL AND CAMPUS BELL TOWER. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$630,000.

SECTION 21. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Arkansas - Fort Smith, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Arkansas - Fort Smith the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 13 of Act 702 of 2017, for costs of designing, renovating, and equipping the Math-Science building, in a sum not to exceed\$132,265.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 10 of Act 842 of 2017, for costs of designing, renovating, and equipping the Math-Science building, in a sum not to exceed

-\$3,000,000.
- (C) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 10 of Act 842 of 2017, for costs of constructing an expanded Math-Science building, in a sum not to exceed\$2,000,000.
- (D) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 10 of Act 842 of 2017, for costs of construction of a College of Business building, in a sum not to exceed\$1,700,000.
- (E) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 10 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$290,000.
- (F) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 10 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$1,460,000.
- (G) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 10 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$829,488.

SECTION 22. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH - NCRC - WILHAUF HOUSE RESTORATION. There is hereby appropriated, to the University of Arkansas - Fort Smith, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas - Fort Smith the following:

- (A) Effective July 1, 2018, the balance of the appropriation provided in Section 23 of Act 234 of 2017, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$600,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - GENERAL IMPROVEMENT. There is hereby appropriated, to the University of Central Arkansas, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the University of Central Arkansas the following:

- (A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 11 of Act 842 of 2017, for critical maintenance, in a sum not to exceed\$1,340,000.
- (B) Effective July 1, 2018, the balance of the appropriation provided

in Item (B) of Section 11 of Act 842 of 2017, for costs of construction for an addition to, renovation of, and equipment for the Lewis Science Center, in a sum not to exceed\$4,000,000.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 11 of Act 842 of 2017, for costs of construction of the Institute for Wellness and Restorative Health facility, in a sum not to exceed\$2,100,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 11 of Act 842 of 2017, for costs of construction of a College of Fine Arts and Communication building, in a sum not to exceed\$2,100,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 11 of Act 842 of 2017, for deferred maintenance, in a sum not to exceed\$3,650,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 11 of Act 842 of 2017, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$2,041,509.

SECTION 24. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in

disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 25. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 26. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
