AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF
ARKANSAS STATE POLICE; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE DEPARTMENT OF ARKANSAS
STATE POLICE REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - GENERAL IMPROVEMENT PROJECTS. There is hereby appropriated, to the Department of Arkansas State Police, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Arkansas State Police the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 1 of Act 407 of 2017, for maintenance, renovation, construction, equipping, improvement, upgrade, land acquisition and repairs, in a sum not to exceed\$160,500.

(B) Effective July 1, 2018, the balance of the appropriation provided in Item (I) of Section 1 of Act 407 of 2017, for radio repeater infrastructure replacement on the Arkansas Wireless Information Network, in a sum not to exceed\$1,370,943.

(C) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 1 of Act 226 of 2017, for fleet vehicle purchase, equipping and sales tax, in a sum not to exceed\$9,200,000.

(D) Effective July 1, 2018, the balance of the appropriation provided in Item (B) of Section 1 of Act 226 of 2017, for Bell Helicopter maintenance,



in a sum not to exceed\$250,000.

(E) Effective July 1, 2018, the balance of the appropriation provided in Item (C) of Section 1 of Act 226 of 2017, for software and hardware to implement an online reporting system for Crimes Against Children Division mandated reporters, in a sum not to exceed\$750,000.

(F) Effective July 1, 2018, the balance of the appropriation provided in Item (D) of Section 1 of Act 226 of 2017, for the replacement of microwave radio equipment installed on the Arkansas Wireless Information Network (AWIN), in a sum not to exceed\$12,900,000.

(G) Effective July 1, 2018, the balance of the appropriation provided in Item (E) of Section 1 of Act 226 of 2017, for Lonoke County Tower replacement and relocation, in a sum not to exceed\$850,000.

(H) Effective July 1, 2018, the balance of the appropriation provided in Item (F) of Section 1 of Act 226 of 2017, for building and tower remediation of the Arkansas Wireless Information System, in a sum not to exceed\$1,500,000.

(I) Effective July 1, 2018, the balance of the appropriation provided in Item (G) of Section 1 of Act 226 of 2017, for hardware and software to track radio system traffic of the AWIN User Management System, in a sum not to exceed\$100,000.

(J) Effective July 1, 2018, the balance of the appropriation provided in Item (H) of Section 1 of Act 226 of 2017, for various maintenance, operations, equipping, construction, acquisition, improvement, upgrade and repair of the Arkansas Wireless Information Network system, in a sum not to exceed\$10,000,000.

SECTION 2. REAPPROPRIATION - STATE POLICE - TROOP L HEADQUARTERS.

There is hereby appropriated, to the Department of Arkansas State Police, to be payable from the Department of Arkansas State Police Fund, for the Department of Arkansas State Police the following:

(A) Effective July 1, 2018, the balance of the appropriation provided in Item (A) of Section 2 of Act 407 of 2017, for construction of a new ASP Troop L Headquarters in Lowell, Arkansas, in a sum not to exceed ..\$875,000.

SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects

described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 5. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
