## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
AND OPERATING EXPENSES FOR THE STATE BOARD OF  
PHARMACY FOR THE FISCAL YEAR ENDING JUNE 30, 2019;  
AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE STATE BOARD OF PHARMACY  
APPROPRIATION FOR THE 2018-2019 FISCAL  
YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the State Board of Pharmacy for the 2018-2019 fiscal year, the following maximum number of regular employees.

SECTION 2. EXTRA HELP. There is hereby authorized, for the State Board of Pharmacy for the 2018-2019 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: four (4) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to the State Board of Pharmacy, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for personal services and operating expenses of the State Board of Pharmacy for the fiscal year ending June 30, 2019, the following:

SECTION 4. APPROPRIATION - PHARMACY STUDENT LOANS. There is hereby appropriated, to the State Board of Pharmacy, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for transfer by warrant to the cash fund as defined by

Arkansas Code 19-4-801 of the University of Arkansas for Medical Sciences - College of Pharmacy for the fiscal year ending June 30, 2019, the following:

SECTION 5. APPROPRIATION - PHARMACY STUDENT LOANS AND SCHOLARSHIPS.

There is hereby appropriated, to the State Board of Pharmacy, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for grants to colleges of pharmacy in Arkansas for pharmacy student loans and scholarships for the fiscal year ending June 30, 2019, the following:

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER BY WARRANT. If, during the ~~2017-2018~~ 2018-2019 fiscal year, the need arises for additional funding for student loans and additional funds become available, the Director of the State Board of Pharmacy may request the Chief Fiscal Officer of the State to cause a transfer by warrant up to fifty thousand dollars (\$50,000) from the balance of cash funds deposited in the State Treasury for the State Board of Pharmacy to the cash fund as defined by the Arkansas Code 19-4-801 of the University of Arkansas for Medical Sciences, there to be used for the sole purpose of providing student loans to pharmacy students.

The provisions of this section shall be in effect only from July 1, ~~2017~~ 2018 through June 30, ~~2018~~ 2019.

SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and

Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 9. EFFECTIVE DATE. This act is effective on and after July 1, 2018.
