## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE DEPARTMENT OF  
PUBLIC SAFETY; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE DEPARTMENT OF PUBLIC  
SAFETY REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

### SECTION 1. REAPPROPRIATION - LAW ENFORCEMENT STANDARDS AND TRAINING.

There is hereby appropriated, to the Department of Public Safety, to be payable from the Development and Enhancement Fund, for the Department of Public Safety - Arkansas Commission on Law Enforcement Standards and Training the following:

(A) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 281 of 2019, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities department-wide, in a sum not to exceed .....\$140,729.

(B) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 415 of 2019, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities department-wide, in a sum not to exceed .....\$2,100,000.

(C) Effective July 1, 2020, the balance of the appropriation provided in Item (B) of Section 1 of Act 415 of 2019, for renovation of Heat/AC at



North Dorm, in a sum not to exceed .....\$700,000.

(D) Effective July 1, 2020, the balance of the appropriation provided in Item (C) of Section 1 of Act 415 of 2019, for professional services, maintenance, equipment, security enhancements, technology/equipment and internet connectivity expenses, in a sum not to exceed .....\$236,000.

(E) Effective July 1, 2020, the balance of the appropriation provided in Item (D) of Section 1 of Act 415 of 2019, for various maintenance, renovation, equipping, construction, acquisition, improvement, and upgrades to facilities, in a sum not to exceed .....\$1,127,000.

(F) Effective July 1, 2020, the balance of the appropriation provided in Item (E) of Section 1 of Act 415 of 2019, for construction, maintenance, renovation, and equipping of a general purpose building at Springdale Academy, in a sum not to exceed .....\$250,000.

(G) Effective July 1, 2020, the balance of the appropriation provided in Item (F) of Section 1 of Act 415 of 2019, for equipment upgrades and construction to meet training needs, in a sum not to exceed .....\$68,000.

SECTION 2. REAPPROPRIATION - STATE POLICE. There is hereby appropriated, to the Department of Public Safety, to be payable from the Development and Enhancement Fund, for the Department of Public Safety - Division of Arkansas State Police the following:

(A) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 227 of 2019, for maintenance, renovation, construction, equipping, improvement, upgrade, land acquisition and repairs, in a sum not to exceed .....\$160,500.

(B) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 412 of 2019, for construction of a driving track at Camp Robinson, in a sum not to exceed .....\$4,000,000.

(C) Effective July 1, 2020, the balance of the appropriation provided in Item (B) of Section 1 of Act 412 of 2019, for software and hardware to implement an online reporting system for Crimes Against Children Division mandated reporters, in a sum not to exceed .....\$750,000.

SECTION 3. REAPPROPRIATION - STATE CRIME LABORATORY. There is hereby appropriated, to the Department of Public Safety, to be payable from the Development and Enhancement Fund, for the Department of Public Safety - State

Crime Laboratory the following:

(A) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 231 of 2019, for constructing and equipping a forensic laboratory in Northwest Arkansas, in a sum not to exceed ...\$83,178.

(B) Effective July 1, 2020, the balance of the appropriation provided in Item (A) of Section 1 of Act 352 of 2019, for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities, in a sum not to exceed ...\$3,500,000.

(C) Effective July 1, 2020, the balance of the appropriation provided in Item (B) of Section 1 of Act 352 of 2019, for constructing and equipping a forensic laboratory in Northwest Arkansas, in a sum not to exceed .....\$4,700,000.

SECTION 4. REAPPROPRIATION - EMERGENCY MANAGEMENT. There is hereby appropriated, to the Department of Public Safety, to be payable from the Development and Enhancement Fund, for the Department of Public Safety - Arkansas Department of Emergency Management the following:

(A) Effective July 1, 2020, the balance of the appropriation provided in Item (C) of Section 1 of Act 412 of 2019, for the replacement of microwave radio equipment installed on the Arkansas Wireless Information Network , in a sum not to exceed .....\$12,900,000.

(B) Effective July 1, 2020, the balance of the appropriation provided in Item (D) of Section 1 of Act 412 of 2019, for building and tower remediation of the Arkansas Wireless Information System , in a sum not to exceed .....\$1,500,000.

SECTION 5. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General

Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2020 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2020 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2020.
