AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the Arkansas
State University, to be payable from the Development and Enhancement Fund,
for the Arkansas State University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided
in Item (A) of Section 1 of Act 103 of 2020, for construction, renovation,
maintenance, equipment, personal services and operating expenses of the
various institutions and entities of the Arkansas State University System, in
a sum not to exceed\$14,916,750.

(B) Effective July 1, 2021, the balance of the appropriation provided
in Item (B) of Section 1 of Act 103 of 2020, for information technology
infrastructure upgrades and security, in a sum not to exceed\$3,193,448.

(C) Effective July 1, 2021, the balance of the appropriation provided
in Item (C) of Section 1 of Act 103 of 2020, for costs of construction of a
College of Engineering building, in a sum not to exceed\$1,093,847.

(D) Effective July 1, 2021, the balance of the appropriation provided
in Item (D) of Section 1 of Act 103 of 2020, for College of Education and



Communications restrooms renovation, in a sum not to exceed\$1,090,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 1 of Act 103 of 2020, for Library HVAC system renovation and modernization, in a sum not to exceed\$2,822,705.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 1 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$670,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 1 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$2,720,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 1 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$2,962,756.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (I) of Section 1 of Act 103 of 2020, for maintenance of the facilities of the Arkansas State University System, in a sum not to exceed\$15,000,000.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - LAKEPORT PLANTATION RESTORATION. There is hereby appropriated, to the Arkansas State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$155,838.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the Arkansas State University, to be payable from the Sustainable Building Design Revolving Loan Fund, for the Arkansas State University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 4 of Act 103 of 2020, for construction, renovation, maintenance and operating expenses, in a sum not to exceed\$171,957.

SECTION 4. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Development and Enhancement Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 5 of Act 103 of 2020, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the Arkansas Tech University, in a sum not to exceed\$15,000,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 5 of Act 103 of 2020, for costs of construction of a Student Union, in a sum not to exceed\$3,500,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 5 of Act 103 of 2020, for costs of construction of an O Street and Campus Entrance, in a sum not to exceed\$1,928,302.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 5 of Act 103 of 2020, for renovation for Brown building academic utilization, in a sum not to exceed\$1,180,438.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 5 of Act 103 of 2020, for costs of land purchase, in a sum not to exceed\$555,600.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 5 of Act 103 of 2020, for renovation of campus signage to be ADA compliant, in a sum not to exceed\$1,035,660.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 5 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$1,150,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 5 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$2,460,000.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (I) of Section 5 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$1,394,203.

(J) Effective July 1, 2021, the balance of the appropriation provided

in Item (J) of Section 5 of Act 103 of 2020, for reroofing the Allied Health Building on the Ozark Campus, in a sum not to exceed\$118,510.

(K) Effective July 1, 2021, the balance of the appropriation provided in Item (K) of Section 5 of Act 103 of 2020, for costs of construction of a Technology Trade Center, in a sum not to exceed\$354,023.

(L) Effective July 1, 2021, the balance of the appropriation provided in Item (L) of Section 5 of Act 103 of 2020, for critical maintenance for the Ozark Campus, in a sum not to exceed\$10,000.

(M) Effective July 1, 2021, the balance of the appropriation provided in Item (M) of Section 5 of Act 103 of 2020, for deferred maintenance for the Ozark Campus, in a sum not to exceed\$190,000.

(N) Effective July 1, 2021, the balance of the appropriation provided in Item (N) of Section 5 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings at the Ozark Campus, in a sum not to exceed\$69,290.

SECTION 5. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the Henderson State University, to be payable from the Development and Enhancement Fund, for the Henderson State University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 6 of Act 103 of 2020, for renovation of the Russell Fine Arts Building, in a sum not to exceed\$6,610,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 6 of Act 103 of 2020, for renovation of Mooney Hall, in a sum not to exceed\$114,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 6 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$260,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 6 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$1,810,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 6 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$540,646.

SECTION 6. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - CAPTAIN HENDERSON HOUSE. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$586,688.

SECTION 7. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Development and Enhancement Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 7 of Act 103 of 2020, for costs of HVAC replacement and upgrades, in a sum not to exceed\$3,783,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 7 of Act 103 of 2020, for technology infrastructure improvements and upgrades, in a sum not to exceed\$2,905,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 7 of Act 103 of 2020, for renovation of Childs Hall and ADA upgrades to create the Science, Technology, Engineering and Mathematics Training Center, in a sum not to exceed\$277,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 7 of Act 103 of 2020, for costs of construction of a bridge to a pump station, in a sum not to exceed\$75,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 7 of Act 103 of 2020, for costs of upgrading the campus sanitary sewer line, in a sum not to exceed\$65,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 7 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$490,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 7 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$1,310,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 7 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$821,638.

SECTION 8. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - BUSSEY HALL RESTORATION. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$698,060.

SECTION 9. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY - OZMER-ALEXANDER FARMSTEAD. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$295,691.

SECTION 10. REAPPROPRIATION - UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the Development and Enhancement Fund, for the University of Arkansas for Medical Sciences the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 8 of Act 103 of 2020, for information technology infrastructure and cybersecurity with classroom technology upgrade, in a sum not to exceed\$5,455,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 8 of Act 103 of 2020, for costs of construction of Pine and Cedar Street modification and enhancement, in a sum not to exceed\$2,745,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 8 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$6,710,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 8 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$10,820,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 8 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$2,018,873.

SECTION 11. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas at Fayetteville, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Fayetteville the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 9 of Act 103 of 2020, for personal services and general operating expenses of the Partners for Inclusive Communities - Sickle Cell Anemia Task Force, in a sum not to exceed\$60,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 9 of Act 103 of 2020, for U of A Fayetteville Partners for Inclusive Communities Autism Awareness Supporting Grants, in a sum not to exceed\$25,811.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 9 of Act 103 of 2020, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed\$613,965.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 9 of Act 103 of 2020, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed\$13,267,931.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 9 of Act 103 of 2020, for technology and equipment upgrades at the Clinton School, in a sum not to exceed\$25,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 9 of Act 103 of 2020, for costs of construction of the Student Success Center and demolition of the School of Social Work building, in a sum not to exceed\$5,000,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 9 of Act 103 of 2020, for costs of construction of the Research Laboratory Office Building and demolition of the Agriculture Annex, in a sum not to exceed\$3,000,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (I) of Section 9 of Act 103 of 2020, for renovation and restoration of the Fine Arts Center, in a sum not to exceed\$1,200,000.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (J) of Section 9 of Act 103 of 2020, for critical maintenance for the U of A - Fayetteville, in a sum not to exceed\$5,330,000.

(J) Effective July 1, 2021, the balance of the appropriation provided in Item (K) of Section 9 of Act 103 of 2020, for upgrades and renovations to the Agricultural Research and Extension Centers and Stations of the Division of Agriculture, in a sum not to exceed\$1,100,000.

(K) Effective July 1, 2021, the balance of the appropriation provided in Item (L) of Section 9 of Act 103 of 2020, for costs of replacing the Alzheimer Laboratory Building, in a sum not to exceed\$2,000,000.

(L) Effective July 1, 2021, the balance of the appropriation provided in Item (M) of Section 9 of Act 103 of 2020, for costs of construction of the Rice Innovation Center of the Division of Agriculture, in a sum not to exceed\$1,000,000.

(M) Effective July 1, 2021, the balance of the appropriation provided in Item (N) of Section 9 of Act 103 of 2020, for broadband expansion and rural fiber deployment for research stations, the National Center for Toxicological Research, and member branch campuses, in a sum not to exceed\$525,000.

(N) Effective July 1, 2021, the balance of the appropriation provided in Item (O) of Section 9 of Act 103 of 2020, for broadband expansion and rural fiber deployment in Mena, De Queen, and West Helena, in a sum not to exceed\$500,000.

(O) Effective July 1, 2021, the balance of the appropriation provided in Item (P) of Section 9 of Act 103 of 2020, for costs of campus ADA

accessibility improvements for the Arkansas School for Mathematics, Sciences, and the Arts (ASMSA), in a sum not to exceed\$250,000.

(P) Effective July 1, 2021, the balance of the appropriation provided in Item (Q) of Section 9 of Act 103 of 2020, for upgrades to the ASMSA STEM Research Lab, in a sum not to exceed\$220,000.

(Q) Effective July 1, 2021, the balance of the appropriation provided in Item (R) of Section 9 of Act 103 of 2020, for costs of construction of a Multi-Purpose Building for the ASMSA, in a sum not to exceed\$555,000.

(R) Effective July 1, 2021, the balance of the appropriation provided in Item (S) of Section 9 of Act 103 of 2020, for construction costs for the expansion of office and storage space at the U of A - System Office, in a sum not to exceed\$1,025,000.

(S) Effective July 1, 2021, the balance of the appropriation provided in Item (T) of Section 9 of Act 103 of 2020, for maintenance of facilities of the U of A - System, in a sum not to exceed\$15,000,000.

(T) Effective July 1, 2021, the balance of the appropriation provided in Item (U) of Section 9 of Act 103 of 2020, for critical maintenance of the U of A - Division of Agriculture, in a sum not to exceed\$70,000.

(U) Effective July 1, 2021, the balance of the appropriation provided in Item (V) of Section 9 of Act 103 of 2020, for critical maintenance for the U of A - System, in a sum not to exceed\$10,000.

(V) Effective July 1, 2021, the balance of the appropriation provided in Item (W) of Section 9 of Act 103 of 2020, for deferred maintenance for the U of A - Fayetteville, in a sum not to exceed\$9,220,000.

(W) Effective July 1, 2021, the balance of the appropriation provided in Item (X) of Section 9 of Act 103 of 2020, for deferred maintenance for the U of A - Division of Agriculture, in a sum not to exceed\$1,560,000.

(X) Effective July 1, 2021, the balance of the appropriation provided in Item (Y) of Section 9 of Act 103 of 2020, for deferred maintenance for the U of A - System, in a sum not to exceed\$40,000.

(Y) Effective July 1, 2021, the balance of the appropriation provided in Item (Z) of Section 9 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings for the U of A - Fayetteville, in a sum not to exceed\$5,048,062.

SECTION 12. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - JOHN A. WHITE,

JR. ENGINEERING HALL. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$600,000.

SECTION 13. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - GARVAN TERRACES, TRAILS AND BRIDGE PROJECT. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$372,700.

SECTION 14. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - GIBSON ANNEX EXTERIOR RESTORATION. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$392,777.

SECTION 15. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - VISUAL ARCHIVE OF CCC HISTORY IN ARKANSAS STATE PARKS. There is hereby appropriated, to the University of Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$50,000.

SECTION 16. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH -

DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas at Fort Smith, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Fort Smith the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 14 of Act 103 of 2020, for costs of construction and renovation for the UAFS Center for Workforce Development, in a sum not to exceed\$6,522,500.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 14 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$530,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 14 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$1,550,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 14 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$794,691.

SECTION 17. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - FORT SMITH - WILLHAF HOUSE RESTORATION. There is hereby appropriated, to the University of Arkansas - Fort Smith, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas - Fort Smith the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$678,461.

SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 16 of Act 103 of 2020, for costs of replacing building infrastructure and performing critical maintenance, in a sum not to exceed

-\$1,000,000.
- (B) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 16 of Act 103 of 2020, for construction costs to complete the Nanotechnology Center, in a sum not to exceed\$3,200,000.
- (C) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 16 of Act 103 of 2020, for improvements to technology infrastructure, in a sum not to exceed\$4,000,000.
- (D) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 16 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$6,130,000.
- (E) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 16 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$5,280,000.

There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Little Rock the following:

- (A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$73,014.

SECTION 20. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK - CONSTITUTIONAL CONVENTION. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Little Rock the following:

- (A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures

or objects, in a sum not to exceed\$35,628.

SECTION 21. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Sustainable Building Design Revolving Loan Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 12 of Act 152 of 2020, for construction, renovation, maintenance and operating expenses, in a sum not to exceed\$1,000,000.

SECTION 22. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 18 of Act 103 of 2020, for costs of construction of a Math and Science Center, in a sum not to exceed\$4,950,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 18 of Act 103 of 2020, for renovation of the Fine Arts Center, in a sum not to exceed\$500,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 18 of Act 103 of 2020, for renovation of the Music Building, in a sum not to exceed\$750,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 18 of Act 103 of 2020, for costs of construction of the Workforce/Collegiate Center on the Crossett campus, in a sum not to exceed\$1,050,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 18 of Act 103 of 2020, for costs of construction of a General Education Building on the McGehee campus, in a sum not to exceed\$1,050,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 18 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$2,260,000.

(G) Effective July 1, 2021, the balance of the appropriation provided

in Item (I) of Section 18 of Act 103 of 2020, for deferred maintenance at the Crossett campus, in a sum not to exceed\$110,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (J) of Section 18 of Act 103 of 2020, for deferred maintenance at the McGehee campus, in a sum not to exceed\$140,000.

(I) Effective July 1, 2021, the balance of the appropriation provided in Item (K) of Section 18 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$462,646.

(J) Effective July 1, 2021, the balance of the appropriation provided in Item (L) of Section 18 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings at the Crossett campus, in a sum not to exceed\$14,015.

(K) Effective July 1, 2021, the balance of the appropriation provided in Item (M) of Section 18 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings at the McGehee campus, in a sum not to exceed\$14,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PINE BLUFF - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 19 of Act 103 of 2020, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$144,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 19 of Act 103 of 2020, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed\$700,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 19 of Act 103 of 2020, for costs of campus renovations and repair, in a sum not to exceed\$3,000,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 19 of Act 103 of 2020, for costs of construction of a Nanotechnology/Biotechnology Center, in a sum not to exceed\$2,000,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 19 of Act 103 of 2020, for costs of construction of a

Life Sciences facility, in a sum not to exceed\$1,200,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 19 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$460,000.

(G) Effective July 1, 2021, the balance of the appropriation provided in Item (G) of Section 19 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$1,520,000.

(H) Effective July 1, 2021, the balance of the appropriation provided in Item (H) of Section 19 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed\$396,500.

SECTION 24. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - DEVELOPMENT AND ENHANCEMENT. There is hereby appropriated, to the University of Central Arkansas, to be payable from the Development and Enhancement Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Item (A) of Section 20 of Act 103 of 2020, for costs of construction of a College of Fine Arts and Communication building, in a sum not to exceed\$2,100,000.

(B) Effective July 1, 2021, the balance of the appropriation provided in Item (B) of Section 20 of Act 103 of 2020, for costs of construction of a Health Sciences building, in a sum not to exceed\$2,100,000.

(C) Effective July 1, 2021, the balance of the appropriation provided in Item (C) of Section 20 of Act 103 of 2020, for costs of construction for an addition to, renovation of, and equipment for the Lewis Science Center, in a sum not to exceed\$4,000,000.

(D) Effective July 1, 2021, the balance of the appropriation provided in Item (D) of Section 20 of Act 103 of 2020, for critical maintenance, in a sum not to exceed\$1,000,000.

(E) Effective July 1, 2021, the balance of the appropriation provided in Item (E) of Section 20 of Act 103 of 2020, for deferred maintenance, in a sum not to exceed\$3,620,000.

(F) Effective July 1, 2021, the balance of the appropriation provided in Item (F) of Section 20 of Act 103 of 2020, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed

.....\$2,051,543.

SECTION 25. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - BIGELOW ROSENWALD SCHOOL. There is hereby appropriated, to the University of Central Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2021, the balance of the appropriation provided in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship or preservation of state owned lands, historic sites, buildings, structures or objects, in a sum not to exceed\$634,594.

SECTION 26. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 27. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget

manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 28. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2021 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2021 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2021.
