AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
AND OPERATING EXPENSES AND FOR GRANTS AND AID TO  
LOCAL SCHOOL DISTRICTS AND SPECIAL PROGRAMS FOR THE  
DEPARTMENT OF EDUCATION - DIVISION OF CAREER AND  
TECHNICAL EDUCATION FOR THE FISCAL YEAR ENDING JUNE  
30, 2023; AND FOR OTHER PURPOSES.

**Subtitle**

AN ACT FOR THE DEPARTMENT OF EDUCATION -  
DIVISION OF CAREER AND TECHNICAL  
EDUCATION APPROPRIATION FOR THE 2022-2023  
FISCAL YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES. There is hereby established for the  
Department of Education - Division of Career and Technical Education for the  
2022-2023 fiscal year, the following maximum number of regular employees.

SECTION 4. EXTRA HELP - FEDERAL VOCATIONAL & TECHNICAL EDUCATION.

There is hereby authorized, for the Department of Education - Division of Career and Technical Education - Federal Vocational and Technical Education for the 2022-2023 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: four (4) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 5. APPROPRIATION - FEDERAL VOCATIONAL & TECHNICAL EDUCATION.

There is hereby appropriated, to the Department of Education, to be payable from the federal funds as designated by the Chief Fiscal Officer of the State, for personal services, operating expenses, and grants by the Department of Education - Division of Career and Technical Education - Federal Vocational & Technical Education for the fiscal year ending June 30, 2023, the following:

SECTION 10. APPROPRIATION - ADVANCED CAREERS PROGRAM. There is hereby appropriated, to the Department of Education, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for expenses of the Advanced Careers Program in collaboration with the Southern Regional Education Board of the Department of Education - Division of Career and Technical Education - Advanced Careers Program for the fiscal year ending June 30, 2023, the following:

SECTION 11. APPROPRIATION - CAMP COUCHDALE. There is hereby appropriated, to the Department of Education, to be payable from the cash fund deposited in the State Treasury as determined by the Chief Fiscal

Officer of the State, for expenses for construction, improvement, technology expenses, and the addition of an agriculture mechanics lab at Camp Couchdale of the Department of Education - Division of Career and Technical Education - Camp Couchdale for the fiscal year ending June 30, 2023, the following:

SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FEDERAL MATCHING. The funds appropriated in Sections for Coordinated Career Education Services, Vocational Center Aid and Vocational Start-up Grants and Aid of this Act may also be used to match any available federal funds from any agency in order to provide the maximum amount of money possible for the purposes enumerated in such Section.

The provisions of this section shall be in effect only from July 1, ~~2021~~ 2022 through June 30, ~~2022~~ 2023.

SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. VOCATIONAL START-UP. The funds and appropriations contained herein for Vocational Start-Up shall be allocated in accordance with rules established by the Career Education and Workforce Development Board, after the rules have undergone a review and approval by the Arkansas Legislative Council or Joint Budget Committee under § 10-3-309.

The provisions of this section shall be in effect only from July 1, ~~2021~~ 2022 through June 30, ~~2022~~ 2023.

SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND TRANSFER. Upon approval from the Chief Fiscal Officer of the State, the Division of Career and Technical Education may transfer an amount not to exceed fifty thousand dollars (\$50,000) per fiscal year from the Alternative Retirement Program Cash Fund to the Division of Career and Technical Education Public School Fund Account for Vocational Start-up Grants and Aid.

The provisions of this section shall be in effect only from July 1, ~~2021~~ 2022 through June 30, ~~2022~~ 2023.

SECTION 15. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 16. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 17. EFFECTIVE DATE. This act is effective on and after July 1, 2022.
