AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF  
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER  
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is hereby appropriated, to the Arkansas Northeastern College, to be payable from the Development and Enhancement Fund, for the Arkansas Northeastern College the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 1 of Act 95 of 2022, for costs of construction of a Center for Science and Technology, in a sum not to exceed .....\$3,000,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 1 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$310,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 1 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$410,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 1 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$113,165.



SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There is hereby appropriated, to the Arkansas State University - Beebe, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Beebe the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 2 of Act 95 of 2022, for expansion of information technology infrastructure to support distance education, in a sum not to exceed .....\$520,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 2 of Act 95 of 2022, for renovation of State Hall, in a sum not to exceed .....\$1,500,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 2 of Act 95 of 2022, for renovation of the Owen Center, in a sum not to exceed .....\$1,480,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 2 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$130,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 2 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$1,110,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 2 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$346,925.

SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH. There is hereby appropriated, to the Arkansas State University - Mid-South, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mid-South the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 3 of Act 95 of 2022, for upgrades to classroom technology, in a sum not to exceed .....\$825,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 3 of Act 95 of 2022, for upgrades to student laptops, in a sum not to exceed .....\$250,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 3 of Act 95 of 2022, for upgrades to faculty hardware

technology, in a sum not to exceed .....\$125,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 3 of Act 95 of 2022, for upgrades to campus security system, in a sum not to exceed .....\$150,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 3 of Act 95 of 2022, for upgrades to technology infrastructure, in a sum not to exceed .....\$150,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 3 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$180,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 3 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$500,000.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 3 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$101,530.

SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME. There is hereby appropriated, to the Arkansas State University - Mountain Home, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Mountain Home the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 4 of Act 95 of 2022, for upgrades to ERP software, in a sum not to exceed .....\$800,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 4 of Act 95 of 2022, for upgrades and replacement of IT infrastructure technology, in a sum not to exceed .....\$850,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 4 of Act 95 of 2022, for costs of renovation and purchase of an Occupational Technical Center, in a sum not to exceed .....\$1,350,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 4 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$150,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 4 of Act 95 of 2022, for deferred maintenance, in a

sum not to exceed .....\$270,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 4 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$137,195.

SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.

There is hereby appropriated, to the Arkansas State University - Newport, to be payable from the Development and Enhancement Fund, for the Arkansas State University - Newport the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 5 of Act 95 of 2022, for costs of renovation and construction of Nursing and Allied Health Building - Newport Campus, in a sum not to exceed .....\$1,050,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 5 of Act 95 of 2022, for renovation and remodel of the Main Building on the Jonesboro Campus, in a sum not to exceed ....\$1,950,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 5 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$50,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 5 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$370,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 5 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$264,815.

SECTION 6. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS.

There is hereby appropriated, to the Arkansas State University Three Rivers, to be payable from the Development and Enhancement Fund, for the Arkansas State University Three Rivers the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 6 of Act 95 of 2022, for costs of construction of a Health/Science Technology Building, in a sum not to exceed .....\$2,504,550.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 6 of Act 95 of 2022, for phone system upgrade and replacement, in a sum not to exceed .....\$99,450.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 6 of Act 95 of 2022, for backup generator for Data Center, in a sum not to exceed .....\$45,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 6 of Act 95 of 2022, for replacement of the Walkway Roof, in a sum not to exceed .....\$162,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 6 of Act 95 of 2022, for upgrades to the Data Center hardware, in a sum not to exceed .....\$94,500.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 6 of Act 95 of 2022, for classroom computer replacement, in a sum not to exceed .....\$67,500.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 6 of Act 95 of 2022, for new classroom building doors and windows, in a sum not to exceed .....\$27,000.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 6 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$220,000.

(I) Effective July 1, 2023, the balance of the appropriation provided in Item (I) of Section 6 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$90,540.

SECTION 7. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS - RITZ THEATRE PHASE III. There is hereby appropriated, to the Arkansas State University Three Rivers, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas State University Three Rivers the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$861,277.

SECTION 8. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is hereby appropriated, to the Black River Technical College, to be payable from the Development and Enhancement Fund, for the Black River Technical College the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 8 of Act 95 of 2022, for improvements to the Health Science Complex, in a sum not to exceed .....\$405,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 8 of Act 95 of 2022, for the renovation of the "A" and "B" Buildings, in a sum not to exceed .....\$157,500.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 8 of Act 95 of 2022, for AC/Library equipment replacement, in a sum not to exceed .....\$54,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 8 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$20,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 8 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$420,000.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 8 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$173,470.

SECTION 9. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot Community College of the University of Arkansas, to be payable from the Development and Enhancement Fund, for the Cossatot Community College of the University of Arkansas the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 9 of Act 95 of 2022, for renovation and expansion of the Educational Resource Center/Center for Student Success, in a sum not to exceed .....\$55,000.

(B) Effective July 1, 2023, the balance of the appropriation provided

in Item (B) of Section 9 of Act 95 of 2022, for costs of construction of a Multipurpose/Convocation Center, in a sum not to exceed .....\$2,270,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 9 of Act 95 of 2022, for technology upgrades and improvements of the network infrastructure, in a sum not to exceed .....\$675,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 9 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$50,000.

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$331,800.

SECTION 11. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There is hereby appropriated, to the East Arkansas Community College, to be payable from the Development and Enhancement Fund, for the East Arkansas Community College the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 10 of Act 95 of 2022, for demolition of the Technology Instruction Center, in a sum not to exceed .....\$616,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 10 of Act 95 of 2022, for expansion of the

Transportation Technology Center, in a sum not to exceed .....\$816,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 10 of Act 95 of 2022, for renovation of technology infrastructure and systems, in a sum not to exceed .....\$550,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 12 of Act 95 of 2022, for public address system technology, in a sum not to exceed .....\$60,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 14 of Act 95 of 2022, for deferred maintenance, in a sum not to exceed .....\$260,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 15 of Act 95 of 2022, for renovation and repair of the Pillow-Thompson House, in a sum not to exceed .....\$325,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 16 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$60,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 26 of Act 95 of 2022, for the purchase of Allied Health equipment, in a sum not to exceed .....\$200,500.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 26 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$50,000.

SECTION 28. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - PULASKI TECHNICAL COLLEGE. There is hereby appropriated, to the University of Arkansas - Pulaski Technical College, to be payable from the Development and Enhancement Fund, for the University of Arkansas - Pulaski Technical College the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 28 of Act 95 of 2022, for the sealing of windows and brick for the CCB, IT/BTC and Science Library Buildings, in a sum not to exceed .....\$330,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 28 of Act 95 of 2022, for roof replacement and repair for the Administration Building, in a sum not to exceed .....\$250,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 28 of Act 95 of 2022, for campus boiler replacement, in a sum not to exceed .....\$900,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 28 of Act 95 of 2022, for critical maintenance, in a sum not to exceed .....\$70,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 28 of Act 95 of 2022, for deferred maintenance, in a

sum not to exceed .....\$580,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 28 of Act 95 of 2022, for repair or replacement of equipment and library holdings, in a sum not to exceed .....\$534,905.

SECTION 29. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 30. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 31. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits

the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2023 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2023 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2023.
