AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS OF  
HIGHER EDUCATION; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE INSTITUTIONS OF HIGHER  
EDUCATION REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY. There is hereby appropriated, to the Arkansas State University, to be payable from the Development and Enhancement Fund, for the Arkansas State University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 1 of Act 73 of 2022, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the Arkansas State University System, in a sum not to exceed .....\$10,779,755.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 1 of Act 73 of 2022, for costs of construction of a College of Engineering building, in a sum not to exceed .....\$4,364,480.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 1 of Act 73 of 2022, for College of Education and Communications restrooms renovation, in a sum not to exceed .....\$908,500.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 1 of Act 73 of 2022, for Library HVAC system



renovation and modernization, in a sum not to exceed .....\$3,227,020.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 1 of Act 73 of 2022, for critical maintenance, in a sum not to exceed .....\$710,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 1 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$2,870,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 1 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$2,989,855.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 1 of Act 73 of 2022, for costs of implementing the ASU System Enterprise Resource Program, in a sum not to exceed .....\$1,250,000.

SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the Arkansas State University, to be payable from the Sustainable Building Design Revolving Loan Fund, for the Arkansas State University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 5 of Act 73 of 2022, for construction, renovation, maintenance and operating expenses, in a sum not to exceed .....\$226.

SECTION 3. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Development and Enhancement Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 6 of Act 73 of 2022, for McEver Science Building, Dean Hall, & Tucker Coliseum renovation, in a sum not to exceed .....\$4,765,200.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 6 of Act 73 of 2022, for costs of construction of 0 Street closure and Campus Entrance, in a sum not to exceed .....\$2,330,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 6 of Act 73 of 2022, for renovation for Brown building academic utilization, in a sum not to exceed .....\$1,180,438.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 6 of Act 73 of 2022, for technology infrastructure upgrades and improvements, in a sum not to exceed .....\$224,362.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 6 of Act 73 of 2022, for critical maintenance, in a sum not to exceed .....\$1,210,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 6 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$3,780,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 6 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$1,314,122.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 6 of Act 73 of 2022, for reroofing the Allied Health Building on the Ozark Campus, in a sum not to exceed .....\$142,212.

(I) Effective July 1, 2023, the balance of the appropriation provided in Item (I) of Section 6 of Act 73 of 2022, for costs of construction of a Technology Trade Center on the Ozark Campus, in a sum not to exceed .....\$1,357,788.

(J) Effective July 1, 2023, the balance of the appropriation provided in Item (J) of Section 6 of Act 73 of 2022, for critical maintenance for the Ozark Campus, in a sum not to exceed .....\$20,000.

(K) Effective July 1, 2023, the balance of the appropriation provided in Item (K) of Section 6 of Act 73 of 2022, for deferred maintenance for the Ozark Campus, in a sum not to exceed .....\$210,000.

SECTION 4. REAPPROPRIATION - ARKANSAS TECH UNIVERSITY - CARAWAY HALL RENOVATION. There is hereby appropriated, to the Arkansas Tech University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Arkansas Tech University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$857,492.

SECTION 5. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is hereby appropriated, to the Henderson State University, to be payable from the Development and Enhancement Fund, for the Henderson State University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 7 of Act 73 of 2022, for technology infrastructure upgrades, in a sum not to exceed .....\$1,500,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 7 of Act 73 of 2022, for Reynolds Labs renovation, in a sum not to exceed .....\$850,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 7 of Act 73 of 2022, for roof replacement for the Library and Womack building, in a sum not to exceed .....\$795,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 7 of Act 73 of 2022, for renovation of the Russell Fine Arts Building, in a sum not to exceed .....\$4,355,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 7 of Act 73 of 2022, for critical maintenance, in a sum not to exceed .....\$280,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 7 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$1,900,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 7 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$597,420.

SECTION 6. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - CADDO CENTER PHASE VI. There is hereby appropriated, to the Henderson State University, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the Henderson State University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$1,400,000.

SECTION 7. REAPPROPRIATION - HENDERSON STATE UNIVERSITY - SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the Henderson State University, to be payable from the Sustainable Building Design Revolving Loan Fund, for the Henderson State University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 12 of Act 25 of 2022, for construction, renovation, maintenance and operating expenses, in a sum not to exceed .....\$996,450.

SECTION 8. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is hereby appropriated, to the Southern Arkansas University, to be payable from the Development and Enhancement Fund, for the Southern Arkansas University the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 9 of Act 73 of 2022, for costs of HVAC replacement and upgrades, in a sum not to exceed .....\$3,783,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 9 of Act 73 of 2022, for technology infrastructure improvements and upgrades, in a sum not to exceed .....\$2,500,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 9 of Act 73 of 2022, for renovation of Childs Hall and ADA upgrades to create the Science, Technology, Engineering and Mathematics Training Center, in a sum not to exceed .....\$1,217,000.

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 10 of Act 73 of 2022, for renovation of the Barton Building, in a sum not to exceed .....\$2,500,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 10 of Act 73 of 2022, for renovation of the EDII 6th Floor for the College of Pharmacy, in a sum not to exceed .....\$2,000,000.

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 11 of Act 73 of 2022, for construction, renovation, maintenance, equipment, personal services and operating expenses of the various institutions and entities of the University of Arkansas System, in a sum not to exceed .....\$4,418,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 11 of Act 73 of 2022, for costs of construction of the Institute for Integrative and Innovative Research, in a sum not to exceed

.....\$3,500,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 11 of Act 73 of 2022, for renovation and restoration of the Agriculture Building, in a sum not to exceed .....\$2,000,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 11 of Act 73 of 2022, for renovation and restoration of the John A. White, Jr. Engineering Hall, in a sum not to exceed .....\$2,000,000.

There is hereby appropriated, to the University of Arkansas at Little Rock, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Little Rock the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$18,178.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 18 of Act 73 of 2022, for costs of construction of the Workforce/Collegiate Center on the Crossett campus, in a sum not to exceed .....\$1,500,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 18 of Act 73 of 2022, for costs of construction of a General Education Building on the McGehee campus, in a sum not to exceed .....\$1,500,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 18 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$2,390,000.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 18 of Act 73 of 2022, for deferred maintenance at the Crossett campus, in a sum not to exceed .....\$120,000.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 18 of Act 73 of 2022, for deferred maintenance at the McGehee campus, in a sum not to exceed .....\$150,000.

(I) Effective July 1, 2023, the balance of the appropriation provided in Item (I) of Section 18 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed

.....\$445,592.

SECTION 20. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT MONTICELLO - TROTTER HOUSE. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$468,249.

SECTION 21. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT MONTICELLO - 1937 FACULTY HOUSE. There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed .....\$211,077.

SECTION 22. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT PINE BLUFF. There is hereby appropriated, to the University of Arkansas at Pine Bluff, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Pine Bluff the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 19 of Act 73 of 2022, for costs of construction of a Student Center, in a sum not to exceed .....\$3,000,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 19 of Act 73 of 2022, for costs of campus renovations and repair, in a sum not to exceed .....\$2,895,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 19 of Act 73 of 2022, for technology infrastructure upgrades, in a sum not to exceed .....\$605,000.

(D) Effective July 1, 2023, the balance of the appropriation provided

in Item (D) of Section 19 of Act 73 of 2022, for critical maintenance, in a sum not to exceed .....\$490,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 19 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$1,600,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 19 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$383,776.

(G) Effective July 1, 2023, the balance of the appropriation provided in Item (G) of Section 19 of Act 73 of 2022, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed .....\$144,000.

(H) Effective July 1, 2023, the balance of the appropriation provided in Item (H) of Section 19 of Act 73 of 2022, for matching funds for the 1890 Research and Extension Programs, in a sum not to exceed .....\$700,000.

SECTION 23. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS. There is hereby appropriated, to the University of Central Arkansas, to be payable from the Development and Enhancement Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Item (A) of Section 21 of Act 73 of 2022, for costs of construction for an addition to, renovation of, and equipment for the Lewis Science Center, in a sum not to exceed .....\$3,000,000.

(B) Effective July 1, 2023, the balance of the appropriation provided in Item (B) of Section 21 of Act 73 of 2022, for renovation of Mashburn Hall, in a sum not to exceed .....\$3,000,000.

(C) Effective July 1, 2023, the balance of the appropriation provided in Item (C) of Section 21 of Act 73 of 2022, for renovation of Old Main, in a sum not to exceed .....\$2,500,000.

(D) Effective July 1, 2023, the balance of the appropriation provided in Item (D) of Section 21 of Act 73 of 2022, for critical maintenance, in a sum not to exceed .....\$1,060,000.

(E) Effective July 1, 2023, the balance of the appropriation provided in Item (E) of Section 21 of Act 73 of 2022, for deferred maintenance, in a sum not to exceed .....\$3,820,000.

(F) Effective July 1, 2023, the balance of the appropriation provided in Item (F) of Section 21 of Act 73 of 2022, for the purchase, replacement, and renewal of equipment and library holdings, in a sum not to exceed .....\$1,948,849.

SECTION 24. REAPPROPRIATION - UNIVERSITY OF CENTRAL ARKANSAS - MCALISTER HALL RESTORATION PHASE II. There is hereby appropriated, to the University of Central Arkansas, to be payable from the Arkansas Natural and Cultural Resources Grant and Trust Fund, for the University of Central Arkansas the following:

(A) Effective July 1, 2023, the balance of the appropriation provided in Section 24 of Act 196 of 2022, for the acquisition, management, stewardship, or preservation of state owned lands, historic sites, buildings, structures, or objects, in a sum not to exceed.....\$549,537.

SECTION 25. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.

(B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

SECTION 26. LEGISLATIVE INTENT. It is the intent of the General

Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 27. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2023 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2023 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2023.
