AN ACT TO AMEND THE LAW CONCERNING PAYMENTS TO
LOCALITIES; AND FOR OTHER PURPOSES.

Subtitle

TO AMEND THE LAW CONCERNING PAYMENTS TO
LOCALITIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code § 14-171-215(a)(5), concerning payments to the Arkansas State Fair and Livestock Show Association for state assistance to cities and counties, is amended to read as follows:

(5) The Arkansas State Fair and Livestock Show Association or its bond trustee shall receive the moneys listed in this subdivision (a)(5), less any general revenues appropriated to the Arkansas State Fair and Livestock Show:
