(b) All duties and powers of the Bureau of Legislative Research shall hereafter be exercised by the Bureau for the Senate and the House Council and Budget Office for the House of Representatives.

(c) There is hereby created the House Rules Committee and the House Management Committee to be composed of such members and perform such duties as prescribed by House Rules and may meet both during the sessions of the General Assembly and between sessions of the General Assembly."
