

SENATE AMENDMENT 2 TO SB273.

deleting all of lines 24 and 25 on page 2 and substituting therefor the following:

"registered limited liability partnership."

AND

by deleting all of line 36 on page 2 and all of lines 1 and 2 on page 3 and substituting therefor the following:

"(2) Subject to subsection (3) of this section a partner in a registered limited liability"

AND

by deleting all of line 7 on page 3 and substituting therefor the following:

"incompetence, or misconduct committed in the course of the"

AND

by deleting all of lines 12 through 17 on page 3 and substituting therefor the following:

"omissions, negligence, incompetence, or misconduct or that of any other person if the partner personally, directly and negligently participated in the specific activity in which the errors, omissions, negligence, incompetence, or misconduct were committed."

AND

by deleting all of lines 30 through 36 on page 3 lines 1 and 2 on page 4

AND

by deleting "SECTION 6" from line 4 on page 4 and substituting therefor "SECTION 5"

AND

by deleting "SECTION 7" from line 36 on page 4 and substituting therefor "SECTION 6"

AND

by deleting "SECTION 8" from line 15 on page 5 and substituting therefor "SECTION 7"

by deleting "SECTION 9" from line 22 on page 5 and substituting therefor "SECTION 8"

by deleting "SECTION 10" from line 30 on page 6 and substituting therefor "SECTION 9"

AND

by deleting line 17 from page 7 and substituting therefor the following:

"(6) An amended filing with the Secretary of State shall be required in the event a registered limited liability partnership changes its name, the address of its principal office, or the name and address of the registered agent for service of process in this state. In the event the aforementioned requirements are not complied with, service of process may be made by serving the Secretary of State in the name of the partnership in its most recent filing or in the name under which it is currently transacting business if there is no filing with that name.

AND

by deleting all of line 26 from page 7 and substituting therefor the following:

"the information stated in the application or notice, or"

by deleting all of line 27 on page 7 and substituting therefor the following:

"(c) Failure to file with the Secretary of State the information required under subsection (6) of this section.

AND

by striking all of lines 29 and 30 from page 9 and substituting therefor the following:

"for debts, obligations, and liabilities of or chargeable to a foreign registered limited liability partnership or another partner or partners, shall be subject to and governed by the laws of the jurisdiction pursuant to the laws of which the foreign registered limited liability partnership is governed."

by deleting "SECTION 11" from line 7 on page 10 and substituting therefor "SECTION 10"

AND

by deleting "SECTION 12" from line 8 on page 11 and substituting therefor "SECTION 11"

by deleting "SECTION 13" from line 11 on page 12 and substituting therefor "SECTION 12"
