

SENATE AMENDMENT 1 TO sb659.

striking Section 1 in its entirety and substituting therefor the following new sections:

"SECTION 1. REGULAR SALARIES. There is hereby established for the Arkansas Employment Security Department - New Hire Registry Division for the 1997-99 biennium, the following maximum number of regular employees whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its successor.
