by deleting lines 1 through 4 on page 6 and substituting therefor the following:

"(c) There is hereby levied a new fee of two dollars and fifty cents (\$2.50) for the sale of each annual license plate validation decal for a motor vehicle. This new fee shall be collected by the Director at the same time the vehicle registration fees imposed by Ark. Code Ann. § 27-14-601 are collected; however, this new decal fee shall be accounted for separately from the registration fee. Such amount shall be"

by deleting line 24 on page 6 and substituting therefor the following:

"(3) All amounts derived from the new fee imposed by subsection (c) of this section for the sale of annual license plate validation"

AND

by deleting line 22 on page 7 and substituting therefor the following:

"no delinquent personal property taxes. Prior to instituting such system the Director shall continue to require vehicle owners to present proof that each vehicle has been assessed and that all personal property taxes due from the owner by the preceding October 10 have been paid before issuing or renewing any vehicle registration. "
