SB26	Madison	AN ACT TO REGULATE THE ADMINISTRATION AND USE OF STATE INSTITUTION OF HIGHER EDUCATION FINANCIAL ASSISTANCE TO STUDENTS. SALES.
SB28	Madison	AN ACT TO REGULATE STATE-SUPPORTED COLLEGE AND UNIVERSITY TEXTBOOK SALES AND TO REQUIRE COURSE SUPPLEMENTS BE SOLD TO COMPETING BOOKSTORES AT COST.
SB29	Madison	TO REQUIRE STATE-SUPPORTED INSTITUTIONS OF HIGHER EDUCATION TO PERMIT LOCAL PRIVATE RETAILERS ACCESS TO STUDENT SALES.

SB31	Madison	TO PROHIBIT REFERRALS TO WEBSITES OF TEXTBOOK RETAILERS THAT ARE NOT REQUIRED AND DO NOT AGREE TO COLLECT ARKANSAS SALES AND USE TAXES.
SB88	J. Jeffress	TO REQUIRE ALL MOTORISTS TO CARRY MINIMUM MOTOR VEHICLE LIABILITY INSURANCE COVERAGE; NAMED DRIVER EXCLUSIONS TO BE LISTED ON PROOF OF INSURANCE CARDS; AND A NOTICE CONCERNING A NAMED DRIVER EXCLUSION TO THE INSURED.
SB93	G. Jeffress	TO MANDATE HEALTH INSURANCE COVERAGE FOR AUTISM AND RELATED DISORDERS.
