SB6	Hendren	TO REQUIRE A DRIVER OF A MOTOR VEHICLE TO POSSESS A HANDS-FREE CELLULAR TELEPHONE DEVICE WHILE DRIVING.
SB7	Hendren	TO REQUIRE A DRIVER OF A MOTOR VEHICLE TO USE A HANDS-FREE CELLULAR TELEPHONE DEVICE WHILE DRIVING ON A PUBLIC HIGHWAY.
SB8	Hendren	TO REQUIRE LOADS CARRYING GRAVEL OR ROCKS TO BE COVERED.
SB19	Hendren	TO PROHIBIT A DRIVER UNDER EIGHTEEN (18)YEARS OF AGE FROM OPERATING A MOTOR VEHICLE WHILE USING A CELLULAR TELEPHONE DEVICE.
SB154	G. Jeffress	TO CREATE A STATE POLICE OFFICER HIGHWAY DEDICATION PROGRAM.
SB195	J. Jeffress	TO PROTECT THE CONSUMERS IN THE STATE BY CREATING THE "LIMITATION ON USE OF RADIO FREQUENCY IDENTIFICATION TAGS ACT" THAT PROHIBITS RFID TAGS FROM BEING USED AFTER SALE.
SB196	J. Jeffress	TO IMPROVE THE SAFETY OF ROADS AND HIGHWAYS IN THE STATE BY ADDRESSING ISSUES RELATED TO THE LICENSING OF BEGINNING OR YOUTHFUL DRIVERS.
HB1206	Dunn	TO ALLOW A PERMIT FOR THE MOVEMENT OF EARTHMOVING EQUIPMENT THAT IS A TRACTOR WITH A DIRT PAN IN TOW UPON THE STATE HIGHWAYS IF THE OWNER IS PRIMARILY ENGAGED IN FARMING OR EARTHMOVING OPERATIONS.
SB227	Wilkins	TO IMPROVE THE SAFETY OF MOTORISTS ON HIGHWAYS AND ROADS IN THE STATE OF ARKANSAS BY MAKING THE MANDATORY SEAT BELT LAW A PRIMARY LAW FOR ENFORCEMENT PURPOSES.
SB247	Madison	TO ALLOW THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO APPOINT A SIGNEE SO THAT A CHILD IN STATE CUSTODY MAY OBTAIN AN INSTRUCTION PERMIT, A LEARNER'S LICENSE, OR AN INTERMEDIATE DRIVER S LICENSE.
HB1128	Rosenbaum	TO PROVIDE THAT A PURPLE HEART RECIPIENT MAY RECEIVE AN ADDITIONAL SPECIAL LICENSE PLATE FOR A NOMINAL FEE.
SB278	Glover	TO IMPLEMENT THE FEDERAL UNIFIED CARRIER REGISTRATION ACT OF 2005 PERTAINING TO THE REGISTRATION OF MOTOR CARRIERS ENGAGED IN INTERSTATE COMMERCE.
HB1377	D. Hutchinson	TO PROVIDE THAT ALL REAL PROPERTY ACQUIRED BY A REGIONAL AIRPORT AUTHORITY IN FEE SIMPLE TITLE FOR AVIATION PURPOSES IS EXEMPT FROM ANNEXATION AND MUNICIPAL REGULATION.
HB1405	Burris	TO PROVIDE THAT A DISABLED VETERAN MAY RECEIVE AN ADDITIONAL SPECIAL LICENSE PLATE FOR A NOMINAL FEE.

HCR1009	Wills	RECOMMENDING THAT FEDERAL FISCAL YEAR 2007 FEDERAL HIGHWAY AND TRANSIT FUNDING LEVELS BE MAINTAINED AS PROVIDED IN SAFETEA-LU.
SB290	Glover	TO INCREASE TITLE FEES TO FUND FLEET OPERATIONS OF THE DEPARTMENT OF ARKANSAS STATE POLICE.
SB291	Glover	TO CLARIFY THE RESTRICTIONS ON DEFERRING THE SENTENCE FOR PERSONS HOLDING A COMMERCIAL DRIVER LICENSE.
SB295	Miller	AN ACT TO AMEND PORTIONS OF ARKANSAS LAW RELATED TO DAMAGED MOTOR VEHICLES.
HB1408	Reep	TO INCREASE THE FINE FOR FAILURE TO YIELD TO AN EMERGENCY VEHICLE.
