SPECIAL AGENT NOTES

During the course of this investigation, it was determined that the North Central Unit (NCU) utilizes kitchen post orders that are unique to its facility. Unlike a universal policy applied across all Arkansas Department of Corrections (ADC) institutions, each facility maintains kitchen post orders tailored to meet its specific operational needs and logistical challenges. While this localized approach is recognized as necessary in some areas, there are core standards—particularly those impacting security and inmate supervision—that should remain consistent across all ADC facilities.

Notably, the NCU kitchen post orders, with an effective date of March 12, 2025, contain a provision which states, in part:

“The only inmate allowed to [be] outside unsupervised is the one assigned to clean the dock, and then he will be pat searched when he enters the building to control contraband.”

This clause permitting an inmate to be outside without direct supervision prompted concern and warranted further examination. To determine whether similar provisions existed elsewhere, I requested kitchen post orders from three additional ADC facilities selected at random: the Grimes Unit, Delta Regional Unit, and East Arkansas Regional Unit.

Upon review, none of the three facilities’ kitchen post orders included language permitting inmates to be outside without staff supervision, even when assigned cleaning duties. In fact, only the North Central Unit’s post orders contained any language explicitly authorizing an inmate to be unsupervised outdoors.

It is important to note that all four facilities—NCU, Grimes, Delta, and East Arkansas—house inmates across minimum, medium, and maximum-security classifications. Therefore, the comparison between them is reasonable and relevant when evaluating security practices and supervisory requirements.

Copies of the kitchen post orders from all four facilities will be included as part of the investigative file for reference and documentation.

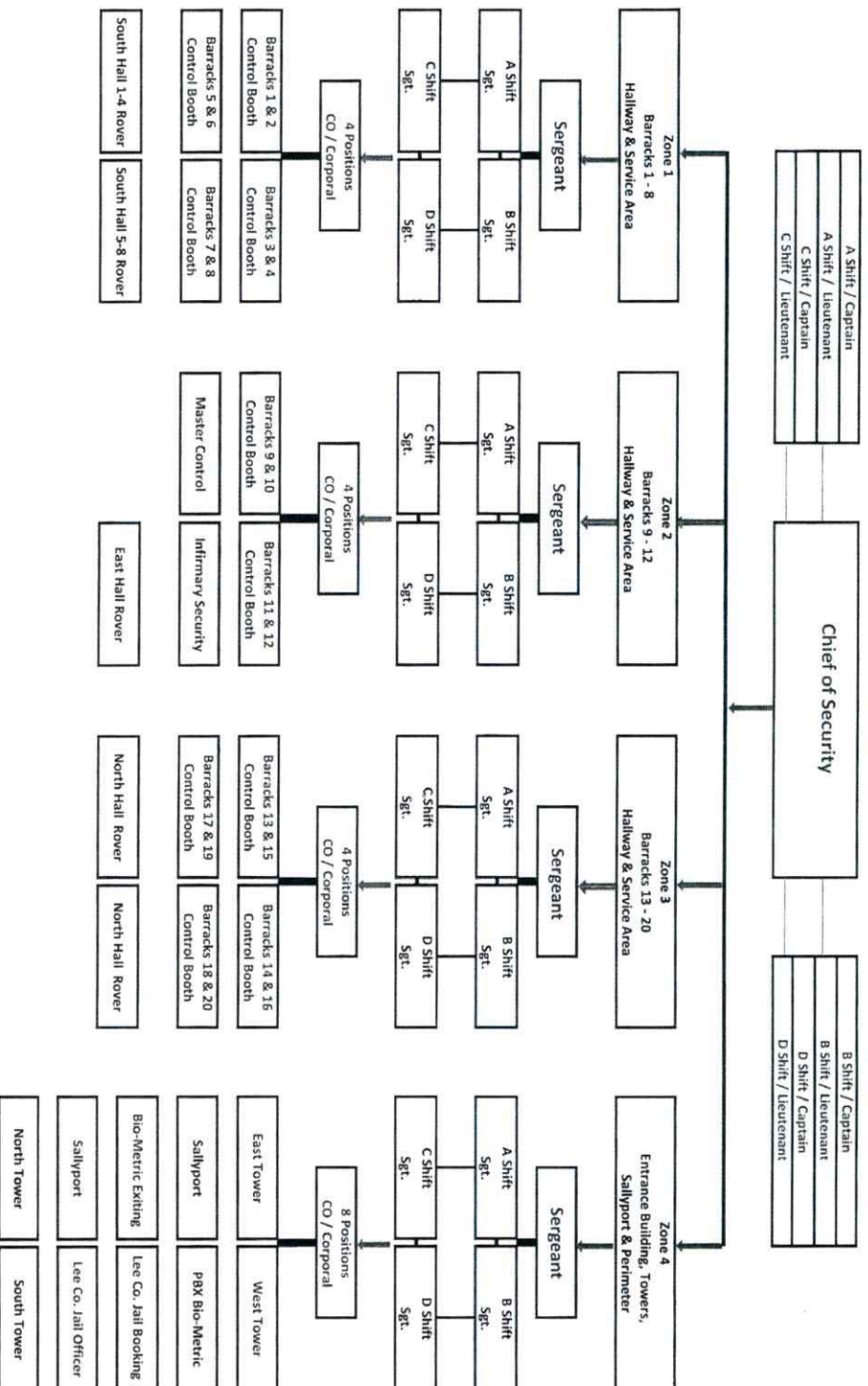

INTERVIEW OF SUBJECT

On Wednesday June 18, 2025, I interviewed Steven Lively via telephone. Lively is identified as the Dog Kennel Supervisor for the North Central Unit of the Arkansas Department of Corrections. The below is an interview summary, it is not intended to be a verbatim account and does not memorialize all statements made during the interview.

Lively advised that he was notified of Hardin's escape at 3:30 PM on May 25, 2025 by Warden Thomas Hurst. Lively said that the dog team was on scene and ready to track at 4:09 PM. Lively explained that he contacted Arkansas State Police Sergeant Chad Staley to request that [REDACTED] Remington Lively, be allowed to assist him with the track due to being short handed. Lively said that he also notified Sergeant Corey Ray of the Arkansas State Police Aircraft Unit of the escape. Lively said that external notifications are not his responsibility but believes that "two notifications are better than none." Lively said that he would have preferred to have been notified of the escape earlier as is usually the practice. Lively said that prior to beginning to track, the area had been contaminated by corrections officers attempting to search for Hardin, which is also contrary to the usual practice.

INTERVIEW OF SUBJECT

On Wednesday June 18, 2025, I interviewed Patricia Harper. Harper is identified as a dispatcher for the Arkansas State Police, Troop I. The below is an interview summary, it is not intended to be a verbatim account and does not memorialize all statements made during the interview.

Harper advised that she and dispatcher Tyler Borland worked in Troop I Dispatch on May 25, 2025. Harper said that Troop I Captain Wesley Smithee contacted Troop I Dispatch to inquire about a possible escaped inmate at the ADC NCU. Harper said that Borland called the NCU and it was confirmed that Grant Hardin had escaped approximately 30 minutes prior. Harper advised that Troop I Dispatch never received a call or terminal message from ADC in reference to the escape, which forced Harper and Borland to create their own BOLO by using information they found from the ADC website about Hardin in order for the responding Troopers to know who they were searching for. A copy of the BOLO created by Harper and Borland is attached to this report. Also attached to the report is a copy of the dispatch log involving the ASP response and radio traffic related to the escape. The log shows Captain Wesley Smithee (I1) called Troop I dispatch at 4:06 PM to inquire with dispatch if there had been an escape from the prison. The log also shows at 4:13 PM, Smithee called dispatch to confirm that a prisoner had escaped.
