This is the first request by the Department of Human Services for Reallocation of Resources, from a limit of four annually. Section 11(c) of Act 1004 of 2025 allows transfer authority to DHS and sets limits for the number of requests, dollar amounts of the total requests, and the purpose for which requests can be submitted.

The following paragraphs outline the need for the transfers as requested by each Division.

**SECRETARY’S OFFICE**

The Secretary’s Office (SO) is requesting to transfer 1 position from the Division of County Operations to provide essential support for the Office of Procurement by managing business functions, including implementation of the Contract Administration system, and coordination and oversight of contracts across the agency.

The Secretary’s Office is also requesting to transfer \$1,904,455.12 in general revenue funding for cost allocation to support client needs and services from the following divisions:

- \$6,439.32 from the Division of Aging, Adult, and Behavioral Health Services;
- \$1,762,745.29 from the Division of Children and Family Services;
- \$99,284.01 from the Division of Developmental Disabilities Services; and
- \$35,986.50 from the Division of Youth Services.

**DIVISION OF AGING, ADULT, AND BEHAVIORAL HEALTH SERVICES**

The Division of Aging, Adult, and Behavioral Health Services (DAABH) is requesting to transfer 2 positions to provide support for the Adult Protective Services call center and support for the Office of Substance Abuse and Mental Health (OSAMH) from the following divisions:

- 1 position from the Division of County Operations; and
- 1 position from the Division of Development Disabilities Services.

The Division of Aging, Adult, and Behavioral Health Services is also requesting to transfer \$67,738.10 in general revenue funding from the Division of Children and Family Services for cost allocation to support client needs and services.

### **DIVISION OF COUNTY OPERATIONS**

The Division of County Operations (DCO) is requesting a transfer of \$180,808.49 in appropriation to redirect internal resources from the following divisions:

- \$73,944 in Regular Salaries and \$26,250.12 in Personal Services Matching from the Secretary's Office; and
- \$59,494 in Regular Salaries and \$21,120.37 in Personal Services Matching from the Division of Youth Services.

The Division of County Operations is also requesting to transfer \$2,062,324.53 in general revenue funding for cost allocation and administrative support:

- \$1,878,694.20 from the Division of Children and Family Services;
- \$144,272.13 from the Division of Developmental Disabilities Services; and
- \$39,358.20 from the Secretary's Office.

### **DIVISION OF DEVELOPMENTAL DISABILITIES SERVICES**

The Division of Developmental Disabilities Services (DDS) is requesting to transfer \$129,657.39 in general revenue funding from the Division of Children and Family Services for cost allocation to support client needs and services.

### **DIVISION OF MEDICAL SERVICES**

The Division of Medical Services (DMS) is requesting to transfer \$51,938.36 in general revenue funding from the Division of Children and Family Services for cost allocation to support client needs and services.

### **DIVISION OF PROVIDER SERVICES AND QUALITY ASSURANCE**

The Division of Provider Services and Quality Assurance (DPSQA) is requesting to transfer \$45,451.53 in general revenue funding from the Division of Children and Family Services for cost allocation to support client needs and services.

### **DIVISION OF YOUTH SERVICES**

The Division of Youth Services (DYS) is requesting to transfer 1 position from the Division of County Operations to support prevention efforts aimed at reducing the number of adjudicated juveniles, aiding with youth currently involved in the system, and strengthening reintegration services as they return to their communities.






