AMENDMENT NO. 1 TO HOUSE BILL NO. 1114

Amend HOUSE BILL NO. 1114 as originally introduced:

Insert additional sections immediately following SECTION 77 to read as follows:

" SECTION 78. Section 83 of uncodified Act 1103 of 2011 is repealed in its entirety.

~~SECTION 83. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING - GRANTS TO FIRE DEPARTMENTS. After funds collected pursuant to §26-57-614 are distributed in accordance with §14-284-403, any remaining balance of authorized funding for grants to fire departments for Crittenden County during the 2010-2011 fiscal year in the amount of one hundred fifty-three thousand eight hundred and ninety-four dollars (\$153,894) or above, shall be distributed as follows:~~

- ~~(a) sixteen percent (16%) shall be distributed to the Edmonson Fire Department up to a maximum of twenty-four thousand five hundred thirty two dollars (\$24,532), and~~
- ~~(b) thirty-two percent (32%) shall be distributed to the Earle Fire Department up to a maximum of forty-nine thousand seventy dollars (\$49,070), and~~
- ~~(c) fifty-two percent (52%) shall be distributed to the Marion Fire Department up to a maximum of eighty thousand two hundred ninety two dollars (\$80,292).~~

~~Any balances remaining for Crittenden County following the distribution in subsections (a) through (c) of this Section, shall be distributed to active fire departments based on population.~~

SECTION 79. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING - GRANTS TO FIRE DEPARTMENTS. After funds collected pursuant to §26-57-614 are distributed in accordance with §14-284-403, any remaining balance of authorized funding for grants to fire departments for Crittenden County during the 2010-2011 fiscal year in the amount of one hundred fifty-three thousand nine hundred and forty-eight dollars (\$153,948) or above, shall be distributed as follows:

- (a) ten percent (10%) shall be distributed to the Anthonyville Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and

(b) ten percent (10%) shall be distributed to the Crawfordsville Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(c) ten percent (10%) shall be distributed to the Earle Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(d) ten percent (10%) shall be distributed to the Edmondson Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(e) ten percent (10%) shall be distributed to the Heifer Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(f) ten percent (10%) shall be distributed to the Horseshoe Lake Fire Department, up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394),
and
(g) ten percent (10%) shall be distributed to the Jericho Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(h) ten percent (10%) shall be distributed to the Marion Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(i) ten percent (10%) shall be distributed to the Proctor Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394), and
(j) ten percent (10%) shall be distributed to the West Memphis Fire Department up to a maximum of fifteen thousand three hundred and ninety-four dollars (\$15,394).
Any balances remaining for Crittenden County following the distribution in subsections (a) through (j) of this Section, shall be distributed to active fire departments based on population."

AND

Delete SECTION 80 in its entirety and substitute the following:

" SECTION 80. EMERGENCY CLAUSE. It is found an determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2012, with the exception that Section 78 and 79 in this Act shall be in full force and effect from and after the date of its passage and approval, is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2012, with the exception that Section 78 and 79 in this Act shall be in full force and effect from and after the date of its passage and approval, could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation

of the public peace, health and safety shall be in full force an effect from and after July 1, 2012, with the exception that Section 78 and 79 in this Act shall be in full force and effect from and after the date of its passage and approval."

AMENDMENT NO. 1 TO HOUSE BILL NO. 1128

Amend **HOUSE BILL NO. 1128** as originally introduced:

Immediately following SECTION 9, add two new sections to read as follows:

" SECTION 10. SPECIAL LANGUAGE — CODE AMENDMENT. Arkansas Code § 8-6-607 is amended to read as follows:

8-6-607. Collection of fees.

Fees imposed pursuant to under the separate provisions of this subchapter shall be collected as follows:

(1) Each landfill permittee and each transporter shall submit to the department on or before January 15, April 15, July 15, and October 15 of each year a quarterly report ~~which~~ that accurately states the total weight or volume of solid waste received at the landfill or transported out of state during the quarter just completed;

(2) On or before January 15, April 15, July 15, and October 15 of each year, each landfill permittee and solid waste transporter shall pay to the Arkansas Department of Environmental Quality the full amount of ~~such~~ disposal fees due for the quarter just completed;

(3) Except as provided in ~~subdivision (4)~~ subdivisions (4) and (5) of this section, the disposal and transportation fees collected ~~pursuant to~~ under this section shall be special revenues and shall be deposited in the State Treasury to the credit of the Solid Waste Management and Recycling Fund for administrative support of the State Marketing Board for Recyclables; ~~and~~

(4)(A) Twenty-five percent (25%) of the disposal fees collected from landfills where a private industry bears the expense of operating and maintaining the landfill solely for the disposal of wastes generated by the industry shall be deposited into a special fund to be created on the books of the Treasurer of State, the Auditor of State, and the Chief Fiscal Officer of the State and to be known as the "Marketing Board Fund".

(B) The fund shall be administered by the department and used by the State Marketing Board for Recyclables for the administration and performance of its duties; ~~and~~

(5) Beginning July 1, 2012, excluding the disposal fees that are to be deposited into the Marketing Board Fund under § 8-6-607(4), the first one hundred

twenty-five thousand dollars (\$125,000) of the fees collected each fiscal year under this section shall be deposited into the State Treasury and credited to the Crime Information System Fund to be used exclusively for the scrap metal log book program.

SECTION 11. SPECIAL LANGUAGE — CODE AMENDMENT. Arkansas Code § 19-5-1011, concerning the Crime Information System Fund, is amended to add an additional subsection to read as follows:

(c) Beginning July 1, 2012, excluding the disposal fees that are to be deposited into the Marketing Board Fund under § 8-6-607(4), the first one hundred twenty-five thousand dollars (\$125,000) of fees collected each fiscal year under § 8-6-607 shall be deposited into the State Treasury and credited to the Crime Information System Fund to be used exclusively for the scrap metal log book program.”

(3) Except as provided in ~~subdivision (4)~~ subdivisions (4) and (5) of this section, the disposal and transportation fees collected pursuant to under this section shall be special revenues and shall be deposited in the State Treasury to the credit of the Solid Waste Management and Recycling Fund for administrative support of the State Marketing Board for Recyclables; ~~and~~

(4)(A) Twenty-five percent (25%) of the disposal fees collected from landfills where a private industry bears the expense of operating and maintaining the landfill solely for the disposal of wastes generated by the industry shall be deposited into a special fund to be created on the books of the Treasurer of State, the Auditor of State, and the Chief Fiscal Officer of the State and to be known as the "Marketing Board Fund".

(B) The fund shall be administered by the department and used by the State Marketing Board for Recyclables for the administration and performance of its duties; and

(5) Beginning July 1, 2012, excluding the disposal fees that are to be deposited into the Marketing Board Fund under § 8-6-607(4), the first one hundred twenty-five thousand dollars (\$125,000) of the fees collected each fiscal year under this section shall be deposited into the State Treasury and credited to the Crime

Information System Fund to be used exclusively for the scrap metal log book program.

It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2012, is essential to the operation of the agency for which the appropriations in this Act are provided; with the exception that Sections 14 and 15 in this Act shall be in full force and effect from and after the date of its passage and approval, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2012 could work irreparable harm upon the proper administration and provision of essential governmental programs; with the exception that Sections 14 and 15 in this Act shall be in full force and effect from and after the date of its passage and approval. That with respect to sections 14 and 15 of this Act, to implement the decisions embodied by the cases of In re Johnson, Peeks, and Estes, 460 B.R. 234 (Bkcty E. D. Ark. 2011), would result in an exponential increase in registrations and require a considerable amount of additional money and staff and a much larger appropriation to the Secretary of State; that additional moneys are not available for this purpose; that the General Assembly is against

growing state government under current financial conditions and budgetary constraints; that the failure to enact sections 14 and 15 of this Act will place an immediate undue financial burden and hardship on the state's budget and the Secretary of State. Therefore, an emergency is hereby declared to exist and, being necessary for the immediate preservation of the public peace, health, and safety, all sections other than sections 14 and 15 of this Act shall be in full force and effect from on and after July 1, 2012, and that sections 14 and 15 of this Act shall become effective on:
