**AMENDMENT NO. 1 TO HOUSE BILL NO. 1086**

Amend **HOUSE BILL NO. 1086** as originally introduced:

Page 2, line 21, delete "8,000" and substitute "18,000"

AND

Page 2, line 24, delete "\$151,602" and substitute "\$161,602"

AND

Insert an additional SECTION immediately following SECTION 3 to read as follows:

" SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. INVESTIGATIVE SERVICES FOR CONSUMER COMPLAINTS. Ten thousand dollars (\$10,000) of the available appropriation in the Professional Fees Line item of this act shall be made available to the board for the purpose of contracting an independent or private investigator for investigative services regarding complaints submitted by consumers.

The provisions of this section shall be in effect only from July 1, 2014 through June 30, 2015."

**AMENDMENT NO. 1 TO HOUSE BILL NO. 1144**

Amend **HOUSE BILL NO. 1144** as originally introduced:

Delete SECTION 18 in its entirety and substitute the following:

" SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HOLIDAY COMPENSATION. The Department of Correction is authorized to pay employees for ~~up to one hundred fifty (150) hours of unused holidays exceeding a balance in the employee's holiday account of ninety-six (96) hours~~ following the end of the calendar year. Payments of unused Holiday hours must be processed on or before June 1st in each fiscal year. Employees terminating employment from the Department of Correction will be eligible for all holiday pay accrued ~~during the years of service~~. This request is contingent on approval by the Chief Fiscal Officer of the State after the Director of the Department of Correction has verified that sufficient revenues are available to make such payments to employees who have served in the following classifications, with the exception that those employees wishing to accrue banked hours be allowed the option to bank unused holiday hours in the employee's holiday account, not to exceed one-hundred fifty (150) hours:

SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EMPLOYEE COMPENSATION REPORT. The Department of Finance and Administration Office of Budget shall prepare and submit to the Arkansas Legislative Council or Joint Budget Committee a report reflecting the

amount of appropriation and funding necessary for the Department of Correction to sufficiently budget for the expenditure of payments to employees for all Holiday Liability, Straight Time Liability, Overtime, and Hazardous Duty Compensation incurred, including the current balances of said liabilities. This report shall be included in the summary budget information manual submitted during the biennial budget process."

" SECTION 82. SPECIAL LANGUAGE. Uncodified Item (B) of Section 10 of House Bill 1007 of the 2014 Fiscal Session, concerning Reappropriations to the Department of Education - State Library, is amended to read as follows:

(B) Effective July 1, 2014, the balance of the appropriation provided in Item (A) Section 1 of Act 632 of 2013, for grants to public libraries for personal services and operating expenses, land acquisition, improvements, construction, renovation, major maintenance, and purchase of equipment or grants to the North Central Arkansas Economic Development District Inc., in a sum not to exceed .....\$500,000.

SECTION 83. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As referenced in Section 1(A) of Act 632 of 2013, Section 3(c) of Act 1518 of 2013 and Section 3(c) of Act 1519 of 2013, the authorized funding for the Department of Education - State Library for grants to public libraries for personal services and operating expenses, land acquisition, improvements, construction, renovation, major maintenance, and purchase of equipment shall be deemed to also include grants to the North Central Arkansas Economic Development District Inc."
