Subtitle of House Bill No. 1214

AN ACT FOR THE DEPARTMENT OF COMMUNITY CORRECTION APPROPRIATION FOR THE 2017-
2018 FISCAL YEAR.

Amendment No. ___ to House Bill No. 1214

Amend House Bill No. 1214 as originally introduced:

Insert an additional SECTION immediately following SECTION 35 to read as follows:

"SECTION 36. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MOTOR VEHICLE PURCHASE PROVISION. The Department of Community Correction is hereby authorized to purchase motor vehicles from the appropriations authorized for Capital Outlay in the State Operations and Special Revenue Operations appropriations in this Act.

The provisions of this section shall be in effect only from July 1, 2017 through June 30, 2018."

Subtitle of Senate Bill No. 94

AN ACT FOR THE ARKANSAS FAIR HOUSING COMMISSION APPROPRIATION FOR THE 2017-2018
FISCAL YEAR

Amendment No. ___ to Senate Bill No. 94

Amend Senate Bill No. 94 as originally introduced:

Page 3, delete SECTION 5 in its entirety and substitute the following:

" SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PROMOTIONAL ITEMS. Upon approval of the Chief Fiscal Officer of the State, the Arkansas Fair Housing Commission is hereby authorized to transfer appropriation from Operating Expenses to Promotional Items in the Education-Trust Appropriation provided by this Act in an amount not to exceed eight thousand dollars (\$8,000) each fiscal year to meet the Commission's educational needs. The provisions of this section shall be in effect only from July 1, 2017 through June 30, 2018."
