

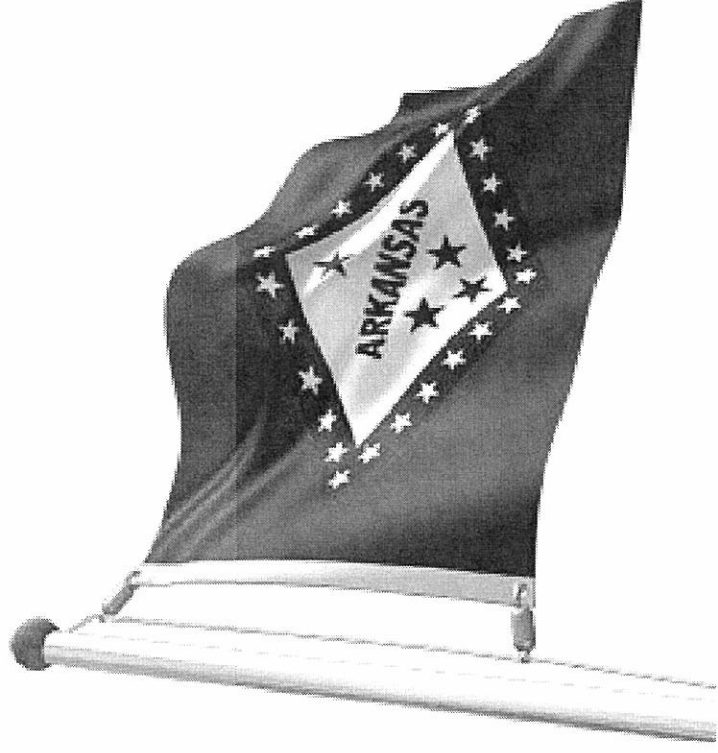

System Overview



What Is AOJF?

The Administration of Justice Fund Section (AOJF) was created in 1995 to collect court-costs, fees and fines paid through state courts, and redistribute proceeds for the state's judicial system. This involves:

- The Judicial branch, including more than 300 courts statewide
- The Legislative Branch, which has created and added to the AOJF system through code
- The Executive Branch (DFA) which administers the AOJF Section
- Since FY07, annual collections by AOJF have averaged \$34.9m

The Fines, Fees & Court Costs collected by local courts are used to defray the costs of operating the State's court system

- None of the funds deposited into the Administration of Justice Fund are used as General Revenue by the State.

AOJF: Distribution of Funds

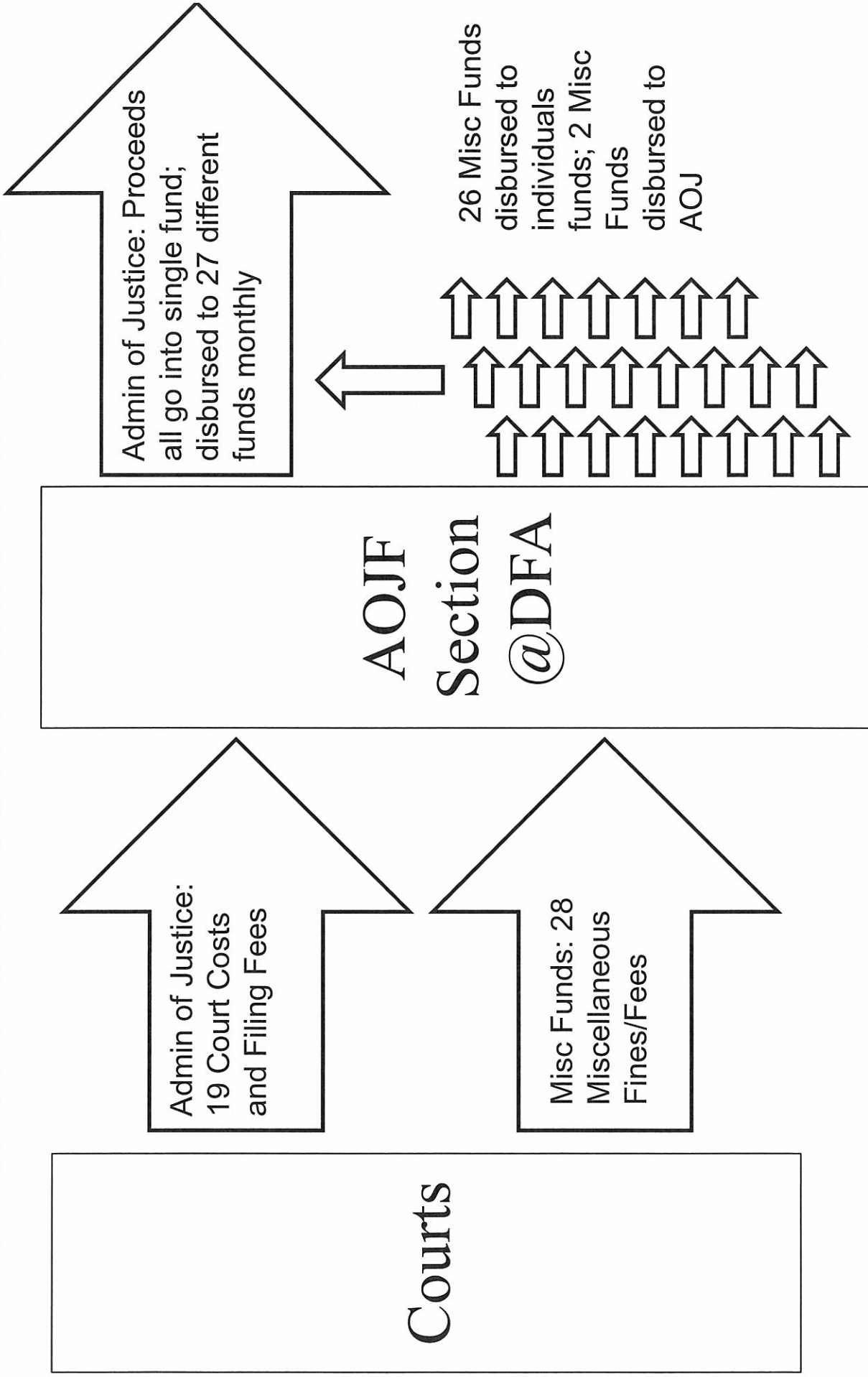

What Else Is AOJF?

Since the main AOJF program was created in 1995, the General Assembly has added two other programs:

- Miscellaneous Court Costs: 28 separate costs, collected by courts, remitted to AOJF, and deposited in funds specified by State code
- State District Judges Program: Local communities are obligated to divide half of the cost of salaries for local district judges amongst themselves. Payments are remitted to AOJF, which is responsible for enforcing payment obligations
