(c)(1) The director shall revoke the license of any licensee ~~proven to have consumed alcoholic beverages who has plead guilty, nolo contendere, or been found guilty of an alcohol related offense committed~~ while carrying a handgun.

~~(2) It shall be conclusive evidence of such consumption if an open container of alcoholic beverages is in the possession of the licensee or is in the vehicle in which the licensee is an occupant.~~
