A BILL FOR AN ACT TO BE ENTITLED AN ACT TO MAKE AN APPROPRIATION FOR ARKANSAS LIGNITE RESOURCES PILOT PROGRAM FOR RESEARCH AND COMMERCIAL TESTING OF ARKANSAS' LIGNITE RESOURCES FOR THE ARKANSAS GEOLOGICAL SURVEY FOR THE FISCAL YEAR ENDING JUNE 30, 2011; AND FOR OTHER PURPOSES.

Upon motion of Representative Maloch, **HOUSE BILL NO. 1145** was placed back on second reading for the purpose of amendment.

**AMENDMENT NO. 1 TO HOUSE BILL NO. 1145**

Amend **HOUSE BILL NO. 1145** as originally introduced:

Add a new SECTION immediately following SECTION 26 to read as follows:

" SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING - GRANTS TO FIRE DEPARTMENTS. As referenced in Section 3 of Act 1442 of 2009 and Section 3 of Act 1443 of 2009, the remaining 25% of authorized funding to be made available during the 2010-11 fiscal year from the funds made available for allocation to the Legislative Division from funds deposited into the 87th Session Projects Account within the General Improvement Fund for the Department of Finance and Administration - Disbursing Officer for grants to fire departments, the portion of these remaining funds for grants to fire departments allocated to Pulaski County shall be distributed as follows:

(a) seventy percent (70%) shall be distributed to the City of Little Rock up to a maximum of forty-one thousand nine hundred fifty-four dollars (\$41,954), and

(b) twenty-one percent (21%) shall be distributed to the City of North Little Rock up to a maximum of twelve thousand five hundred one dollars (\$12,501).

(c) seven percent (7%) shall be distributed to the City of Jacksonville up to a maximum of four thousand forty-three dollars (\$4,043).

(d) two percent (2%) shall be distributed to the City of Sherwood up to a maximum of one thousand four hundred two dollars (\$1,402).

If there is any funding remaining for Pulaski County after distributing funding in accordance with subsections (a) through (d) of this Section, the remaining funding allocated to Pulaski County, shall be distributed to fire departments based on population."

" SECTION 27. SECTION 70 of Act 1499 of 2009 is amended to read as follows:

~~SECTION 70. APPROPRIATION - PSYCHIATRIC RESIDENTIAL TREATMENT CENTERS. There is hereby appropriated to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, the following:~~

~~(A) For a grant to the Department of Human Services - Division of Behavioral Health for construction, equipping, renovation, improvements, upgrading, repair, and personal, operating and programmatic expenses and materials for psychiatric residential treatment centers across the state, the sum of .....\$200,000."~~

Delete SECTION 29 of the bill in its entirety and substitute the following:

" SECTION 30. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2010, with the exception that Section 27 in this Act shall be in full force and effect from and after the date of its passage and approval, is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2010, with the exception that Section 27 in this Act shall be in full force and effect from and after the date of its passage and approval, could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public

peace, health and safety shall be in full force and effect from and after July 1, 2010, with the exception that Section 27 of this Act shall be in full force and effect from and after the date of its passage and approval.”

Following Section 1, insert two new Sections:

" SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

(a) A Boys and Girls Club that was legally incorporated in the State of Arkansas during 2009, but was not recognized as a club by the Boys & Girls Clubs of America until 2010, shall receive the first three thousand three hundred forty-eight dollars and twenty-two cents (\$3,348.22) of any distribution made under this appropriation, provided the Club was recognized by the Boys & Girls Clubs of America on or before September 30, 2010.

(b) A club under subsection (a) of this section shall also be included in the equal distribution of any remaining funds between Boys and Girls Clubs as determined by the Athletic Commission.

SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

The State Athletic Commission shall distribute any available funds for the grants appropriated in this Act within forty-five (45) days of obtaining access to the funds, but in no event prior to October 15, 2010."
