<u>HB1172</u>	Tosh	CREATING A SENTENCE ENHANCEMENT FOR CERTAIN CRIMINAL OFFENSES TARGETING A CURRENT OR FORMER LAW ENFORCEMENT OFFICER, FIRST RESPONDER, OR HIS OR HER FAMILY; AND TO DECLARE AN EMERGENCY.

<u>HB1201</u>	Ballinger	CONCERNING STATE DISTRICT COURTS; CONCERNING THE THIRD JUDICIAL DISTRICT; AND TO DECLARE AN EMERGENCY.
<u>HB1030</u>	Bentley	TO AMEND THE ARKANSAS RURAL MEDICAL PRACTICE STUDENT LOAN AND SCHOLARSHIP PROGRAM AND THE COMMUNITY MATCH RURAL PHYSICIAN RECRUITMENT PROGRAM TO IMPROVE AND INCREASE ACCESS TO HEALTH CARE IN MEDICALLY UNDERSERVED COMMUNITIES.
<u>HB1016</u>	Farrer	TO CONVERT THE HOSPITAL REIMBURSEMENT SYSTEMS UNDER THE ARKANSAS MEDICAID PROGRAM TO DIAGNOSIS-RELATED GROUP METHODOLOGY.
<u>HB1185</u>	D. Meeks	TO AMEND THE LAWS CONCERNING A FETAL DEATH CERTIFICATE AND REGISTRATION OF TERMINATION OF PREGNANCY; AND TO AMEND THE LAW CONCERNING A CERTIFICATE OF BIRTH RESULTING IN STILLBIRTH.
