- Governor's Scholar \$5,000 award to students who graduate with a diploma of distinction or earn an associate degree while in high school - \$5,000,000
- Workforce Challenge award level changes - \$9,062,982
- Repeal of Concurrent Challenge – (\$3,875,974)
- ACCESS to Acceleration Program \$2,000 per year maximum award for concurrent credit students up to 30 hours per academic year - \$15,502,000
- Academic Challenge savings due to concurrent credit hours earned from ACCESS to Acceleration Program – (\$11,750,000)
