HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,093.6 million have increased \$26.3 million, or .5%, above the \$5,067.3 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$292.9 million decreased \$3.1 million, or 1.05%, from the \$296 million available for distribution in May 2008.

In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$1,877,229.75 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$20,649,527.25.

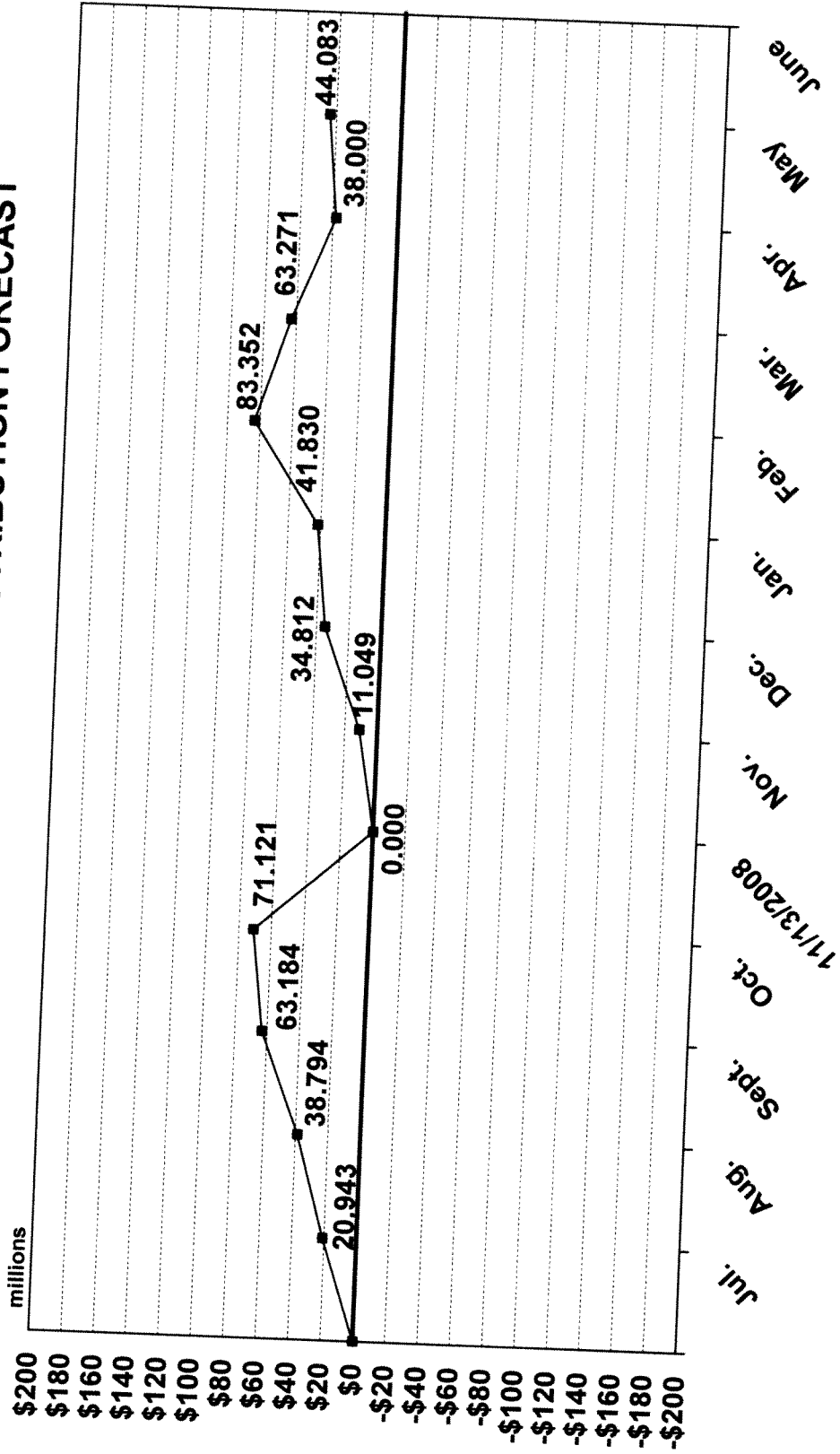
