There is hereby authorized, for the Department of Inspector General - Office of Medicaid Inspector General for the 2026-2027 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: ~~two~~ (2) one (1) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

Immediately following Section 20, please insert the following and renumber accordingly:

SECTION XX. EXTRA HELP - OPERATIONS - OFFICE OF THE JUVENILE OMBUDSMAN. There is hereby authorized, for the Department of Inspector General - Office of the Juvenile Ombudsman for the 2026-2027 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: one (1) temporary or part-time employee, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

The above requests are necessary to transfer one (1) extra help position from the Office of Medicaid Inspector General to the Office of the Juvenile Ombudsman.
