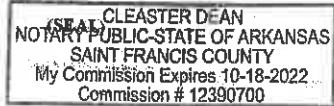

At EARU Fusion Center on December 27, 2013 at approx. 6:00pm, I Cpl. Matthews reviewed the inmate banking account of inmate Ricky Leonard #075333 as a result of a phone call that was placed by Inmate Gary Stotts #92571 on December 3, 2013 to telephone number 501-259-2575 that is shown belonging to Cainra Stotts Moore who is listed as the sister of Gary Stotts. During that phone call inmate Stotts can be heard asking the female on the receiving end to deposit money in inmate Leonard's inmate account so that he could go to the store (commissary) for him because he was on restrictions. Inmate Stotts did receive a disciplinary for asking the female to violate ADC policy: Unauthorized Use of Mail/Phone, Failure To Obey Order Of Staff, Purchase Of Unauthorized Articles and Asking/Offering Inducement (see incident numbered 2013-12-027).

While reviewing Leonard's Inmate Banking Account it was discovered that Cainra Stotts Moore deposited four hundred twenty dollars on December 4, 2014 and two hundred eighty dollars on December 9, 2013 totaling seven hundred dollars into inmate Leonard's account.

Inmate Leonard knows that receiving money from another inmate's family or associate for trafficking and trading is a direct violation of both ADC and Unit Policy. Therefore I am charging this Inmate Ricky Leonard #75333 with rule violations 12-1, 15-1, 15-2 and 2-3 pending DCR and of statement.







RESPONDENT'S MOTION TO DISMISS


COMES NOW the Respondent, Arkansas Department of Correction, and for its MOTION TO DISMISS, states and responds as follows:

1. Claimant alleges two claims of failure to follow procedure. Claimant is seeking \$9,500.00. Claimant has failed to state a claim upon which relief can be granted under ARCP Rule 12(b)(6) and (b)(1) lack of jurisdiction and the matter should be dismissed.
2. Claimant's argument is that he was found guilty of a false disciplinary (possession of cell phone charger, unauthorized use of electronic device, and failure to obey order of staff), but offers no proof of its falsity. The appeal was upheld at all levels!
4. Claimant is merely trying to reargue and appeal to the commission his conviction. Administrative agencies, due to their specialization, experience, and greater flexibility of procedure, are better equipped than courts to analyze legal issues dealing with their agencies. *Crawford v. Cashion*, 361 S.W.3d 268, 271 (2010), citing *Dukes*, 369 Ark. at 516, 256 S.W.3d at 487; *Clinton v. Bonds*, 306 Ark. 554, 557, 816 S.W.2d 169, 171 (1991). In particular, the administration of prisons has generally been held to be beyond the province of the courts. *Clinton*, 306 Ark. at 557, 816 S.W.2d at 171. Therefore, we have consistently declined to dictate the operation of the Arkansas Department of Correction. *See, e.g., Martin v. State*, 340 Ark. 719, 13 S.W.3d 576 (2000) for these reasons this matter should be dismissed for lack of jurisdiction.
5. Claimant's second claim alleges that he was not promoted to Class III in the proper time. He was no eligible for Class until 11-6-14 due to the contraband (receiving money on his books \$700.00 from another inmate's sister – trafficking and trading) disciplinary he received. This disciplinary carried the nine (9) months penalty before being re-assessed by classification. He was seen by classification on 11-13-14 and promoted from Class IV to Class III.
6. A motion to dismiss is proper when there are no facts upon which relief can be granted. ARCP 12(b)(6). Respondent moves that the commission dismiss this claim.

WHEREFORE, for the reasons stated above and the evidence submitted the Claim must be dismissed.

Matthews reviewed the inmate banking account of inmate Ricky Leonard #075333 as a result of a phone call that was placed by Inmate Gary Stotts #92571 on December 3, 2013 to telephone number 501-259-2575 that is shown belonging to Camra Stotts Moore who is listed as the sister of Gary Stotts. During that phone call Inmate Stotts can be heard asking the female on the receiving end to deposit money in inmate Leonard's inmate account so that he could go to the store (commissary) for him because he was on restrictions. Inmate Stotts did receive a disciplinary for asking the female to violate ADC Policy: Unauthorized Use of Mail/Phone, Failure To Obey Order Of Staff, Purchase Of Unauthorized Articles and Asking/Offering Inducement (see incident numbered: 2013-12-027).

While reviewing Leonard's Inmate Banking Account it was discovered that Camra Stotts Moore deposited four hundred twenty dollars on December 4, 2013 and two hundred eighty dollars on December 9, 2013 totaling seven hundred dollars into Inmate Leonard's account.

Inmate Leonard knows that receiving money from another inmate's family or associate for trafficking and trading is a direct violation of both ADC and Unit Policy. Therefore I am charging this Inmate Ricky Leonard #75333 with rule violations 12-1, 15-1, 15-2 and 2-3 pending DCR. End of statement.

I am writing to your office in Dire need of your help or for you to point me in the direction that I can go for help on this matter. I am incarcerated at E.R.R.U. I made parole in Sept. 2013 and was written up for a bunch of rules that the officer, major and several others at this prison knew were lies when it was written. I will try to explain some of this to you to make it easier to understand. I am enclosing the facts to show you my civil rights have been violated. First off I was written up for another inmates sister sending me money. In my disciplinary they said she sent me \$700.00 which was a blatant lie. My bank account shows the amounts that were sent. They found me guilty for having \$700.00 sent to my account which is on file. They took my parole, Isolation for 30 days, Class 4 and 273 days good time. As you can see by the paperwork enclosed they convicted me on lies. Now they are saying that I used the telephone to bring contraband into their unit. I have never ever used the phone and it is on file that I have no one on my phone list. They are saying I can't get my class back for 9 months because of this. What they are trying to do is hold what another inmate done against me. I was never caught or seen doing anything with or for the inmate they said.

I have written the Warden and several others about this but cannot get an answer. You can see in my appeals where they continued to violate policies and that the director Ray Hall that signed these policies blatantly went against his own word that he approved. I have no where else to turn to and have exhausted all other remedies besides a lawsuit. Can you please help me on this matter or tell me who might help me with this. By these lies I am being made to stay here a year longer & just because these people have power over us that they can violate all rights and get by with it.
