My bonuses are generally 20% of my salary. This amount also does not include what would have gone into my Retirement account from the State of Arkansas. I have worked for ACE since 9-10-07. I feel that I have earned this money and it should have been paid to me, and I believe this money should be paid to me now. I have attached the emails I received from Tiffany and my supervisor. Joy.
