To ensure every public school district receives the full amount of foundation funding, ACA 6-20-2305(a)(4)(A), states by the end of each school year, for a school district whose net revenues are less than the sum of 98% of the uniform rate of tax (URT) multiplied by the property tax assessment of the school district, the Department of Education shall distribute to the school district the difference between the net revenues of the school district and sum of 98% of the URT multiplied by the property assessment of the district. The division will use fund balance to make these payments; however additional appropriation is required to meet the obligation.


