**HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS**

Collections of Gross General Revenues year-to-date of approximately \$887.8 million have million, or 2.8%, above the \$864 million collected last fiscal year-to-date. Net General Revenue Distribution this month of \$369.1 million decreased \$4.6 million, or 1.2%, from the \$373.7 million distribution in August 2011. In accordance with Act 1315 of 1999, the Chief Fiscal Officer transferred \$2,283,070.84 from Corporate Income Tax to the Workforce 2000 Development Fund for a total of \$4,566,141.68.

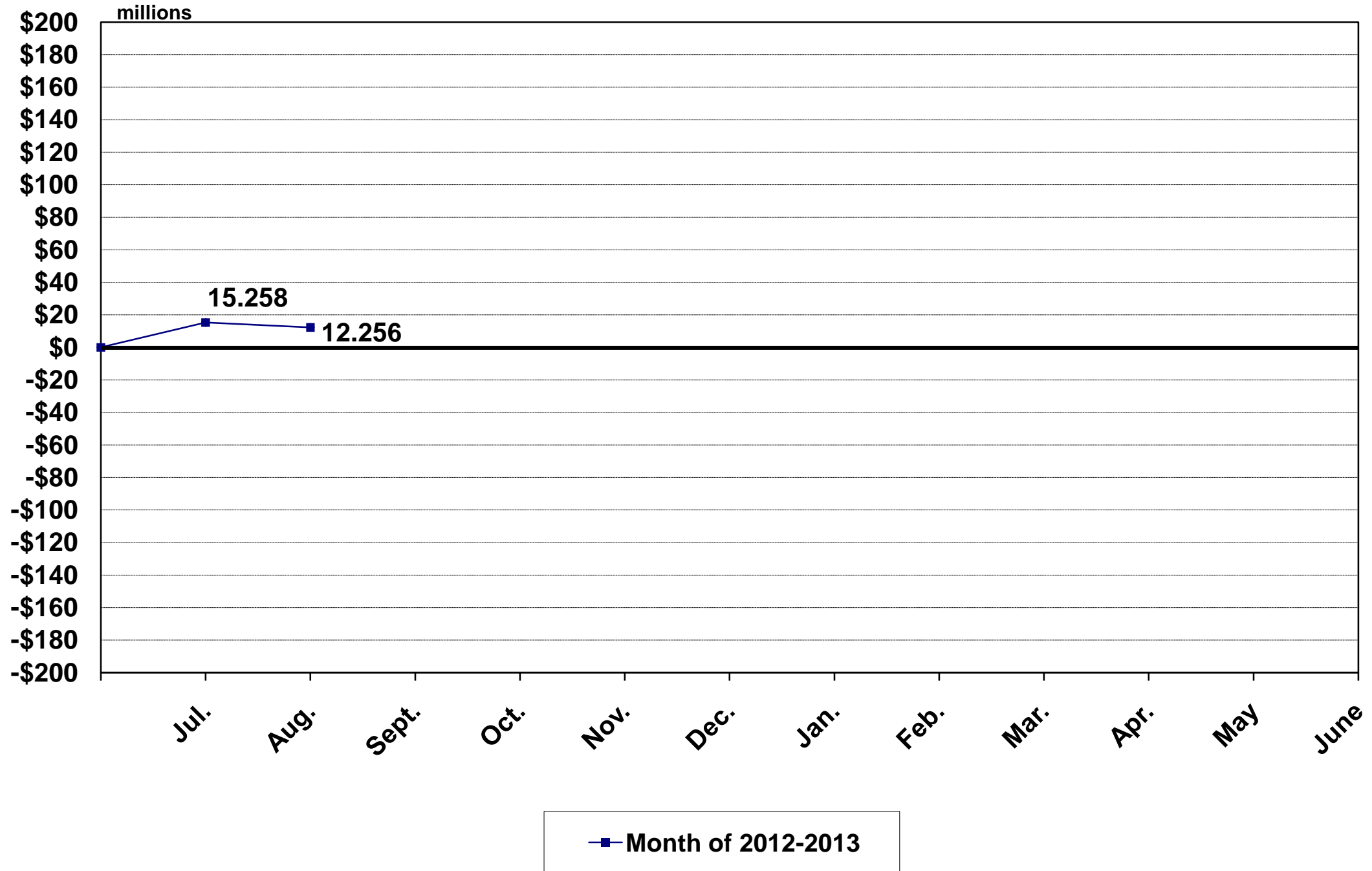
