Explanation: Approximately 8-15-13 I was cut-out to general population "22 Barracks". And I immediately wrote SGT CRUMPTON "over the locks at Varner Unit" to receive a key to my locker box, so I could secure my personal property. Also wrote Warden Watson and Warden Andrews; plus talked with Warden Andrews on 2 different occasions. Around October 1st Warden Andrews stated to me in the chow hall He would send someone to issue me a key to my locker box. Never Happened! On October 9th I received a cut-slip to move to 9 Bks. I told the officer on our post that I had a no-stair script. She called LT Boatright house. He called me down the hallway and advised me that Dr. Iko stated my script was no more. I returned to 22 barracks to get my script and when I got in my locker all of my property was stolen. I immediately reported it to staff (LT Boatright house, SGT White) They did nothing and I refused to move so they locked me up. Then I couldn't even get a stolen property form. A.D.C. is suppose to provide me with some type of way to secure my personal property, since I was never issued a key I was never given that right and all of my property was stolen. I immediately filed grievance and was transferred during grievance process and that was why my grievance was conveniently considered untimely due to my transfer and me not having original and knowledge of how to proceed. All receipts and paperwork are enclosed. End of Statement

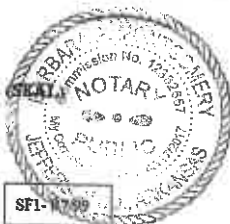

I then told the SGT White in Isolation 1 that my property was missing. I had talked to Warden Watson and Warden Andrews about getting a key to my box plus wrote them and SGT Crompton. A.D.C. is suppose to provide me with some way of securing my personal property. Since I was never given that opportunity A.D.C. is responsible for my loss property. Since I've been locked down I can't get a stolen property form or anyone to help me. RESPONDENT'S MOTION TO DISMISS

COMES NOW the Respondent, Arkansas Department of Correction, and for its MOTION TO DISMISS, states and responds as follows:

1. Claimant has filed a claim for loss of property and failure to follow policy. He is seeking \$199.00. Claimant has failed to state a claim upon which relief can be granted under ARCP 12(b)(6) and the claim should be dismissed.
2. Claimant states that he did not receive a lock for his property box upon release to general population at VSM on August 15, 2013, and his property was stolen on October 9, 2013. Claimant has been incarcerated since 2006 and has been at Varner from April 2011 through August 2011. Claimant is aware that keys are issued upon arrival at the unit or release to population by Sgt. Crompton.
3. Claimant states that he talked to Deputy Warden Andrews and Sgt. Crompton about a lock, but took no other steps to obtain one. No grievance was filed for not having one issued until after his property was stolen. No inmate request was sent asking for a lock. Testimony will show that Sgt. Compton did not receive any requests for a lock from Claimant.
4. Interesting, Claimant's property was taken after two large trips to the commissary. He was transferred from VSM to ORCU on October 17, 2013 and had none of the property. On July 20, 2014, at ORCU while being locked up on DCR, he was found to be in possession of CL-20 headphones, Nike gym shoes, GPX radio, 6 T-shirts, 2 bowls, 1 mirror, and multiple other items. See Exhibit "A". The only items on the list which were found to be purchased were batteries and he was in excess of the number allowed. See Exhibit "B".
5. Claimant failed to properly exhaust his remedies by filing his grievance and exhausting the appeals as required. Claimant's grievance was rejected as UNTIMELY due to him attempting to file a copy and mailing the original home to his mother, thereby making his claim 6 days late. "REJECT - Untimely eOMIS message: FYI - This grievance was not filed in a timely manner. Step 1 10/14/2013; email rec'd on 10/28/2013 from ORCU inmate going to step 2; 10/30/2013 rec'd photocopy of grievance through US Mail, advised ORCU cannot enter grievance from photocopy, ORCU advised did not have original as inmate had mailed original

home to his mother, advised ORCU cannot enter; Rec'd Original through US Mail on 11/07/2013. 10/14 to 10/28 exceeds 6 day time frame."

6. AD12-16(N) provides that "inmates are hereby advised that they must exhaust their administrative remedies as to all defendants at all levels of the grievance procedure before filing a Section 1983 lawsuit and Claims Commission claim. If this is not done, their lawsuit or claims may be dismissed immediately.
7. Claimant's possession of these items is evidence that Claimant has engaged in trafficking and trading.
8. Based on the foregoing statements, has failed to state a claim upon which relief can be granted herein under ARCP Rule 12(b)(6).

WHEREFORE, for the reasons stated about and the evidence submitted, the Claim must be dismissed.

The Varner Unit is the only unit I've been to where you don't have to be on your assigned rack or issued a key or able to purchase a lock. (The only time I was issued a key was in the Pal Program; which is a program that is faith based and have inmate mentors who give you a key to your lock.)

A.) In paragraph 2. Respondent states that inmates are issued Keys upon arrival or release to population by SGT CRUMPTON. (That is their policy but in 2011 and 2013 never received Key to a lock)

B.) In paragraph 3. Respondent states that Claimant never took any steps to obtain lock. I wrote Deputy Warden Andrews and SGT crumpton, plus talked to the Warden and Deputy Warden Andrews, plus MR. Naylor over Internal Affairs.

C.) In paragraph 4. Respondent states that claimant had a bunch of property that wasn't purchased. Captain King was working through Warden Andrews and MR Naylor's orders giving me property out of property room,

D.) In paragraph 5. Respondent states that Claimant didn't exhaust remedies. On 12-10-13 Director Larry May Exhausted my Grievance process. Grievance # VSM 13-04459. I was transferred during process and that was were there was a

2. Respondent is questioning persons involved and now I've been told Varner Unit is now following this Policy on making sure inmates receive a key but as said earlier in 2011 and 2013 I did not receive a key to secure my personal property.
3. If Captain King and Mr Naylor was questioned about my property being stolen you would know that they were trying to help me and was giving me property out of the Ouachita River Unit's property room to keep me from filing this lawsuit. Now all of it was stolen and I've showed property forms showing this so I filed this small claims. They were using me as an informant and since all the inmates know now; I'm placed in the maximum Security Unit for protection. Now noone will talk to me and ignore all request and letters to all that are involved.
4. At the Ouachita River Unit you sign for a key and a cylinder and every time you move a SGT. removes them and places it in a new lock. At Varner Unit 2011-2013 you don't even get your assigned bed space and half of the beds are missing the lock and even if it had one you wouldn't receive a key. This type of Negligence is why the A.D.C. has had so many thefts at this unit, but inmates are either scared or don't know their rights. A.D.C. is responsible to provide me some type of way to secure my personal property; since they never did they are responsible for the \$199.00

5. Respondent tries to mess up our grievance process by transferring us during the process so they will usually be untimely but just because it's untimely doesn't mean our claim is void. Policy AD12-16(N) as long as it's exhausted; which I did.
6. Certain Officers told inmates that I worked for Internal Affairs and they waited for me to go back to the store and took all of my property. I never received a key to the lock at the end of my bed.

Wherefore for the reasons cited in my case and all the evidence provided in my initial claim the claimant prays that the respondent pays the 199.00 or have a hearing and the truth will come out.
