Reports from Members Who Attended Recent Meetings Concerning Public or Higher Education

**The Honorable Joyce Elliott**, State Senator, District 31, was recognized. Senator Elliott commented that the NCSL (National Conference of State Legislatures) Fall Forum was an extremely good meeting. She said it included a discussion of priority issues with members of Arkansas's congressional delegation on Capitol Hill, informative sessions on choice and on workforce and the arts, and the results of the PISA (Programme for International Student Assessment) exams.

Issues Included in the Discussion:

- testing students nationally vs. internationally,
- addressing special needs populations in testing,
- methods used by countries that are doing extremely well, and
- amount spent per student.

At Senator Johnny Key's request, Senator Elliott announced that legislators were invited to attend a press conference at 1:00 p.m., at which reclaiming the promise of public education would be addressed, followed by a brief work session.

#### Overview of the Imagination Libraries Program

**The Honorable Jason Rapert**, State Senator, District 35, introduced Dr. Charlotte Green.

##### Presenter & Synopsis:

**Dr. Charlotte Green**, Supervisor, Gifted and Advanced Placement, Conway School District, was recognized. Dr. Green discussed a non-profit collaboration between Conway Public Schools and the local Chamber of Commerce set up to invest in professional development, educational materials, and home support initiatives. She said the Imagination Library is one of the home support initiatives, and presented a YouTube video about the Library. In support of the Library's effectiveness, Dr. Green presented Qualls Early Learning Inventory (QELI) assessments of kindergarten students from Des Arc Elementary showing developmental data from before and after implementation of the Imagination Library.

#### Overview of the Bookcase For Every Child Program

**The Honorable Jason Rapert**, State Senator, District 35, introduced Mr. Jim Davidson.

##### Presenter & Synopsis:

**Mr. Jim Davidson**, Chairman, The Conway Bookcase Project Committee, was recognized. Mr. Davidson presented a YouTube video about the Bookcase Project. He furnished a historical perspective about the program and explained the differences between the Imagination Library and the Bookcase For Every Child Program. He said the project works exclusively with children from low-income families through the Head Start program; children are given a bookcase along with a starter set of donated books. Parents and grandparents are encouraged to buy books on special occasions to supplement the library. He discussed various methods used to involve groups and whole communities with support and funding for the project.

##### Issues Included in the Discussion:

- ◆ changing the culture of households,

- ◆ schools reflecting the community, and
- ◆ encouraging legislators to recruit local participation in the project.

Senator Key thanked Senator Rapert for requesting that both speakers be on the agenda. He thanked the participants for giving very informative presentations to the Committees.

Update on the Elementary and Secondary Education Act (ESEA) Waiver and Associated Accountability Results

Presenter & Synopsis:

**Mr. John Hoy**, Assistant Commissioner, Division of Academic Accountability, Arkansas Department of Education, was recognized. Mr. Hoy began with a brief update on the Elementary and Secondary Education Act (ESEA) reauthorization. He discussed The Student Success Act (H.R.5) passed by the U.S. House of Representatives on July 19, 2013, and stated that while progress has been made, he didn't think anything would happen soon that would trickle down to impact states. He discussed the two-year waiver of the ESEA statute received by Arkansas, this being the second year. He said the option of a one-year extension of the waiver that is in place, with the possibility of amendments, has been authorized by U.S. Secretary of Education, Mr. Arne Duncan. As far as accountability in the state, Mr. Hoy stated that, based on 2013 assessment results, the following schools have currently been identified: 9 exemplary schools, 138 achieving schools, 793 needs improvement schools, 89 focus schools, and 42 priority schools. He made one cautionary note about the results of the ESEA accountability. He said plans were implemented during the second semester of last year. He stated this will be the first full year of implementation, and we are looking forward to those results, especially in the priority and focus schools.

- appropriate indicators to determine a letter grade for school district performance.
