19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 *SECTION 1. Arkansas Code 22-3-302 (b), concerning the boundaries of*
22 *the Capitol Zoning District, is amended to read as follows:*

23 *(b)(1) In addition to the area described in subsection (a) of this*
24 *section, the Capitol Zoning District shall also include an area surrounding*
25 *the Governor's Mansion, which is located at 18th and Center Streets in the*
26 *City of Little Rock, Pulaski County, Arkansas, within the following described*
27 *boundaries: Beginning at a point on the southwestern corner of 13th and*
28 *Cumberland Streets, in the City of Little Rock, Pulaski County, Arkansas,*
29 *proceeding south along the western side of Cumberland Street to the northwest*
30 *corner of 16th and Cumberland Streets, and then proceeding west along the*
31 *northern boundary of 16th Street to a point where the centerline of the*
32 *alleyway between Scott and Cumberland Streets, extended northward, intersects*
33 *that northern boundary, thence, south along the centerline of the alleyway,*
34 *or an imaginary line bisecting the blocks between Cumberland and Scott*
35 *Streets, to the southern boundary of 22nd Street, and thence west along that*
36 *southern boundary to a point where an imaginary line bisecting the block*

1 between Scott and Main Streets intersects that southern boundary, thence
 2 south along that imaginary line to a point where the centerline of ~~23rd~~
 3 ~~Street~~ Roosevelt Road, extended eastward, intersects that imaginary line,
 4 then west along the centerline of ~~23rd Street~~ Roosevelt Road to the
 5 centerline of Chester Street, thence north along the centerline of Chester
 6 Street to the centerline of 20th Street, thence east along the centerline of
 7 20th Street, to a point where the centerline of the alleyway between Gaines
 8 and State Streets intersects the centerline of ~~23rd~~ 20th Street, thence north
 9 along the centerline of the alleyway, or an imaginary line bisecting the
 10 blocks between Gaines and State Streets, to a point where that centerline
 11 intersects the southern boundary of 13th Street, thence east along the
 12 southern boundary of 13th Street to the point of the beginning.

13 (2) In addition, the Capitol Zoning District may in the future
 14 be further extended by a two-thirds vote of the Commission to include the
 15 area in the following described boundaries: Beginning at the centerline of
 16 Chester Street where it intersects with the centerline of 20th Street
 17 proceeding north along the centerline of Chester Street to I-630; thence east
 18 along the southern boundary of I-630 to the intersection of the centerline of
 19 Commerce Street; thence south along the centerline of Commerce Street to a
 20 point where it intersects the centerline of 24th Street; and thence east
 21 along the centerline of 24th Street to I-30; thence south along the western
 22 boundary of I-30 to the intersection of the centerline of Roosevelt Road; and
 23 thence west along the centerline of Roosevelt Road to the point of
 24 intersection with the imaginary line that bisects the block between Scott and
 25 Main Streets.
