**HOUSE JOINT RESOLUTION**

9 AN ACT TO AMEND § 9(b) OF AMENDMENT 51 TO THE  
10 ARKANSAS CONSTITUTION REGARDING THE APPLICATION  
11 TO REGISTER; AND FOR OTHER PURPOSES.

14 AN ACT TO AMEND § 9(b) OF AMENDMENT 51  
15 TO THE ARKANSAS CONSTITUTION.

17 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FOURTH GENERAL  
18 ASSEMBLY OF THE STATE OF ARKANSAS AND BY THE SENATE, A MAJORITY OF ALL  
19 MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:  
20

21 That the following is hereby proposed as an amendment to the  
22 Constitution of the State of Arkansas, and upon being submitted to the  
23 electors of the state for approval or rejection at the next general election  
24 for Representatives and Senators, if a majority of the electors voting  
25 thereon at such election, adopt such amendment, the same shall become a part  
26 of the Constitution of the State of Arkansas, to wit:  
27

28 SECTION 1. Under the authority granted in §19 of Amendment 51 to the  
29 Arkansas Constitution, § 9(b) of Amendment 51 to the Arkansas Constitution,  
30 regarding the application to register, is amended to read as follows:

31 (b)(1) Except as provided in subdivision (b)(2) of this section,  
32 ~~Registration~~ registration shall be in progress at all times except during the  
33 thirty-day period immediately prior to any election scheduled within the  
34 county, during which period registration of voters shall cease for that  
35 election, but registration during such period shall be effective for  
36 subsequent elections.

1           (2) If a voter moves from one county to another, the voter may  
2 transfer his or her registration at any time and is not required to re-  
3 register upon moving within the state.

4           (3) Upon notification of the voter's new address, the county  
5 registrar shall verify the voter's status from the statewide voter file and  
6 update the voter's address.

7           (4) After the voter's address is updated, the voter shall be a  
8 registrant of the new county of residence.

9           (5) All voter history shall follow the transferring registrant  
10 from the statewide voter file.

11           (6) The General Assembly shall prescribe the procedures for the  
12 transfer of registration.
