## For An Act To Be Entitled

9 AN ACT TO ALLOW CITIES AND TOWNS THE OPTION OF  
10 REVERSE INTERNET AUCTIONS FOR THE PURCHASE OF  
11 GOODS AND SERVICES; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT TO ALLOW CITIES AND TOWNS THE  
15 OPTION OF REVERSE INTERNET AUCTIONS FOR  
16 THE PURCHASE OF GOODS AND SERVICES.

18  
19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20  
21 SECTION 1. Arkansas Code § 14-58-303 is amended to add an additional  
22 subsection to read as follows:

23 (c)(1) In a city of the first class, a city of the second class, or an  
24 incorporated town, the governing body by ordinance shall have the option to  
25 make purchases by participation in a reverse Internet auction.

26 (2) The ordinance shall include, but is not limited, to the  
27 following procedures:

28 (A) Bidders shall be provided instructions and  
29 individually secured passwords for access to the reverse Internet auction by  
30 either the city, town, or reverse Internet auction vendor;

31 (B) The bidding process shall be timed, and the time shall  
32 be part of the reverse Internet auction specifications;

33 (C) The reverse Internet auction shall be held at a  
34 specific date and time;

35 (D) The reverse Internet auction and bidding process shall  
36 be interactive with each bidder able to make multiple bids during the



1 allotted time;

2 (E) Each bidder shall be continually signaled his or her  
3 relative position in the bidding process;

4 (F) Bidders shall remain anonymous and shall not have  
5 access to other bidders or bids; and

6 (G) The governing body shall have access to real-time data  
7 including all bids and bid amounts.

8 (3) The governing body may create by an additional ordinance  
9 reverse Internet auction specifications for the anticipated purchase of a  
10 specific item or purchase.

11 (4)(A) The governing body is authorized to pay a reasonable fee  
12 to the reverse Internet auction vendor.

13 (B) The fee may be included as part of the bids received  
14 during the reverse Internet auction and paid by the winning bidder or paid  
15 separately by the governing body.

16 (5) The governing body retains the right to:

17 (A) Refuse all bids made during the reverse Internet  
18 auction; and

19 (B) Begin the reverse Internet auction process anew if the  
20 governing body determines it is in the best interest of the city or town.

21 (d) For purposes of this section:

22 (1) "Reverse Internet auction" means an Internet-based process  
23 in which bidders:

24 (A) Are given specifications for items and services being  
25 sought for purchase by a municipality; and

26 (B) Bid against themselves in order to lower the price of  
27 the item or service to the lowest possible level; and

28 (2) "Reverse Internet auction vendor" means an Internet-based  
29 entity that hosts a reverse Internet auction.
