8 **HOUSE CONCURRENT RESOLUTION**

9 TO ADOPT THE RULES OF THE HOUSE OF  
10 REPRESENTATIVES AND THE SENATE OF THE EIGHTY-  
11 SIXTH GENERAL ASSEMBLY.

13 **Subtitle**

14 TO ADOPT THE RULES OF THE HOUSE OF  
15 REPRESENTATIVES AND THE SENATE OF THE  
16 EIGHTY-SIXTH GENERAL ASSEMBLY.

18  
19 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-SIXTH GENERAL  
20 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

21  
22 The following are adopted as the rules of the House of Representatives  
23 and the Senate of the Eighty-Sixth General Assembly of the State of Arkansas.

24  
25 **JOINT RULES**  
26 **OF THE**  
27 **HOUSE OF REPRESENTATIVES**  
28 **AND THE SENATE**  
29

30 **Joint Session - How Convened**

31 Section 1. When, by the Constitution or laws of the state, a joint  
32 meeting of the Senate and House of Representatives is required, they shall  
33 assemble with their clerks on the day and at the hour previously agreed on  
34 for that purpose in the hall of the House of Representatives.

35  
36 **Officers of Joint Session**





1 regardless whether the bill or resolution originated in the House or the  
2 Senate, the Senate shall engross the bill or resolution as amended. After  
3 the adoption of the amendment on the floor of the House of Representatives,  
4 regardless whether the bill or resolution originated in the House or the  
5 Senate, the House of Representatives shall engross the bill or resolution as  
6 amended.

7 This rule may be waived by the President Pro Tempore of the Senate or  
8 in his absence the Chairman of Senate Rules Committee, or the Speaker of the  
9 House of Representatives.

### Enrollment of Bills

12

Section 7. When a bill shall have passed both houses, it shall be  
13 enrolled by the enrolling clerk of the house in which it originated.

14

Section 8. All bills must be enrolled and reported to each house by  
16 the committee designated by each house to supervise the enrolling of bills,  
17 within three (3) days after their passage; provided, that if the  
18 reconsideration of any bill is moved, in either house, previous to its  
19 presentation to the Governor, the committee shall hold the same until action  
is taken upon such motion.

20

21

Section 9. No bill, resolution, or memorial shall be sent to the  
22 Governor for his approval, unless the same shall have been clearly and fairly  
enrolled without obliteration or interlineation.

### Signing of Bills

25

26

Section 10. After examination and report by the committee responsible  
27 for enrolling bills, each bill shall be signed by the Speaker of the House of  
Representatives and by the President of the Senate. Each page of a bill  
28 shall be signed by the Speaker of the House of Representatives on the right  
29 margin, and shall be signed by the President of the Senate on the left margin  
30 of each page. The Speaker of the House of Representatives and the President  
31 of the Senate shall manually sign each page of each bill, or may provide, at  
32 their option and under their supervision, for the affixing thereto of their  
33 facsimile signature in the manner and procedure provided by Act 69 of 1959.  
34 (*Arkansas Code §§ 21-10-101 thru 21-10-106*)

### Announcement of Message

1           Section 11. When the Secretary of the Senate or Chief Clerk of the  
2 House, or either of the assistants, shall wait upon the other house, notice  
3 thereof shall be given to the President or Speaker of the House by the  
4 Sergeant at Arms, or Assistant Sergeant at Arms, who shall declare the same,  
5 and a copy of the message to be laid on the table of the clerk or secretary.  
6

#### 7                           **Bills Passed by the Other House**

8           Section 12. Tuesday and Friday of each week are hereby set apart in  
9 each house for the special and exclusive consideration of bills and  
10 resolutions, which may have been passed by the other house, and the  
11 consideration of such bills and resolutions shall take precedence over all  
12 the other business on these days immediately after the expiration of one (1)  
13 hour after the house shall be called to order by the presiding officer;  
14 provided, that the reading of the Journal shall be completed in any event.  
15

#### 16                           **Conference Committee**

17           Section 13. When either body shall request a conference, and appoint a  
18 committee for that purpose, the other body shall also appoint a committee of  
19 equal number to confer, and such conference shall be held at any time and  
20 place agreed upon by the Chairpersons.  
21

#### 22                           **Suspension of Joint Rules**

23           Section 14. No joint rules shall be dispensed with but by a concurrent  
24 vote of two-thirds (2/3) of each house, and if either house shall violate a  
25 joint rule, the question of order may be raised in the other house, and  
26 decided in the same manner as in case of a violation of the rules of such  
27 house.  
28

#### 29                           **Appropriation Bills**

30           Section 15. The general appropriation bill, and all appropriation  
31 bills recommended "do pass" by the Joint Budget Committee, shall be  
32 privileged bills advanced upon the calendar, and take precedence over all  
33 other bills at any time after the reading of the Journal. It shall be in  
34 order, by the direction of the appropriate committee, to move that the House  
35 or Senate (as the case may be) resolve itself into the committee of the whole  
36 house for the purpose of considering the general appropriation bill, and no

1 dilatory motion shall be entertained by the presiding officer.

2  
3 **Deadline for the Introduction of Bills**

4 Section 16. (A) No appropriation bill shall be filed for introduction  
5 in either the House of Representatives or the Senate later than the fiftieth  
6 (50th) day of a regular session except upon consent of two-thirds (2/3) of  
7 the members elected to each house; and, no other bill shall be filed for  
8 introduction in either the House of Representatives or the Senate later than  
9 the fifty-fifth (55th) day of a regular session, except upon consent of two-  
10 thirds (2/3) of the members elected to each house. When the filing deadline  
11 for any bills or resolutions ends on Saturday or Sunday, the deadline is  
12 hereby extended until the close of business the following Monday.

13 (B) Any proposed legislation affecting any publicly supported  
14 retirement system or pension plan to be considered by the General Assembly at  
15 a regular session shall be introduced in the General Assembly during the  
16 first fifteen (15) calendar days of a regular biennial session.

17 (C) No such bill shall be introduced after the fifteenth (15th) day of  
18 a regular biennial session unless its introduction is first approved by a  
19 three-fourths (3/4) vote of the full membership of each house of the General  
20 Assembly.

21 (D) A bill affecting any publicly supported retirement system or  
22 systems shall not be introduced or considered at any special session of the  
23 General Assembly unless the introduction and consideration of the bill is  
24 first approved by a three-fourths (3/4) vote of the full membership of each  
25 house of the General Assembly. (*Arkansas Code § 10-2-115*)

26  
27 **Introduction of Health Care Legislation**

28 Section 17. (A) Any proposed legislation affecting the licensure of  
29 any profession, occupation, or class of health care providers not currently  
30 licensed, or expanding the scope of practice of any profession, occupation,  
31 or class of health care providers to be considered by the General Assembly at  
32 a regular biennial session shall be introduced in the General Assembly during  
33 the first fifteen (15) calendar days of a regular biennial session.

34 (B) No such bill shall be introduced after the fifteenth (15th ) day  
35 of a regular biennial session unless its introduction is first approved by a  
36 three-fourths (3/4) vote of the full membership of each house of the General

1 Assembly.

2 (C) The Senate and the House, and committees of the Senate and House,  
3 shall take no action on any such bill for an additional fifteen (15) calendar  
4 days after the fifteen (15) calendar day deadline for introduction of such  
5 bills has passed.

#### Method of Preparing Bills

8

#### and Resolutions - Automated Bill Preparation System

9 Section 18. (A) No bill or resolution, as defined herein, shall be  
10 accepted for introduction by clerks of the Senate or of the House of  
11 Representatives unless such bill or resolution has been prepared for  
12 introduction by an automated bill preparation system developed by the Bureau  
13 of Legislative Research.

14 (1) The Bureau of Legislative Research shall establish and  
15 operate, in cooperation with the appropriate officials of the House of  
16 Representatives and the Senate, an automated bill preparation system in which  
17 all bills and resolutions, as defined herein, shall be prepared for  
18 introduction. Such system shall be designed in a manner which will permit  
19 either or both houses of the General Assembly to install compatible and  
20 interconnecting electronic equipment for the preparation of bills and  
21 resolutions in the same format as prepared by the Bureau of Legislative  
22 Research for introduction in either house of the General Assembly.

23 (2) The Bureau of Legislative Research shall provide the  
24 Secretary of the Senate and the Chief Clerk of the House of Representatives  
25 access by electronic medium to the central bill files in which bills and  
26 resolutions recorded in the automated bill preparation system are stored, to  
27 enable the engrossing rooms of the respective houses to have ready access  
28 thereto for enrollment of engrossed amendments adopted to such bills and  
29 resolutions.

30 (3) As used herein:

31 (a) "resolutions" shall mean all resolutions prepared for  
32 introduction which require the concurrence of both houses of the General  
33 Assembly for the adoption thereof, and shall include resolutions prepared for  
34 consideration by only the house in which introduced;

35 (b) "automated bill preparation system" shall mean an  
36 automated system using word processors, computers, or other electronic

1 devices for the typing and preparation of bills and resolutions (as defined  
2 herein) for introduction by members of the General Assembly in either the  
3 Senate or the House of Representatives, and shall include the following  
4 features:

5 (i) a separate identification number, to be placed  
6 upon each page of the original and each copy thereof prepared for  
7 introduction in the General Assembly;

8 (ii) a method of electronically recording the  
9 contents of each bill and resolution for ready access for retrieval and  
10 engrossment purposes;

11 (iii) security features to protect the automated  
12 bill preparation files from access by unauthorized persons, and to maintain  
13 the integrity and confidentiality of drafts of bills and resolutions prepared  
14 by the Bureau of Legislative Research for members of the General Assembly  
15 which have not been filed for introduction; and

16 (iv) such other features as deemed to be necessary and  
17 advisable by the Bureau of Legislative Research after consulting with the  
18 appropriate officials of the House of Representatives and the Senate.

19 (B) All bills and resolutions introduced in the House and Senate shall  
20 be prepared on 8 1/2 x 11 inch paper. A computer generated original and  
21 eight (8) copies of the bill or resolution, or a photocopy of an original  
22 computer generated copy with eight (8) additional copies thereof, shall be  
23 prepared for introduction. The original computer generated copy shall be  
24 placed in the manuscript cover provided for the official copy of bills or  
25 resolutions and a photocopy of the computer generated original shall be  
26 placed in the manuscript cover provided for the duplicate copy, with the  
27 eight (8) copies thereof to be attached thereto in such manner as may be  
28 prescribed by the respective houses. In addition, eight (8) copies of the  
29 caption on each bill or resolution shall be prepared and attached thereto at  
30 the time of introduction.

31 (C) Upon the introduction of each bill and resolution, the appropriate  
32 clerks of the respective houses shall cause the original signed copy thereof  
33 (which is contained in the official bill or resolution manuscript cover) to  
34 be identified as the official copy by perforation or stamping on the left  
35 margin of each page thereof the words "HOUSE ORIGINAL" to be placed on each  
36 official original copy of House bills and resolutions, and the words "SENATE

1 ORIGINAL” to be placed on the left margin of each official original copy of  
2 Senate bills and resolutions. Whenever any bill or resolution is amended,  
3 the engrossed page or pages thereof shall be perforated in the same manner as  
4 the original introduced copy. Only the original signed copy of a bill or  
5 resolution and engrossed pages thereof shall be perforated or stamped as  
6 provided herein.

7 (D) If any person shall unlawfully perforate any fraudulent or  
8 counterfeit copy of any bill or resolution for the purpose of intentionally  
9 inserting in any bill or resolution any page or provision thereof for the  
10 purpose of altering the bill or resolution as introduced, such person shall  
11 be in contempt of the House or Senate, or both House and Senate, and shall be  
12 punished accordingly. If any person shall make any alteration, change or  
13 erasure in any original copy of a bill or resolution as originally  
14 introduced, except upon direction of the House or Senate, or both House and  
15 Senate, or upon direction of the appropriate committees on engrossed or  
16 enrolled bills, such person shall be in contempt of the House or Senate, or  
17 both of them and shall be punished accordingly. In addition, such person  
18 shall be subject to such fine and imprisonment as may be imposed by the laws  
19 of this State for fraud.

20 (E)(1) Only bills and amendments to bills which meet the requirements  
21 of this subsection (E) may be introduced into the Senate or the House of  
22 Representatives.

23 (2) Except as provided in subsections (E)(5), (6) and (8), all  
24 bills and amendments to bills shall reflect the changes proposed in the  
25 existing law by:

26 (a) over striking all language of the existing law which  
27 is proposed to be deleted; and

28 (b) underlining all new language proposed to be added to  
29 the existing law. At the top of the first page of the bill shall appear  
30 language substantially similar to the following: “Stricken language would be  
31 deleted from present law. Underlined language would be added to present  
32 law.”

33 (3) Except as provided in subsections (E)(5), (6) and (8), all  
34 resolutions proposing amendments to the Arkansas Constitution and amendments  
35 to resolutions shall reflect the changes proposed in the existing  
36 Constitution by:



1 (a) over striking all language of the existing Constitution  
2 which is proposed to be deleted; and

3 (b) underlining all new language proposed to be added to  
4 the existing Constitution. At the top of the first page of the bill shall  
5 appear language substantially similar to the following: "Stricken language  
6 would be deleted from the present Constitution. Underlined language would be  
7 added to present Constitution."

8 (4) Except as provided in subsections (E)(5), (6) and (8), all  
9 resolutions proposing changes in the rules of the Senate or House or the  
10 joint rules of the Senate and House shall reflect the changes proposed in the  
11 existing rule by:

12 (a) over striking all language of the existing rule which  
13 is proposed to be deleted; and

14 (b) underlining all new language proposed to be added to  
15 the existing rule. At the top of the first page of the resolution shall  
16 appear language substantially similar to the following: "Stricken language  
17 would be deleted from present rule. Underlined language would be added to  
18 present rule."

19 (5) This subsection (E) may be waived by the President Pro  
20 Tempore of the Senate or in his absence, the Chairman of the Senate Rules  
21 Committee, or the Speaker of the House of Representatives.

22 (6) Markups are not required of the following:

23 (a) appropriation sections, state agencies regular salary  
24 sections, and state agencies extra help sections contained within a bill if  
25 the sections do not specifically amend existing law;

26 (b) sections which allocate funds within the Revenue  
27 Stabilization Law or within the General Improvement Fund Distribution Law;  
28 and

29 (c) sections which amend Arkansas Code §§ 21-5-208(b) and  
30 21-5-209(e).

31 (7) It shall be the duty of the Chairman of the Joint Budget  
32 Committee to have a schedule prepared which reflects the amounts approved by  
33 the Joint Budget Committee for each category for each fund within the Revenue  
34 Stabilization Law to provide funding for the biennial budget enacted by the  
35 General Assembly and a schedule reflecting the proposed distribution of  
36 General Improvement funds. The schedule reflecting the allocation of funds

1 in the Revenue Stabilization Law and the General Improvement Fund  
2 Distribution Law for the next biennium shall be submitted to each body of the  
3 Arkansas General Assembly at least three (3) days prior to the day at which  
4 the same is to be considered for final passage.

5 (8) Markups are not required on sections that are substantially  
6 the same as the following boiler-plate sections:

7  
8 "SECTION. COMPLIANCE WITH OTHER LAWS. Disbursement of  
9 funds authorized by this Act shall be limited to the appropriation for such  
10 agency and funds made available by law for the support of such  
11 appropriations; and the restrictions of the State Purchasing Law, the General  
12 Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the  
13 Regular Salary Procedures and Restrictions Act, the Higher Education  
14 Expenditure Restrictions Act, where applicable, and regulations promulgated  
15 by the Department of Finance and Administration, as authorized by law, shall  
16 be strictly complied with in disbursement of said funds.

17  
18 SECTION. EMPLOYMENT OF ATTORNEYS. None of the funds  
19 appropriated in this Act for Maintenance and General Operation shall be  
20 expended in payment for services of attorneys, unless the agency shall first  
21 make a request in writing to the Attorney General of the State of Arkansas to  
22 provide the required legal services. The Attorney General's Office shall  
23 provide the required legal services, or, if the Attorney General's Office  
24 shall determine that sufficient personnel are not available to provide the  
25 requested legal services, the Attorney General shall certify the same to the  
26 agency and may authorize the agency to employ legal counsel and to expend  
27 monies appropriated for Maintenance and General Operations thereof, if:

28 (1) The Attorney General determines, and certifies in  
29 writing, that such agency needs the advice or assistance of legal counsel,  
30 and

31 (2) The Attorney General consents in writing to the  
32 employment of the legal counsel to be retained by the agency.

33 Such certification shall be required with respect to each  
34 instance of the employment of special legal counsel, or shall be required  
35 annually with respect to legal counsel employed on a retainer basis. A copy  
36 of such certification shall be entered in the official minutes of the agency,

1 and shall be retained in the fiscal records of the agency for audit purposes.

2  
3 SECTION. DISBURSEMENT CONTROLS. (A) No contract may be  
4 awarded nor obligations otherwise incurred in relation to the project or  
5 projects described herein in excess of the State Treasury funds actually  
6 available therefor as provided by law. Provided, however, that institutions  
7 and agencies listed herein shall have the authority to accept and use grants  
8 and donations including Federal funds, and to use its unobligated cash income  
9 or funds, or both available to it, for the purpose of supplementing the State  
10 Treasury funds for financing the entire costs of the project or projects  
11 enumerated herein. Provided further, that the appropriations and funds  
12 otherwise provided by the General Assembly for Maintenance and General  
13 Operations of the agency or institutions receiving appropriation herein shall  
14 be not be used for any of the purposes as appropriated in this Act.

15 (B) The restrictions of any applicable provisions of  
16 the State Purchasing Law, the General Accounting and Budgetary Procedures  
17 Law, the Revenue Stabilization Law and any other applicable fiscal control  
18 laws of this State and regulations promulgated by the Department of Finance  
19 and Administration, as authorized by law, shall be strictly complied with in  
20 disbursement of any funds provided by this Act unless specifically provided  
21 otherwise by law.

22  
23 SECTION. LEGISLATIVE INTENT. It is the intent of the  
24 General Assembly that any funds disbursed under the authority of the  
25 appropriations contained in this Act shall be in compliance with the stated  
26 reasons for which this Act was adopted, as evidenced by the Agency Requests,  
27 Executive Recommendations and Legislative Recommendations contained in the  
28 budget manuals prepared by the Department of Finance and Administration,  
29 letters, or summarized oral testimony in the official minutes of the Arkansas  
30 Legislative Council or Joint Budget Committee which relate to its passage and  
31 adoption.

32  
33 SECTION. GENERAL REPEALER. All laws and parts of law in  
34 conflict with this act are hereby repealed.”

35 Section 19. (A) Once a Senate bill has passed the House of  
36 Representatives and returned to the Senate, it may not be subsequently

1 amended in the Senate unless the House expunges the vote by which it passed  
2 the bill and any amendments to the bill and the Senate expunges the vote by  
3 which the bill was passed and places the bill on second reading.

4 (B) Once a House bill has passed the Senate and has been returned to  
5 the House, it may not be subsequently amended in the House unless the Senate  
6 expunges the vote by which it passed the bill and any amendments to the bill  
7 and the House expunges the vote by which the bill was passed and places the  
8 bill on second reading.

#### 9 10 **Submission of Bills to Governor**

11 Section 20. Whenever any Senate bill shall be approved by the House of  
12 Representatives and enrolled by the Senate, the Secretary of the Senate or  
13 one of his or her authorized agents shall without delay, deliver the same to  
14 the Governor or his or her designated representative and take receipt  
15 thereof, which receipt shall be returned to the Senate and entered in the  
16 Journal. Whenever any House bill shall be approved by the Senate and  
17 enrolled by the House, the Chief Clerk of the House or one of his or her  
18 authorized agents shall, without delay, deliver the same to the Governor or  
19 his or her designated representative and take receipt thereof, which receipt  
20 shall be returned to the House and entered in the Journal. In the event the  
21 Governor, or his or her designated representative, shall refuse to accept  
22 delivery of any such bill, the Secretary of the Senate, or the Chief Clerk of  
23 the House, or their designated agents, as the case may be, shall forthwith  
24 serve the same by handing the bill to either the Governor or to any employee  
25 of the Governor's office, and shall return a certificate to the Senate or the  
26 House as the case may be, of the date and time of such delivery and of the  
27 name of the person to whom delivered and such certificate shall be entered in  
28 the Journal of the Senate or the Journal of the House, as the case may be,  
29 and shall constitute proof of delivery of said bill to the Governor in  
30 determining the period of time in which the Governor has to sign the same or  
31 return it to the Senate or the House with his veto as provided in the  
32 Constitution of the State of Arkansas.

#### 33 34 **Joint Committee on Constitutional Amendments**

35 Section 21. The Joint Committee on Constitutional Amendments shall  
36 consist of the members of the Senate Committee on State Agencies and

1 Governmental Affairs and the members of the House Committee on State Agencies  
2 and Governmental Affairs. No proposed constitutional amendment shall be  
3 recommended to either house of the General Assembly except upon the  
4 affirmative vote of a majority of the Senate members of the Joint Committee  
5 on Constitutional Amendments and an affirmative vote of a majority of the  
6 House members of the Joint Committee on Constitutional Amendments. No  
7 resolution proposing a constitutional amendment shall be filed in either the  
8 House of Representatives or the Senate after the thirty-first (31st) day of  
9 each regular session of the General Assembly. All resolutions proposing  
10 constitutional amendments shall be referred to the Joint Committee on  
11 Constitutional Amendments. Other resolutions proposing constitutional  
12 amendments shall not be reported to or considered by either house of the  
13 General Assembly until the original recommendations of the Joint Committee on  
14 Constitutional Amendments are disposed of by both Houses.

#### 15 16 **Joint Meetings of Senate and House Committees**

17 Section 22. The standing and select Committees of the Senate and the  
18 House of Representatives are authorized to hold joint meetings upon call of  
19 the Chairpersons of the two committees involved or by one-half (1/2) or more  
20 of the members of both committees involved.

#### 21 22 **Correction of Obvious Errors**

23 Section 23. The Secretary of the Senate and the Chief Clerk of the  
24 House are authorized, subject to approval by the appropriate designated  
25 committee, to correct obvious errors occurring in documents originating in  
26 the House and the Senate respectively, provided that each such correction is  
27 noted on the bill jacket and is documented by a "correction note" at the end  
28 of the official daily journal for the date on which the correction was made.

#### 29 30 **Assigning Bill and Resolution Numbers**

31 Section 24. In assigning numbers to bills and resolutions introduced  
32 in the Senate and House of Representatives, Senate bills and resolutions  
33 shall be numbered commencing with the figure 1, and House bills and  
34 resolutions shall be assigned numbers commencing with the figure 1001.

#### 35 36 **Prefiling of Bills and Resolutions**

1           Section 25. Beginning on November 15th of each year preceding a  
2 regular session of the General Assembly, each holdover member of the Senate  
3 who will be serving at the next following regular session of the General  
4 Assembly, and each member-elect of the General Assembly, as soon as the  
5 members-elect of the next General Assembly are certified to the Secretary of  
6 State, shall be permitted to prefile bills and resolutions for such regular  
7 session with the Chief Clerk of the House and the Secretary of the Senate.  
8 (Arkansas Code § 10-2-112)

9  
10                                   **Succession to the Powers of Governor**

11           Section 26. (A) It is recognized that no Rule can amend the  
12 Constitution; therefore, it is the intent of this Rule to provide for the  
13 President Pro Tempore and Speaker of the House to exercise gubernatorial  
14 powers sparingly or under only extraordinary circumstances.

15           (B) Neither the President Pro Tempore of the Senate nor the Speaker of  
16 the House shall exercise the powers of the Governor unless he or she succeeds  
17 to the powers of the Governor because of a vacancy in both the office of  
18 Governor and Lieutenant Governor, the disability of both officers, or a  
19 vacancy in one office and the disability of the other officer.

20           (C) (1) For the purpose of this section a disability shall be  
21 considered to exist only if:

22                                   (a) The Governor or Lieutenant Governor transmits to the  
23 President Pro Tempore of the Senate and the Speaker of the House of  
24 Representatives his or her written declaration that he or she is unable to  
25 discharge the powers and duties of his or her office; or

26                                   (b) A Majority of the constitutional officers of the  
27 Executive Department of this State transmit to the President Pro Tempore of  
28 the Senate and the Speaker of the House of Representatives their written  
29 declaration that the Governor or Lieutenant Governor is unable to discharge  
30 the powers and duties of his or her office.

31                                   (2) A disability shall cease upon the officer transmitting to  
32 the President Pro Tempore of the Senate and the Speaker of the House of  
33 Representatives his or her written declaration that no disability exists.

34           (D) If the Speaker of the House of Representatives exercises the  
35 powers of the Governor in violation of this Rule, he or she may be removed  
36 from the office of Speaker of the House upon a majority vote of the House.

1 If the President Pro Tempore of the Senate exercises powers of the Governor  
2 in violation of this Rule, he or she may be removed from the office of  
3 President Pro Tempore of the Senate upon a majority vote of the Senate.
