22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES - REVENUE SERVICES DIVISION. There is

 13 authorized, for the Department of Finance and Administration - Revenue
 14 Services Division for the 2012-2013 fiscal year, the following maximum number

8 receipts taxes paid upon tickets to athletic events pursuant to Arkansas Code
9 26-52-511 and for other purposes as authorized by law for the fiscal year

17 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
19 APPROPRIATION TRANSFERS. The Director of the Department of Finance and
20 Administration is authorized to transfer appropriation between refund line
21 item appropriations in this Act. The Director of the Department of Finance
22 and Administration shall immediately report any such transfers to the
23 Arkansas Legislative Council. Such report shall contain the amounts
24 transferred and the reasons for the same.

25 The provisions of this section shall be in effect only from July 1, ~~2011~~
26 2012 through June 30, ~~2012~~ 2013.

27
28 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
30 HELP EXEMPTION. Extra Help positions authorized herein are specifically
31 exempt from limitation of hours, either by act or regulation. Provided,
32 however, when a temporary or part-time employee is employed by the Department
33 of Finance and Administration - Revenue Services for a period of time
34 exceeding seven (7) months, a report of such shall be filed with the Arkansas
35 Legislative Council.

36 The provisions of this section shall be in effect only from July 1,

1 ~~2011~~ 2012 through June 30, ~~2012~~ 2013.

3 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. AUTHORITY
5 TO EMPLOY CERTIFIED LAW ENFORCEMENT OFFICERS. The Director of the Department
6 of Finance and Administration is authorized to employ not more than one (1)
7 certified law enforcement officer as certified under § 12-9-101 et seq. The
8 certified law enforcement officer employed under this section shall be
9 responsible for maintaining order and providing for the security, protection,
10 and safety of Department buildings, grounds, property, employees and
11 customers. The certified law enforcement officer shall have the powers,
12 duties, privileges, and immunities of a certified law enforcement officer.
13

14 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

16 CONTINGENT POSITIONS. There is hereby established for the Department of
17 Finance and Administration - Revenue Division - Contingent Positions for the
18 ~~2011-2012~~ 2012-2013 fiscal year, the following maximum number of regular
19 employees whose salaries shall be governed by the provisions of the Uniform
20 Classification and Compensation Act (Arkansas Code 21-5-201 et seq.), or its
21 successor, and all laws amendatory thereto. All persons occupying positions
22 authorized herein are hereby governed by the provisions of the Regular
23 Salaries Procedures and Restrictions Act (Arkansas Code 21-5-101), or its
24 successor.

34 If it has been determined by the Director of the Department of Finance and
35 Administration that the Department cannot continue a contract with a private
36 provider and the Director deems it necessary to utilize Department staff to

1 provide the required services, the Department is allowed, after seeking prior
2 review by the Arkansas Legislative Council or Joint Budget Committee, to
3 utilize the contingent positions for data entry contained in this Section and
4 make the appropriate transfers from the various Maintenance and Operations,
5 Professional Fees and Services or Data Processing line items contained in
6 Section 3 of this Act to Regular Salaries and Personal Services Matching.

7
8 SECTION 14. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
9 authorized by this act shall be limited to the appropriation for such agency
10 and funds made available by law for the support of such appropriations; and
11 the restrictions of the State Procurement Law, the General Accounting and
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
13 Procedures and Restrictions Act, or their successors, and other fiscal
14 control laws of this State, where applicable, and regulations promulgated by
15 the Department of Finance and Administration, as authorized by law, shall be
16 strictly complied with in disbursement of said funds.

17
18 SECTION 15. LEGISLATIVE INTENT. It is the intent of the General
19 Assembly that any funds disbursed under the authority of the appropriations
20 contained in this act shall be in compliance with the stated reasons for
21 which this act was adopted, as evidenced by the Agency Requests, Executive
22 Recommendations and Legislative Recommendations contained in the budget
23 manuals prepared by the Department of Finance and Administration, letters, or
24 summarized oral testimony in the official minutes of the Arkansas Legislative
25 Council or Joint Budget Committee which relate to its passage and adoption.

26
27 SECTION 16. EMERGENCY CLAUSE. It is found and determined by the
28 General Assembly, that the Constitution of the State of Arkansas prohibits
29 the appropriation of funds for more than a one (1) year period; that the
30 effectiveness of this Act on July 1, 2012 is essential to the operation of
31 the agency for which the appropriations in this Act are provided, and that in
32 the event of an extension of the legislative session, the delay in the
33 effective date of this Act beyond July 1, 2012 could work irreparable harm
34 upon the proper administration and provision of essential governmental
35 programs. Therefore, an emergency is hereby declared to exist and this Act
36 being necessary for the immediate preservation of the public peace, health

and safety shall be in full force and effect from and after July 1, 2012.
