## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
9 SERVICES AND OPERATING EXPENSES FOR THE STATE  
10 ATHLETIC COMMISSION FOR THE FISCAL YEAR ENDING  
11 JUNE 30, 2013; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE STATE ATHLETIC COMMISSION  
15 APPROPRIATION FOR THE 2012-2013 FISCAL  
16 YEAR.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. EXTRA HELP. There is hereby authorized, for the State  
23 Athletic Commission for the 2012-2013 fiscal year, the following maximum  
24 number of part-time or temporary employees, to be known as "Extra Help",  
25 payable from funds appropriated herein for such purposes: one (1) temporary  
26 or part-time employees, when needed, at rates of pay not to exceed those  
27 provided in the Uniform Classification and Compensation Act, or its  
28 successor, or this act for the appropriate classification.  
29

30 SECTION 2. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
31 to the State Athletic Commission, to be payable from the Arkansas Athletic  
32 Commission Fund, for personal services and operating expenses of the State  
33 Athletic Commission for the fiscal year ending June 30, 2013, the following:

12         SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 13 authorized by this act shall be limited to the appropriation for such agency  
 14 and funds made available by law for the support of such appropriations; and  
 15 the restrictions of the State Procurement Law, the General Accounting and  
 16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 17 Procedures and Restrictions Act, or their successors, and other fiscal  
 18 control laws of this State, where applicable, and regulations promulgated by  
 19 the Department of Finance and Administration, as authorized by law, shall be  
 20 strictly complied with in disbursement of said funds.

22         SECTION 4. LEGISLATIVE INTENT. It is the intent of the General  
 23 Assembly that any funds disbursed under the authority of the appropriations  
 24 contained in this act shall be in compliance with the stated reasons for  
 25 which this act was adopted, as evidenced by the Agency Requests, Executive  
 26 Recommendations and Legislative Recommendations contained in the budget  
 27 manuals prepared by the Department of Finance and Administration, letters, or  
 28 summarized oral testimony in the official minutes of the Arkansas Legislative  
 29 Council or Joint Budget Committee which relate to its passage and adoption.

31         SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General  
 32 Assembly, that the Constitution of the State of Arkansas prohibits the  
 33 appropriation of funds for more than a one (1) year period; that the  
 34 effectiveness of this Act on July 1, 2012 is essential to the operation of  
 35 the agency for which the appropriations in this Act are provided, and that in  
 36 the event of an extension of the legislative session, the delay in the

1 effective date of this Act beyond July 1, 2012 could work irreparable harm  
2 upon the proper administration and provision of essential governmental  
3 programs. Therefore, an emergency is hereby declared to exist and this Act  
4 being necessary for the immediate preservation of the public peace, health  
5 and safety shall be in full force and effect from and after July 1, 2012.
