7 **HOUSE CONCURRENT RESOLUTION**

8 TO AUTHORIZE THE INTRODUCTION OF A NONAPPROPRIATION  
9 BILL TO REPEAL ACTS 2011, NO. 1058, THAT EXEMPTED  
10 FROM THE SALES AND USE TAX THE GROSS RECEIPTS DERIVED  
11 FROM THE SALE OF CLASS SIX AND CLASS SEVEN TRUCKS IF  
12 THE VEHICLE IS REGISTERED WITH THE INTERNATIONAL  
13 REGISTRATION PLAN AND ENGAGED IN INTERSTATE COMMERCE;  
14 THAT EXEMPTED FROM THE SALES AND USE TAX THE GROSS  
15 RECEIPTS DERIVED FROM THE SALE OF ALL SEMITRAILERS;  
16 THAT OFFSET GENERAL REVENUES LOST AS A RESULT OF THE  
17 EXEMPTION WITH REVENUES FROM DISTILLATE MOTOR FUEL  
18 TAXES; AND FOR OTHER PURPOSES.

22 TO AUTHORIZE THE INTRODUCTION OF A  
23 NONAPPROPRIATION BILL TO REPEAL ACTS  
24 2011, NO. 1058, THAT EXEMPTED FROM THE  
25 SALES AND USE TAX THE GROSS RECEIPTS  
26 DERIVED FROM THE SALE OF CERTAIN TRUCKS  
27 AND SEMITRAILERS.

30 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-EIGHTH GENERAL  
31 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

33 THAT Speaker Moore is authorized to introduce a bill which, as introduced,  
34 will read substantially as follows:

36 "For An Act To Be Entitled



1 TO REPEAL ACTS 2011, NO. 1058, THAT EXEMPTED FROM THE SALES AND USE TAX THE  
2 GROSS RECEIPTS DERIVED FROM THE SALE OF CLASS SIX AND CLASS SEVEN TRUCKS IF  
3 THE VEHICLE IS REGISTERED WITH THE INTERNATIONAL REGISTRATION PLAN AND  
4 ENGAGED IN INTERSTATE COMMERCE; THAT EXEMPTED FROM THE SALES AND USE TAX THE  
5 GROSS RECEIPTS DERIVED FROM THE SALE OF ALL SEMITRAILERS; THAT OFFSET GENERAL  
6 REVENUES LOST AS A RESULT OF THE EXEMPTION WITH REVENUES FROM DISTILLATE  
7 MOTOR FUEL TAXES; AND FOR OTHER PURPOSES.

9 Subtitle

10 TO REPEAL ACTS 2011, NO. 1058, THAT EXEMPTED FROM THE SALES AND USE TAX THE  
11 GROSS RECEIPTS DERIVED FROM THE SALE OF CERTAIN TRUCKS AND SEMITRAILERS AND  
12 THAT OFFSET GENERAL REVENUES LOST AS A RESULT OF THE EXEMPTION.

13  
14 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

15  
16 SECTION 1. DO NOT CODIFY. Purpose. The purpose of this act is to  
17 repeal Acts 2011, No. 1058, that would have become effective July 1, 2012.  
18 Consequently, the Arkansas Code Sections amended by Acts 2011, No. 1058,  
19 shall remain in effect as if Acts 2011, No. 1058, had not been enacted by the  
20 General Assembly.

22 SECTION 2. DO NOT CODIFY. Acts 2011, No. 1058, is repealed."
