## For An Act To Be Entitled

8 AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
9 IMPROVEMENT APPROPRIATIONS FOR THE INSTITUTIONS  
10 OF HIGHER EDUCATION AND THE DEPARTMENT OF HIGHER  
11 EDUCATION; AND FOR OTHER PURPOSES.

## Subtitle

14 AN ACT FOR THE INSTITUTIONS OF HIGHER  
15 EDUCATION AND THE DEPARTMENT OF HIGHER  
16 EDUCATION; REAPPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REAPPROPRIATION - HENDERSON STATE UNIVERSITY. There is  
23 hereby appropriated, to the Henderson State University, to be payable from  
24 the General Improvement Fund or its successor fund or fund accounts, for the  
25 Henderson State University the following:

26 (A) Effective July 1, 2012, the balance of the appropriation provided  
27 in Item (A) Section 1 of Act 445 of 2011, for equipment, personal services,  
28 maintenance and operating expenses, and grants of the Rural Entrepreneurial  
29 Initiative and for construction, acquisition, renovation, furnishing,  
30 personal services, maintenance and equipment, in a sum not to exceed  
31 .....\$2,000,000.

32 (B) Effective July 1, 2012, the balance of the appropriation provided  
33 in Item (A) Section 7 of Act 709 of 2011, for Phase I campus renovations, in  
34 a sum not to exceed.....\$2,200,000.

35 (C) Effective July 1, 2012, the balance of the appropriation provided  
36 in Item (B) Section 7 of Act 709 of 2011, for local area network



1 infrastructure, in a sum not to exceed.....\$800,000.

2 (D) Effective July 1, 2012, the balance of the appropriation provided  
3 in Item (C) Section 7 of Act 709 of 2011, for deferred maintenance, in a sum  
4 not to exceed.....\$1,330,000.

5 (E) Effective July 1, 2012, the balance of the appropriation provided  
6 in Item (D) Section 7 of Act 709 of 2011, for replacement and renewal of  
7 equipment and library holdings, in a sum not to exceed.....\$620,000.

9 SECTION 2. REAPPROPRIATION - SOUTHERN ARKANSAS UNIVERSITY. There is  
10 hereby appropriated, to the Southern Arkansas University, to be payable from  
11 the General Improvement Fund or its successor fund or fund accounts, for the  
12 Southern Arkansas University the following:

13 (A) Effective July 1, 2012, the balance of the appropriation provided  
14 in Item (A) Section 8 of Act 709 of 2011, for construction of a University  
15 Agriculture Center, in a sum not to exceed.....\$1,100,000.

16 (B) Effective July 1, 2012, the balance of the appropriation provided  
17 in Item (B) Section 8 of Act 709 of 2011, for technology upgrades, in a sum  
18 not to exceed.....\$1,000,000.

19 (C) Effective July 1, 2012, the balance of the appropriation provided  
20 in Item (C) Section 8 of Act 709 of 2011, for renovation of the Bruce Center,  
21 in a sum not to exceed.....\$400,000.

22 (D) Effective July 1, 2012, the balance of the appropriation provided  
23 in Item (D) Section 8 of Act 709 of 2011, for deferred maintenance, in a sum  
24 not to exceed.....\$1,410,000.

25 (E) Effective July 1, 2012, the balance of the appropriation provided  
26 in Item (E) Section 8 of Act 709 of 2011, for replacement and renewal of  
27 equipment and library holdings, in a sum not to exceed.....\$510,000.

28 (F) Effective July 1, 2012, the balance of the appropriation provided  
29 in Item (A) Section 2 of Act 766 of 2011, for construction of a University  
30 Agriculture Center, in a sum not to exceed.....\$1,000,000.

31 (G) Effective July 1, 2012, the balance of the appropriation provided  
32 in Item (D) Section 2 of Act 766 of 2011, for constructing, equipping,  
33 personal services, maintenance and operating expenses of a Natural Resources  
34 Research Center for research of lignite and other natural resources in the  
35 State, in a sum not to exceed.....\$75,000.

36 (H) Effective July 1, 2012, the balance of the appropriation provided

1 in Item (E) Section 2 of Act 766 of 2011, for construction/renovation/  
2 maintenance/critical maintenance/equipment/library resources, in a sum not to

4 (I) Effective July 1, 2012, the balance of the appropriation provided  
5 in Item (F) Section 2 of Act 766 of 2011, for expenses of a lignite  
6 feasibility study, in a sum not to exceed.....\$32,194.

7 (J) Effective July 1, 2012, the balance of the appropriation provided  
8 in Item (G) Section 2 of Act 766 of 2011, for critical maintenance/equipment  
9 /library resources, in a sum not to exceed.....\$38,787.

19 programs, in a sum not to exceed.....\$500,000.

20 (B) Effective July 1, 2012, the balance of the appropriation provided  
21 in Item (A) Section 1 of Act 361 of 2011, for the ASU - Searcy main building  
22 renovation, in a sum not to exceed.....\$1,000,000.

23 (C) Effective July 1, 2012, the balance of the appropriation provided  
24 in Item (A) Section 2 of Act 361 of 2011, for lighting and mechanical system  
25 upgrades at the ASU - Beebe campus, in a sum not to exceed.....\$500,000.

26 (D) Effective July 1, 2012, the balance of the appropriation provided  
27 in Item (A) Section 3 of Act 709 of 2011, for renovation of the ASU-Searcy  
28 Main Building, in a sum not to exceed.....\$1,000,000.

29 (E) Effective July 1, 2012, the balance of the appropriation provided

13 SECTION 24. REAPPROPRIATION - DEPARTMENT OF HIGHER EDUCATION - GENERAL  
14 IMPROVEMENT. There is hereby appropriated, to the Department of Higher  
15 Education, to be payable from the General Improvement Fund or its successor  
16 fund or fund accounts, for the Department of Higher Education the following:

17 (A) Effective July 1, 2012, the balance of the appropriation provided  
18 in Item (A) Section 1 of Act 709 of 2011, for various maintenance,  
19 renovation, equipping, construction, acquisition, improvement, upgrade, and  
20 repair of real property and facilities for all public four-year institutions,  
21 two-year institutions, and technical colleges, in a sum not to exceed  
22 .....\$5,000,000.

23 (B) Effective July 1, 2012, the balance of the appropriation provided  
24 in Item (C) Section 20 of Act 766 of 2011, for grants for scholarships for  
25 Historically Black Colleges and Universities and for personal services and

30 SECTION 25. REAPPROPRIATION - DEPARTMENT OF HIGHER EDUCATION - TRUST -  
31 COLLEGE SAVINGS OBLIGATION. There is hereby appropriated, to the Department  
32 of Higher Education, to be payable from the Higher Education Projects  
33 Development Fund, for the Department of Higher Education the following:

34 (A) Effective July 1, 2012, the balance of the appropriation provided  
35 in Item (A) Section 21 of Act 766 of 2011, for the development of projects at

4 SECTION 26. REAPPROPRIATION - DEPARTMENT OF HIGHER EDUCATION - TRUST -  
5 COLLEGE SAVINGS BOND. There is hereby appropriated, to the Department of  
6 Higher Education, to be payable from the Higher Education Projects  
7 Development Fund, for the Department of Higher Education the following:

8 (A) Effective July 1, 2012, the balance of the appropriation provided  
9 in Item (A) Section 21 of Act 766 of 2011, for the development of projects at  
10 State Institutions of Higher Education and the payment of project costs and  
11 expenses of the issuance of bonds of the Arkansas College Savings General  
12 Obligation Bonds Program, in a sum not to exceed.....\$3,050,209.

13  
14 SECTION 27. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
15 obligations otherwise incurred in relation to the project or projects  
16 described herein in excess of the State Treasury funds actually available  
17 therefor as provided by law. Provided, however, that institutions and  
18 agencies listed herein shall have the authority to accept and use grants and  
19 donations including Federal funds, and to use its unobligated cash income or  
20 funds, or both available to it, for the purpose of supplementing the State  
21 Treasury funds for financing the entire costs of the project or projects  
22 enumerated herein. Provided further, that the appropriations and funds  
23 otherwise provided by the General Assembly for Maintenance and General  
24 Operations of the agency or institutions receiving appropriation herein shall  
25 not be used for any of the purposes as appropriated in this act.

26 (B) The restrictions of any applicable provisions of the State  
27 Purchasing Law, the General Accounting and Budgetary Procedures Law, the  
28 Revenue Stabilization Law and any other applicable fiscal control laws of  
29 this State and regulations promulgated by the Department of Finance and  
30 Administration, as authorized by law, shall be strictly complied with in  
31 disbursement of any funds provided by this act unless specifically provided

34 SECTION 28. LEGISLATIVE INTENT. It is the intent of the General  
35 Assembly that any funds disbursed under the authority of the appropriations  
36 contained in this act shall be in compliance with the stated reasons for

1 which this act was adopted, as evidenced by the Agency Requests, Executive  
2 Recommendations and Legislative Recommendations contained in the budget  
3 manuals prepared by the Department of Finance and Administration, letters, or  
4 summarized oral testimony in the official minutes of the Arkansas Legislative  
5 Council or Joint Budget Committee which relate to its passage and adoption.  
6

7 SECTION 29. EMERGENCY CLAUSE. It is found and determined by the  
8 General Assembly, that the Constitution of the State of Arkansas prohibits  
9 the appropriation of funds for more than a one (1) year period; that the  
10 effectiveness of this Act on July 1, 2012 is essential to the operation of  
11 the agency for which the appropriations in this Act are provided, and that in  
12 the event of an extension of the legislative session, the delay in the  
13 effective date of this Act beyond July 1, 2012 could work irreparable harm  
14 upon the proper administration and provision of essential governmental  
15 programs. Therefore, an emergency is hereby declared to exist and this Act  
16 being necessary for the immediate preservation of the public peace, health  
17 and safety shall be in full force and effect from and after July 1, 2012.
